# 1. Commencement of meeting and apologies

The meeting commenced at 5.30pm.

# 180 Years of Council

The Lord Mayor advised that this week marks the 180th anniversary of the first 'business' meeting of the City of Melbourne, and read the following:

In 1842 the Port Phillip District of New South Wales, as Victoria was then known had a population of under 24,000.

There were 1,025 births, 413 deaths and 515 marriages registered in that year. There were just 3 post offices in the whole District.

The Town of Melbourne Council was created early in 1842 and following elections the first business meeting of the Council was held on 15 December 1842. We formally became a City in 1849.

The Council Meeting was held at the Royal Hotel in Collins Street, which thanks to some research by the Royal Historical Society of Victoria, we think once stood close to the corner of Queen Street on the South side. This was close to the centre of Town at the time, close to the Customs House (now the Immigration Museum).

180 years later, here in our beautiful Town Hall we are continuing to deliver for Melburnians and make our City a better, fairer and safer place.

# 6.1 Global Entrepreneurship Congress - Melbourne 2023

The purpose of this report was to seek Council's support for the 2023 Global Entrepreneurship Congress (GEC), to be held from 1-4 May in Melbourne.

Moved: Cr Griffiths

- 1. That Council:
  - 1.1. Requests that management undertake the following activities in order to maximise opportunities arising from Melbourne hosting the Global Entrepreneurship Congress (GEC) in May 2023:
    - 1.1.1. Seek to have CoM staff on the GEC steering committee in order to promote Council's policy priorities;
    - 1.1.2. Nominate subject-matter experts to GEC working groups where this aligns with Council policy;
    - 1.1.3. Provide tourism information about Melbourne at the GEC via a visitor desk staffed by our volunteers;
    - 1.1.4. Hold a welcome event at Melbourne Town Hall for VIP delegates, hosted by the Lord Mayor and/or Councillors;
    - 1.1.5. Offer 'innovation tours' for delegates to showcase Melbourne's leading infrastructure, research and workforce; and
    - 1.1.6. Promote to delegates a diverse range of local entrepreneurial events occurring that week.

#### 7.1 Notice of Motion, Cr Leppert: Review of Local Planning Policy for Licenced Venues

Moved: Cr Leppert

- 1. That Council seeks a report from management, to be presented to the Future Melbourne Committee by the end of March 2023, providing an opinion on whether the Melbourne Planning Scheme requires amendment in relation to planning permission for licensed premises. The report should consider:
  - 1.1. The function of Clause 13.07-1L-04 (Licensed Premises), the land use terms and table of uses in the Schedules to the Capital City Zone and Docklands Zone, and related provisions;
  - 1.2. The extent to which the above planning provisions are facilitating state and local planning policies and their objectives to offer entertainment uses in the Central City (while limiting unreasonable amenity impacts);
  - 1.3. Whether the cessation of the 'freeze' for new late night Liquor Licence applications from 1 July 2023 might create or exacerbate issues with the operation of the above planning provisions; and
  - 1.4. If the opinion is that the above planning provisions require amendment, what options there are to partner with the State Government (as the agent of change to the regulatory framework) to co-fund and fast-track a formal study and any resultant planning scheme amendment.

# 7.2 Notice of Motion: Cr Hakim, Funding request to support pop-up Docklands Neighbourhood House

#### Moved: Cr Hakim

- 1. That Council:
  - 1.1. Acknowledges the commitment of the local community in Docklands to build community connections and support through facilities such as the pop-up Docklands Neighbourhood House (DNH).
  - 1.2. Notes that the current operation of the DNH is at risk due to lack of funding support.
  - 1.3. Approves an allocation of \$20,000 from the 2022/23 discretionary budget towards continued operation of the DNH and that the allocation be supported by a funding agreement which includes key performance indicators.
  - 1.4. Requests that management advise the DNH that any future needs will be considered as part of the next phase of the City of Melbourne's Neighbourhood Model and work being undertaken to better understand and support community priorities.
  - 1.5. Notes that the DNH is also seeking funding support through the Victorian Government.

#### 7.3 Post travel report – Councillor Hakim, public art, creative and social programs, New Zealand

The purpose of this report was to report to Council on the travel undertaken by Councillor Jamal Hakim to Auckland and Christchurch, New Zealand to explore initiatives and strategies supporting public art, creative, cultural and social programs.

- 1. That Council notes:
  - 1.1. The report by Councillor Jamal Hakim on key observations, commitments and opportunities associated with his travel to New Zealand between 22 and 27 August 2022 at a cost to Council of \$5961.
  - 1.2. That ongoing dialogue and exchange between officers at City of Melbourne and Cities of Auckland and Christchurch will occur on policies, issues and programs of mutual interest and benefit.

# 9. Closure of meeting to the public

#### Moved: Cr Hakim

- 1. That pursuant to section 66 of the Local Government Act 2020 (Act), the meeting of the Council be closed to members of the public for the consideration of the items under the following categories:
  - 1.1 Agenda item 14.1 as it contains private commercial information which if released would unreasonably expose the property owner to disadvantage by disclosing the rates at which the owner is willing to negotiate the Lease.
  - 1.2 Agenda item 14.2 as it contains information that was confidential for the purposes of section 77 of the Local Government Act 1989. The responses contain various design and commercially sensitive approaches to the site response, including financial modelling, and confidentiality is required to protect commercially sensitive negotiations that are yet to take place.
  - 1.3 Agenda items 14.3 and 14.5 as they contain private commercial information, which if prematurely released, prejudices the Council's position in commercial negotiations.
  - 1.4 Agenda item 14.4 as it contains private commercial information, which if released, would unreasonably expose the business to disadvantage by disclosing financial information to competitors.
  - 1.5 Agenda items 14.6 and 14.7 as they contain personal information, which if released, would result in the unreasonable disclosure of information about a person or their personal affairs.

#### Seconded: Cr Campbell

The motion was put and carried unanimously with the following Councillors present: Lord Mayor Sally Capp, Deputy Lord Mayor Nicholas Reece and Councillors Dr Ball, Campbell, Griffiths, Hakim, Le Liu, Leppert and Louey.
