Dear councillors,

I am an enthusiastic supporter of this proposal.

I have had the opportunity to contribute to various consultations that the City has run regarding the park and I am keen to see this design implemented.

Further, I should like to see similar treatments afforded to all the radial West Melbourne streets.

I am, however, wary that this is a Final Concept, and not the detailed design.

I am especially alert to the possibility that the Final Concept may conflict with the City's civil engineering and waste management design parameters. If so, this may result in the Final Concept being significantly altered during the detailed design phase in a way that adversely impacts the ultimate plan and reduces the amount of space afforded to the linear park or the quality of plantings in it.

With this in mind, may I please ask:

1. Has civil engineering signed off on the Final Concept?

Several proposed tree plots appear to be located in close proximity to existing crossovers. There are two recent examples of development applications where notice to grant a permit was issued for private developments, with the subsequent permits being amended at the detailed design stage to remove trees because of conflicts between trees and crossovers (refer TP-2015-19/A, Roden Street; and TP-2020-12, Spencer Street);

2. Has waste management signed off on the Final Concept?

Bin collection is more complicated in the Final Concept and it is not clear how Hawke Street residents will navigate grassed areas, bike land and carparking, and if the retained road space is wide enough to accommodate bins and traffic. We have seen a recent example of the waste management area of council being afforded only a second or third order consideration in the issuing of a permit (refer TP-2016-851/A, Ireland Street, refer attached location map).

It is my hope that the Final Concept has been comprehensively tested, that the concerns behind my questions are without foundation, and that the community is going to get this park delivered as presented.

Thank you to all involved who have seen this project through to this point.
