## Schedule of Council and Future Melbourne Committee meetings 2024

## Purpose and background

1. The purpose of this report is to resolve the dates and times for meetings of the Council and its Future Melbourne Committee (FMC) for 2024.

## **Key issues**

- 2. In general, FMC meetings are scheduled on the first and third Tuesday of each month, however this can sometimes change with the consideration of school and public holidays.
- 3. Council meetings are scheduled on the last Tuesday of each month, except in December where the Council meeting, being the last meeting of the year, is held on the second Tuesday of the month.
- 4. Due to the Victorian local government elections scheduled to take place on Saturday 26 October 2024, the following adjustments have been made to the schedule:
  - 4.1. The removal of one FMC meeting in the months of September and October.
  - 4.2. The September Council meeting to take place on the third Tuesday of the month.
- 5. At its meeting on 14 December 2021, Council resolved to hold one of its two monthly FMC meetings at a community location in the 2022 meeting schedule and again in 2023. For 2024, it is proposed to revert all FMC meetings back to the Melbourne Town Hall.
- 6. The schedule proposes that management may arrange for meetings to be held in community locations in the event that an agenda is significantly weighted towards a neighbourhood whether by number of agenda items relevant to that location, or by significance of items. Any change in location would be communicated on Council's website, noticeboard and emailed out to those who have registered to be notified of Council meeting changes and information. Where a meeting has been moved to a neighbourhood location, the start time of the meeting will change to 6pm from 5.30pm.
- 7. Melbourne Town Hall is a centrally located venue with purpose built accessible facilities, and meeting primarily at Town Hall ensures meetings are accessible to the whole municipality, particularly as agenda items often relate to a number of different neighbourhoods.
- 8. Public notice of meeting dates is provided on Council's website.

  - 9.1. Approves the schedule of Council and Future Melbourne Committee (FMC) meeting dates for 2024, as detailed in Attachment 2 of the report from management.
