I am making a submission on this item because one week ago I submitted a request using the Council's online form requesting the overall performance score in the Annual Community Satisfaction Survey 2023, and have not received a reply, even though the online form says there is a 2-day turnaround time on responding to requests.

The Annual Community Satisfaction Surveys are not published on the City of Melbourne website. Therefore it is not possible to check whether the data in the Performance Statement of the Annual Report is correct or not. The Independent Auditors Report, on page 197 of the Annual Report, says that Councillors are responsible for the Performance Statement. To quote "The Councillors are responsible for the preparation and fair presentation of the performance statement in accordance with the performance reporting requirements of the Local Government Act 2020 and the Local Government (Planning and Reporting) Regulations 2020 and for such internal control as the Councillors determines is necessary to enable the preparation and fair presentation of a performance statement that is free from material misstatement, whether due to fraud or error. "

Indicator G5 Governance Satisfaction – satisfaction with Council decisions made in the interest of the community – decreased from 64 to 58.

I would like to suggest that in the interests of transparency and community accountability the Annual Community Satisfaction Surveys should be readily available on the Council website. One other aspect of the Annual Report 2022–23 that I would like to comment on is that the Audit and Risk Committee have not been reported on. Surely this committee is of significant importance that one page of an annual report could be allocated to the attendance and activities of this committee. Apologies if that page is there but I didn't find it. Thank-you.
