The National Trust of Australia (Victoria) (National Trust) provides the following submission to the above planning referrals for an early works planning permit application and the proposed Queen Victoria Market (QVM) Southern Precinct Development Plan, December 2023.

The National Trust has a long-standing interest in the City of Melbourne's Queen Victoria Market Precinct Renewal Program and has been actively engaged in the process for many years, including as a member of the Queen Victoria Market People's Panel in 2018. The National Trust recognises the Queen Victoria Market's national significance as one of the great nineteenth century markets of Victoria. It has been in continuous operation since the 1870s and is the only Melbourne market to survive from a group of important central markets built by the City of Melbourne Corporation.

We also recognise the social significance of the Queen Victoria Market as a record of change and continuity in market activity over a long period and as an important shopping, leisure and meeting place for generations of Victorians and visitors to Melbourne. The complex of enclosed food halls, open sheds, shops, and stores perpetuates distinctive forms of trading, providing a very tangible continuity from the nineteenth century to the present. The social significance of the Market is reflected in its function as an affordable and diverse retail market serviced by small, independent businesses, from many different cultural backgrounds.

Furthermore, the Old Melbourne Cemetery is located underneath the current at grade carpark and is recognised through the edge of the Franklin Street Stores which are built on this alignment. It is Melbourne's first official cemetery, established in 1837, and is of archaeological significance as many burials remain on the site.

The National Trust advocates for the values of both the Market and Old Melbourne Cemetery to be maintained during and after the Market Renewal process. In particular, we expect the open character of the Market sheds to be maintained, and for the market to continue to be an affordable place to shop for locals and visitors.

1.0 Summary of National Trust Position

In 2017 the National Trust conditionally supported the Queen Victoria Market Precinct Renewal. The National Trust continues to consult with the Market Renewal team to provide input and advocate for positive heritage outcomes on the site.

We acknowledge that this permit application seeks to implement key outcomes that were terms of the 2014 agreement between the City of Melbourne and the State Government as part of the Market Renewal. We also recognise that the proposal is subject to the requirements of a Development Plan Overlay (DPO11), Design and Development Overlay and outcomes of the Queen Victoria Market Precinct Renewal Master Plan.

The National Trust recognises that funds secured through the development of the Southern Development Site will be reinvested into the Queen Victoria Market as part of the Queen Victoria Market Precinct Renewal Program. While we acknowledge the precinct benefits to be delivered by this development, the National Trust believes these benefits do not require the cost of the Market's integrity as a site of rare significance in a location of the CBD that has to date been distinguished by its relatively low-density surrounds, enabling public appreciation of its intactness and distinguished role.

- We support the proposal for the replacement of the open-air carpark with Market Square. However, we have concerns regarding certainty around the design and consultation process for this new public open space, and the excising effect on the Franklin Street Stores from the rest of the Market site.
- We support the proposed adaptive reuse of the Franklin Street Stores. However, we object to the temporary and permanent demolition of the canopy to facilitate the encroachment and cantilever of the tower developments behind the Stores.
- We object to the scale of development proposed behind the Franklin Street Stores. We submit that the bulk, height and encroachment of the proposed towers on the Stores overwhelms the Market. It is our position that these elements must be reduced to minimise the impacts of the new development on the state and national heritage values of the Market complex.

2.0 Ministerial Planning Referral: TPMR-2023-10 Early works permit application

With regard to the application for early works associated with the redevelopment of the site being concurrently considered under development plan application DP2302292 (CoM ref TPMR-2023-7). We submit that early works should not be considered until the key matters of the Queen Victoria Market (QVM) Southern Precinct Development Plan have been fully resolved and the plan finally approved. Approval of works and planning for this significant site should not be driven by pre-determined outcomes.

3.0 Ministerial Planning Referral: TPMR-2023-7 Queen Victoria Market (QVM) Southern Precinct Development Plan, December 2023

We acknowledge that in light of the Heritage Victoria permit approval, heritage is not a required consideration for the Committee. However, we implore the Committee to view this site and the proposed changes in a holistic manner, accounting for all significant values to the Melbourne and Victorian community.

We note that the <u>Heritage Victoria Officers Report</u> concerning this permit application states, 'It is a poor heritage outcome that a place of State and National significance should have to be physically altered to allow for an improved development outcome, however in this case there is little alternative.'

3.1 Public Realm

The National Trust conditionally supports the proposal for the replacement of the open-air carpark with Market Square. While we acknowledge that the design of Market Square is subject to change based on City of Melbourne led community consultation, we have concerns regarding certainty around the proposed design, particularly with the shared one effectively excising the Franklin Street Stores from the rest of the Market site.

We therefore approve of the Shared Zone Design Principle 3,

The north-south crossings for laneway pedestrians that should denote pedestrian priority and ensure that the shared zone is not a barrier between the Southern Development Site and the activation of the northern tenancy areas of the Franklin Street Stores, Market Square and the Market.

We submit that the detailed design for Market Square and the treatment of the shared zone should ensure that the Franklin Street boundary can continue to be read as the southern extent of the Market, rather than the public open space visually excising the Franklin Street Stores from the rest of the Market site.

We would seek more detail and certainty regarding the Ground Plane Design Principle 2,

Provide for a continuous north-south connection between Franklin Street, Market Square and the Market. Where possible, the view lines through this space at ground level should not be obscured.

This Principle should go further to guarantee that a connection between the Franklin Street stores to the Market will be maintained in the design of both the shared zone and Market Sqaure.

We also seek greater transparency regarding what design elements of Market Square are subject to change through the City of Melbourne led community consultation. It is not clear what level of public interpretation of the Old Melbourne Cemetery will be expected. While this element may not be the concern of the Southern Precinct Development Plan, the National Trust encourages ongoing meaningful community consultation on how the history of the site is to be acknowledged to engage and raise public interest in the archaeological significance of the Old Melbourne Cemetery site.

3.2 Landscape Design

The National Trust supports the vision and principles of the Market Square landscape design. We acknowledge that species selection has not been finalised and Traditional Owners will be consulted.

3.3 Franklin Street Stores

The National Trust supports the adaptive reuse of heritage buildings to ensure they have an ongoing purpose and remain viable assets to their communities. We generally

support the plans to adaptively re-use the Franklin Street Stores, and the required conservation works and removal of non-original fabric to facilitate this.

However, we have serious concerns with the removal of the Franklin Street Stores canopy as part of the development of the T1 and T2 towers. We disagree with the comments in the delegate report that this constitutes a 'high level of retention of the Franklin Street Stores' (Page 42 of 45).

We are not satisfied that the demolition and partial removal of the Franklin Street Stores' canopy has been sufficiently justified. Demolition of original fabric should be avoided, and retention of some significant fabric is not a justification for demolition elsewhere.

3.3 Tower developments

Regarding the proposed tower developments behind the Franklin Street Stores, we submit that,

- the height of the proposed towers should be reduced to mitigate the overwhelming nature of their mass;
- the separation between each tower should be increased to mitigate the cumulative bulk and walled effect of the three towers;
- the development should be further set back from the Franklin Street Stores and not cantilever over them, which it has been argued necessitates the partial demolition of the Stores' canopy.

3.3.1 Impact of height and bulk

The National Trust objects to the proposed bulk and massing of the tower developments behind the Franklin Street Stores, as they overwhelm the Market and would result in an unacceptable and unreasonable impact on the significance of the registered place.

The National Trust finds that both the intactness of the Franklin Street Stores and the ability to appreciate the noted architectural elements of the Market would be threatened by the height and bulk of the proposed tower developments encroaching on the Stores.

We find that the height and proximity of the three towers creates a wall effect on the Franklin Street boundary which overwhelms the Franklin Street Stores and looms over the rest of the Market.

Furthermore, we fundamentally disagree that large-scale development on the fringes of the Market will not diminish its intactness and legibility as an early market complex. The overwhelming nature of this proposed development, and the encroachment and cantilever over the Franklin Street Stores, prevents the appreciation of these structures in their own right. We also submit that these towers will impact the wider site and its important value as a distinct market complex due to the significant impact on the traditionally low scale density sightlines of the site. Additionally, the transition from the higher built form of the central city to the very low scale of the Market will be starkly disrupted if these tower developments are approved.

To mitigate these negative impacts, the height and bulk of the proposed towers should be reduced, and their separation, and setback from the Franklin Street Stores increased.

3.3.2 Impact of the cantilever

The National Trust objects to the cantilever of T1 and T2 over the Franklin Street Stores. We acknowledge the proposed cantilever is not as extensive as DPO11 allows, however, we submit that just because it is not as extensive as it could be, this does not make the cantilever a good design outcome.

The National Trust also disagrees that the Franklin Street Stores are provided with sufficient breathing space from the cantilevered parts of T1 and T2. We submit that necessitating the demolition of the canopies would indicate the cantilever produces an overwhelming effect on the Franklin Street Stores, in that elements of their built fabric must be removed to accommodate the towers.

We submit that the design of the cantilever over the Franklin Street Stores should be removed from the development proposal.

4.0 Conclusion

We respectfully request that the Future Melbourne Committee refuse to support either application TPMR-2023-7 or TPMR-2023-10 in their current forms.

We encourage the City of Melbourne to oppose the partial demolition of the Franklin Street Stores canopy, as well as the height, bulk and cantilever of the proposed tower developments, on the basis they would have an adverse and irreversible impact on the significance of the Queen Victoria Market.



Friends of Queen Victoria Market does not support the 'informal' Ministerial Referral before the Future Melbourne Committee meeting 20 February 2024 to accelerate the early works to the Southern Site.

The City of Melbourne, a partner in this commercial enterprise with Lendlease, and which stands to profit from this development, supports this application for 'early works associated with the proposed QVM Southern Precinct Plan' despite the fact that a planning approval by the State Government is still under consideration. This is an Alice in Wonderland scenario where the planning authority is referring the matter to the organisation proposing the development.

Friends of QVM are concerned that in considering this 'informal' Ministerial Referral to accelerate the early works to the Southern Site (which do not have planning approval) is for Lendlease's benefit, ignoring proper process and the concerns of the indigenous stakeholders and local residents. Both, Friends of QVM and the Wurrundjeri Woi Wurrung Elders are key stakeholders, which unlike the CoM, are without financial investment in property development.

The public statements by the Council and Lendlease indicate that there is Aboriginal approval. However, Friends believe this is questionable although an arm of the Wurrundjeri Woi Wurrung Cultural Corporation has given approval for the use of the name, Gurrowa Place only.

We question the relationship between a public authority, the City of Melbourne, and a commercial development company, Leadlease, and feel acute disquiet. This is not in the interest of the rate payers of Melbourne, nor the interests of the local residents and Queen Victoria Market, nor the interests of the Aboriginal custodians of their significant site.

Recent media has reported that the CoM is cash-strapped. Council should recognise that grandiose Queen Victoria Market renewal plans

originally devised in 2014 and the Queen Victoria Market Precinct Framework 2017, are now dated and outdated, and beyond the financial means of the Council.

Melbourne has undergone radical change in the intervening years yet the vision for the market remains the same.

Since the renewal plans in 2014 began under former Lord Mayor Robert Doyle, the profitability of the Market has decreased. Since then, QVM has lost one third of its traders. The empty sheds are testimony to poor decision-making, incompetence, and ignorance of the decision-makers of the importance of our market to Melbourne. The rot set in well before COVID which accelerated an attrition of Market businesses in the Upper Market that was already well on its way and is continuing.

Lip service is given only by the Council and its partner Lendlease to the Market as a place registered on the Victorian and National Heritage list. By describing the market as the QVM **precinct**, it diminishes its significance as a discrete place of elevated significance to Aboriginal people, Victoria and Australia.

Heritage Victoria despite disapproving of the many aspects of the City of Melbourne/Lendlease proposal, approved the Lendlease's application. Heritage Victoria states in the Heritage Victoria Officer's Report and Recommendation the following:

Page 53:

'The reporting officer does not support the construction of Towers One and Two (or Tower three and the Queen Corner Building) in such close proximity to the Franklin Street Stores. Towers One and Two cantilever over and directly abut the Stores and would dominate and overpower them. It would be necessary to remove sections of the southern canopy to ensure the Stores are functional and inviting. The bulk of the towers are outside the extent of the registration (ie Heritage listing) and will be constructed regardless of whether this permit is approved or not.'

Page 14:

'.... the towers will have a substantial impact on the cultural heritage significance of QVM. They are massive in scale (both height and width) and will dwarf the single storey Franklin Street Stores located at their base.'

The Heritage Victoria's Officer's Report, which in an unprecedented move by Heritage Victoria (HV), is posted on the HV website for the

public to view. Statements such as 'The surviving Franklin Street Stores were designed to be visible and accessible for both the north and south elevations' (page 14);

'The reporting officer does not agree that the decision to remove the canopy should be informed by the new urban condition created by the towers. Rather, the location of the towers should have been informed by the cultural heritage significance of the Franklin Street Stores in the context of QVM in its entirety. It is a poor heritage outcome that a place of State and National significance should have to be physically altered to allow for an improved development outcome'(page 14) to quote just a few.

The above excerpts suggest that the Heritage Victoria decision was reluctant and implies pressure was applied.

How can you appropriate one third of the Victorian and National Heritage listed place, subsume the southern storage sheds (also on the Victorian and National Heritage register) into the overwhelmingly high wall that will divide the western end of the CBD to the Market's south, rip off part of the storage shed canopy because the proposed walkway beneath would be 'dark and dingy' while at the same time extoling the virtues of our marvellous 19th century heritage Market loved by Australia.

Ratepayers expect Council to operate in a fiscally responsible manner which does not include speculative property development. We urge you to defer this decision, pause and review your outdated strategy. The City of Melbourne is now forced to subsidise the operation of the market which it can ill afford. Prior to QVM 'renewal', the Market generated \$4million+ annually to Council coffers by doing what the market does best – serving Melbourne as a traditional fresh food and general market.

In essence what it comes down to is that Lendlease, supported by the City of Melbourne, its commercial partner, is supporting its commercial development partner to begin preliminary construction and demolition work on the site before the development has actually been approved. This is bizarre!

Tony Barry of RedBridge has found in polling that people are increasingly distrusting institutions like this Council because they don't represent community values.

Is this not another example of community values not being valued?

Melbourne City should not be supporting, in any way the current proposal for the Lend Lease development of the Franklin Street land.

The Minister (and by this referral the Council) have an obligation to protect the environs and heritage significance of the Queen Victoria Market.

The current scheme is an overpowering and excessive development of the land immediately to the south of the market.

Not only will it overpower the low scale form of the market but its proximity to the heritage registered storage sheds results in those structures being seriously compromised including by the removal of most of the southern canopy to the sheds.

The issue of a permit by the Executive Director, Heritage for these works should not provide a reason for the Council to overlook its obligation to use its planning powers to protect the environs of the market.

The size of the development is excessive and makes little effort to acknowledge the existence of the market. The new towers should be set further away from the storage sheds such that the sheds can continue to be a part of the market rather than an odd and compromised appendage to the new development.

The Council has an opportunity to seek revisions to this development and show that it treats the conservation of this nationally significant heritage place seriously.







When we saw a document with the word 'Strategy' in the title, we expected it to include the following:

- An evaluation of the current and numerous interventions and support services that the City of Melbourne undertakes to address homelessness,
- Proposed improvements to these various projects as a result of the evaluation and
- New initiatives to address perceived gaps.

The document provides a detailed analysis of the various cohorts and the unique challenges of each. It also provides comprehensive coverage of the various causes of homelessness. The document is of value for that alone.

However, the section on priorities says the CoM will 'deliver', 'advocate' and 'partner', but there is no detail on the 'what' and 'how'. So, if this document is to be the basis for consultation, it seems that it is too ephemeral to result in concrete and useful responses.

The SRA has been well-aware for some time of the expertise and experience of CoM personnel working in this area. Their presentations on this matter have conveyed an appreciation of its complexity and the need for compassion.

It is therefore surprising not to find information on the dot points above.

The agenda item proposes a consultation with the community on homelessness in its broadest terms. It is almost as if the consultation is starting with a blank canvas without the benefits of any critique of the CoM's current support and interventions.

The SRA wishes CoM well with this exercise, but it thinks the time and money would be better spent addressing the dot points mentioned at the beginning.

Hi, my name is Anna. I have been involved in circulating information about Palestine on social media and I wanted to represent information coming directly from Palestinians. It's not that hard to find these individuals on social media platforms such as instagram and TikTok, where they are able to provide unfiltered and honest perspectives of the absolute horrors occurring in Gaza.

There is nothing more that needs to be said that there is a major humanitarian crisis occurring in Gaza. Innocent Palestinians are trapped and dying daily, nobody is being spared.

There are videos of doctors risking their lives to bring patients into the hospitals they work at, afraid to get struck down in the cross fire that injured the person in the first place. Children who survive bombings are having to face amputations with no anaesthesia or numbing. There are teenagers having to look after many of their younger relatives as they are the oldest people left in their families, so children looking after children because there's no other choice, does that sound like a humane way to treat people?

The Israeli government has been and continues to use an unreasonable amount of force against the Palestinian population, with very little sign of stopping without intervention. It's clear that Israel's goal is to perform an ethnic

cleanse of the Gaza region and we need to bring more attention and support to this issue. One example would be the clearing and burning of olive trees throughout the region, generations of Palestinian farmers have looked after these trees and the IDF has gone and destroyed most of it. This is just a very surface level example.

Many Palestinians see a bleak future, either they stay in the Rafah region and continue to face heavy bombardment, or they allow themselves to be pushed out into the desert, where there is no food and no water. Egypt is also to blame here too, they have shown resistance to allowing Palestinian refugees to enter their country, often requiring twelve to fifteen thousand dollars for civilians to cross the border. The main way the general public are trying to help right now is by donating to these families who just want peace, which is something that should never have to be done in the first place.

I am also thankful that this motion also brings protections in place for both the Jewish and Muslim communities of Melbourne. Although religion is a factor involved in this war, it doesn't mean anyone who follows either automatically agree with the actions of the respective states. Antisemitism and islamophobia are very real problems so it's important that we help to protect our local communities and cultures from unwarranted hate. I could only imagine the amount of generational trauma this is bringing up for them.

I am so thankful we still have individuals like Bisan who are going through these horrors and sharing it with us. I know it's not comfortable to think about, but imagine how painful this is for all of the displaced Palestinians who have no choice. Please stop listening to journalists who only have second hand information, listen to the Palestinian people who want nothing but peace and to have their rightful homes back. From the river to the sea, always was always will be.

I suggest the council not adopt the motion presented by Cr Jamal Hakim. Please see below the logic that leads to this recommendation.

Questionable Credibility of the Motion Title: The title states: "Reflecting community sentiment on the humanitarian crisis in Gaza." Has the entire community of Melbourne City been surveyed on this topic, and did the results suggest the sentiment stated in the title? If not, how does Cr Jamal Hakim consider the opinion of those not partaking in demonstrations in Melbourne CBD, those who go about their business and want to simply live and work in peaceful Australia?

Oversimplification of the Issue: The conflict in the Middle East is long-standing and very complex. It started a long time ago. The motion being presented to the Future Melbourne Committee on 20th February 2024 tries to describe this conflict within four paragraphs of English text. This grossly simplifies the issue, which certainly negatively impacts humans globally. I question both the qualifications and the desire of Cr Jamal Hakim to analyse the roots of the issue and provide informed, expert advice on its resolution, keeping in mind the interests of all parties.

One-Sided, Biased: While section 1 of Cr Jamal Hakim's motion includes descriptions of how civilians on both sides

of the conflict suffer, his motion is largely one-sided. For example, it mentions both Israeli hostages, abducted in their homes and at a music festival, forced to witness murders and rapes by members of the terrorist organisation Hamas, and prisoners detained for breaking law and order. He states: "...immediate release of Palestinians held in Israeli prisons without charge." This is just one example of the motion's bias.

Importing Political Issues: Many of us have come to Australia in search of a better life. We left troublesome countries of origin because they could not provide the peace and prosperity we desired. Should we import these problems (or parts of them) to Australia? There are many more atrocities happening in the world. Should we take to the streets to fight for their resolution? Should we divide this country based on the histories and present situations of the countries we came from? Let's ask the council to get involved with the Russia–Ukraine war, Azerbaijan–Armenia conflict, India–Pakistan disagreements, China–Taiwan disputes, and many others in Africa, Syria, and other places where injustice is happening. Perhaps we should keep Australia as a safe haven of peace and prosperity so that our children and new migrants can enjoy good lives here for years to come?

Divisive: The actions of pro-Palestinian activists in Melbourne CBD and across Australia for several months have often been aggressive and intimidating. They disrupt the lives of ordinary Melburnians, whether attending a Friday night service at a local synagogue, taking their kids to see the Myer Christmas Windows in December, or attending a Christmas concert. Many Melburnians simply avoid coming to the city on Sundays to avoid the loud and aggressive mob. By joining their effort, the City of Melbourne will take their side and make the Australian public, including those who live and work in Melbourne city, feel threatened and unsafe.

Not Necessary: It says on the City of Melbourne website: "Melbourne City Council is the local government body responsible for the municipality of Melbourne." The City of Melbourne council's role is to address local issues; Australia has a Department of Foreign Affairs tasked with developing and implementing Australian foreign policy. It is not the City of Melbourne's responsibility to spend ratepayers' money trying to analyse a conflict on the other side of the globe. This council should avoid the risk of getting involved with an issue that is absolutely outside of its responsibility.





My name is Edwina, I'm a Parkville resident and love living as a part of the vibrant, diverse, and welcoming community we have created here in the City of Melbourne.

Melbourne Council is a progressive council, with an admirable record of advocating for human rights. This includes recent actions on the Yes Vote, reconciliation action with Aboriginal and Torres Strait Islander People, LQBTQIA+ and disabled residents, climate action, as well as cancelling sister city relations in Russia as part of the war in Ukraine. This reflects the concerns and progressive values of the residents of the City of Melbourne.

Melbourne Council speaks of their commitment to inclusive Melbourne and the recognition of justice and equity. The motion in Agenda 7.2 entitled 'Reflecting community sentiment on the humanitarian crisis in Gaza', slated to be discussed by Council this coming Tuesday, should be supported unanimously by Councillors.

I have been a resident of the City of Melbourne for a decade and half, and have been a practicing lawyer in the city for nearly two decades. In my career, I have focused on human rights and corporate misconduct.

I was an author and coordinator of a letter from Australian lawyers to our government, signed by over 1400 practitioners and academics from across the country. The letter highlighted the grave human rights violations taking place in Gaza and called for a ceasefire. See <u>https://lawyersletter.au/</u>

It is devastating to me that since that letter was written, the ICJ has confirmed the main conclusions of our letter and the death toll has trebled.

Not a day passes that I do not think about the many lives lost, and the grave risks faced by many more, including friends. I have found the experience of watching people defend this genocide to be soul destroying. I feel ashamed that our government is not doing more. It makes it difficult to have faith in representative government.

I have found significant solace in the vibrant and peaceful rallies that have taken place in the City of Melbourne since this assault on Gaza began. I have attended all but a handful and have felt safe, encouraged and energised. These gatherings are a source of comfort in these dark months, and represent the city at its very best.

It is our duty as citizens of the world to find ways to ensure our views are represented in organs of power. The motion reflects the widespread view that the humanitarian catastrophe unfolding in Gaza is neither justified nor inevitable. The motion reflects the very least we can do to demonstrate to our friends abroad that we have not forgotten them, that they are entitled to dignity and life. I commend the motion to you.

Lord Mayor and Honourable Councillors

I write to unreservedly oppose the proposed motion at agenda Item 7.2 for 20 February 2024 sponsored by Cr. Jamal hakim, entitled "Reflecting community sentiment on the humanitarian crisis in Gaza".

Introduction

As a ratepayer in the City of Melbourne, I want the Council to focus on planning, sustainability, the built form of the local government area, garbage collection, initiatives to support retail strips and local icons such as the Victoria Market. I believe that is what most ratepayers want. If there is evidence about community sentiment to the contrary, then it is incumbent on Cr Hakim to provide pursuant to the principle of transparency.

However, even if evidence of community sentiment supported the ill-targeted motion, the content of this statement is offensive and the subject matter a long bow from where the Council's focus should be and from where the Council's expertise lies.

The Council will be judged by the standard it sets, which is established by what it chooses to accept and reject. The fact that some Councils are swayed by the loudest shouters is pathetic and weak. Melbourne is supposed to be a leader and it is in the rejection of this motion that the City of Melbourne can demonstrate its strength.

Objections

It is impractical to comprehensively respond to all that is objectionable in the motion, therefore points are made in summary in the hope that amongst the body of Councillors there is sufficient leadership to ensure this motion is not passed:

A. "We unequivocally condemn all attacks targeting civilians and civilian infrastructure including hospitals, utilities, homes and places of worship, education and culture"

The primary subject of the above statement is self-evidently Israel as it is wellknown that Israel has bombed all of the types of places mentioned. It is outrageous to "*unequivocally*" condemn these actions as if the law of proportionality in armed conflict did not require consideration. This statement ignores the lawful attack on such places and indeed the killing of innocent civilians in armed conflict, when it arises in certain circumstances such as when those places become tools of war. Moreover, the relevance circumstances have been alleged by Israel and Israel has provided overwhelming evidence of these allegations to the world's media, including storage of weapons, launching of attacks, housing of hostages in and under hospitals, schools, mosques and in homes of "civilians" and UNRWA staff. The Council has no authority to pass a motion disregarding international law and implicitly make a judgment against Israel.

B. "We acknowledge the distress caused by the catastrophic humanitarian crisis in Gaza and recognise the profound impact of recent events, including the atrocities committed on October 7th, the hostages held in

Gaza and in Israel, the continuous bombing and total siege of Gaza, including the bombing of Rafah, the last 'safe zone' and that these are part of a history of violence for over 75 years"

This is a most poorly constructed, reckless, offensive and revisionist statement.

- 1. Whilst Cr. Hakim wants the Council to condemn actions permitted under international law as stated above, the crimes against humanity committed on October 7 are only an inclusion in a general context and warrant only that the Council "*recognise the profound impact*"!
- 2. Upon the advent of girls having their pelvises broken due to gang rape before being mutilated, having their vagina's and faces shot, the Council should "*recognise the profound impact*"?
- 3. Is there no need for mention more than a passing generalised "*we condemn attacks against civilians*" to cover this?
- 4. The soldiers, many young inexperienced non-combatants fulfilling compulsory duty required due to decades of terrorist threats against Israel, whose bodies were desecrated were also victims of war crimes is no comment about the war crimes committed against them due if the Council seeks to assert a role as commentator?
- 5. Before you vote, Councillors, it is incumbent on you to view some of the evidence relating to October 7 and confirm whether you believe, if the Council makes a statement about it, that that statement ought to include condemnation or something stronger:

- 6. Where is the specific condemnation of crimes against humanity committed in Israel by Hamas? Where is the outrage about this? This is not legitimised by any of the history and this is ongoing since October 7 by the use of Palestinian civilians as human shields and the use of hospitals, schools and mosques as tools of war.

- 7. The mention of 75 years of history in this statement seeks to legitimise October 7 for some, obviously not the maker of the statement who needs to "*recognise*" it for others - who *may be* impacted by babies and foreign workers being beheaded, a parent and child tied together and burnt alive, children being made to watch siblings and parents executed before their eyes by Hamas terrorists who report with glee to their families how many Jews they killed. Where is the moral clarity?
- 8. This statement implies a history of 75 years of violence committed by Israel, which is perverse. In 1947, the UN made a partition plan for a homeland for the Jews in the land that Jews have had continuous connection to for over 3,500 years and have never ceded it. A homeland was also offered to the Arabs within the borders, roughly, of West Bank and Gaza. The Jews accepted the UN Partition Plan and the Arabs rejected it. From the day of declaration of the State if Israel on May 14, 1948, Israel defended war thrust on it by all of its neighbouring Arab States, Jordan, Iraq, Egypt, Syria, Sudan, Saudi Arabia and Lebanon every decade since some combination of Arab states have attacked Israel, or tried to do so. This has been followed by terrorism against Israel especially from the 1990s and onwards led by Hezbollah, Hamas and other terrorist organisations dedicated to the destruction of the State of Israel, many sponsored by Iran.
- 9. Israel has not had ongoing violence with all of its neighbours, only those committed to its destruction who reject Israel's right to exist.
- 10. Peace treaties have been signed by Israel with Egypt, Jordan, UAE and Bahrain, Israel has returned land in Sinai to Egypt.
- 11. Israel also handed control of Gaza to the Palestinians in 2005, who then elected Hamas as its government in 2006.
- 12. Although Gaza remains under 'siege' led by Israel, this is to prevent bombs and missiles entering Gaza given the proven commitment of the rulers to vicious attacks on Israel. 1,000s of rockets have been shot into Israel annually and October 7, occurred notwithstanding the siege.

C. Balance of the Statement

Especially in the context of referencing the violence of the past 75 years, this statement is incomplete without a call also for the right of Israel to exist within safe and secure borders. The absence of a call for Israel's right to exist to be recognised suggests in fact a nod those chanting "from the river to the sea, Palestine will be free", which is a call for the destruction of Israel.

D. Request for the Lord Mayor to relay a message to the PM and make further calls

Despite listing a number of matters to help the Palestinians, the total absence of any action called for against Hamas is outrageous. Is this Council really content for an elected government of Gaza to commit crimes against humanity and carry on emboldened to fulfil their promise to do it again and again? No comment about Hamas speaks volumes about a lack of moral leadership. It heats up the electric bed of the terrorists whose bed Councils approving motions like this are getting into.

All of statements to the PM are ineffectual, they seek of the PM nothing more than what is already being done or what is a redundant request. This further underlines the futility of this statement in any practical sense despite its offensiveness.

Conclusion

Israel is a liberal democracy, world-leading in technology, medicine, arts, and other fields, notwithstanding that it is also imperfect and has domestic issues which Israeli people have cause to and do protest. However, any objective bystander must recognise that in a sea of Arab countries that oppress women, outlaw religions other than Islam or otherwise punish people practising those religions and criminalise members of the LBTQI+ community, Israel is a leader that deserves world's respect and fair treatment.

Approximately 20% of Israel's population are Arab Muslims, there is an Arab Muslim judge on the Supreme Court of Israel, there are Arab Muslim political parties and serving members of the Israeli parliament. Israel provides access to all and has repeatedly been of the forefront of providing humanitarian aid during natural and man-made disasters such as in Fukushima and Haiti. Israel grants asylum to Palestinian members of LGBTQI+ community who fear being killed by their families and neighbours in the West Bank and Gaza.

If the terrorism in Israel is not rejected without limitation, without contextualisation and without reservation, the terrorism will not stop and it will not stop in Israel.

Please focus on keeping Melbourne the place we love and live in with freedom.

The role of Melbourne City Council is to provide good governance for the benefit and wellbeing of the municipal community, which includes residents, ratepayers, traditional landowners and people and bodies who conduct activities in the municipal district. Councils receive funds by levying municipal rates. They must spend these funds according to their responsibilities in a fiscally responsible manner.

In exercising, their roles they employ numerous staff to assist in fulfilling their mandate and when they do not have the requisite expertise they outsource to appropriate external consultants.

I have worked in the City of Melbourne since 1988, my family have owned a business since they arrived as migrants in 1926. We have always felt that the city of Melbourne provided a safe environment, respectful of the many diverse cultures that work and enjoy the City. Unfortunately, because of the hatred displayed towards Jews during the regular demonstrations, I now feel unsafe in the city.

In my role as President of Jewish care I am concerned by the impact of the current antisemitism on our community. Jewish Care has had a proud association with the City of Melbourne going back 175 years. We operate a large Aged Care facility caring for the elderly, many of whom were immigrants to this country, after fleeing persecution in Europe during the Holocaust and post war communist Russia. It is incumbent on us to provide a safe environment for them. We also provide services to the most disadvantaged in our community, people living with Economic hardship and with disabilities.

I am troubled by this resolution on several grounds:

- 1. The attempt to involve the Council in foreign policy falls outside the jurisdiction of the Council
- Clearly the appropriate level of legal expertise has not been provided when drafting this Motion as it contains many factual errors and demonstrates a lack of understanding International law.
- 3. Such a motion does not promote the well being of those who live and conduct their business within the city of Melbourne. It will only further feelings of fear and isolation amongst the Jewish Community.
- 4. Paragraph 1 references Palestine when the current conflict is between Hamas and Israel
- 5. Para 2 under point 1 references hostages held in Israel I am aware of none.
- 6. Paragraph 2.5 displays a complete misunderstanding of terms under international law. It completely ignores the legal doctrine of uti possidetis iuris.
- 7. Paragraph 2.5 misunderstands the scope of UN resolutions which are not binding in International law unless made under chapter 7 of the UN Charter.
- $\mathbf{8}$. The Motion makes no call on Hamas to abide by the ceasefire which existed on 6^{th} October.
- 9. Fails to require either a future Palestinian State or Hamas to recognise Israels right to exist.

The statistics released by Victoria Police show a significant weighting to antisemitism versus Islamophobia resulting in 10 arrests of which 9 related to "alleged" antisemitism and only 1 to "alleged" Islamophobia.

There have also been numerous reports of threats to Councilors from other Councils who have opposed motions condemning Israel.

In this climate, the Melbourne City Council cannot hope to get a balanced view from the wider community unless anonymous submissions and secret ballots are allowed in the voting. The Australia Palestine Advocacy Network (APAN) strongly supports the City of Melbourne community members in their calls for the City of Melbourne to pass a motion of solidarity with Palestine, the Palestinians and to call for a total, immediate and unconditional ceasefire in Gaza.

Councils play an important role in providing a public forum for the discussion of issues that relate to the wellbeing and benefit of their diverse communities. In fact only 2 weeks ago the <u>ACT government</u> passed a particularly strong motion in support of Palestine. Doing so they conveyed a strong message that they are committed to their communities' collective values of social justice, peace and social cohesion.

In the first 60 days of this war on Palestine in what the <u>International Court of Justice</u> has since deemed a "plausible" Genocide, the WHO determined that a child was killed <u>every 10 minutes</u> in what an official describes as "<u>humanity's darkest hour</u>."

Dear Councillor,

We are aware that you are being pressured by a very vocal minority to pass inexpert resolutions by Jamal Hakim and Davydd Griffiths that demonstrate a total lack of knowledge and understanding of the facts of the tragic war that Hamas waged on Israel.

Please understand that other councillors who meant well, and did not understand the fanaticism of elements who seem to support a terrorist organisation in its mission to destroy Israel, both militarily and in the soft war of delegitimisation, have inadvertently waded into endangering themselves and their community, as violence, harassment and threats were used to coerce their acceptance of their motion.

As local councillors your role is to promote peace, order, good governance as per the preamble in the Local Government Act.

The activists who seek to run your council and control your agenda, are neither historians nor experts in the conflict. The one sided narrative they are offering you, underplays the terrorist atrocities committed on October 7 where 3000 assorted Hamas and Islamic Jihad terrorists and other assorted opportunistic Gazans broke the border to Israel and committed the most heinous acts of savagery mutilating men, women and children, burning families alive, beheading babies, raping women and young girls and killing 1200 defenceless people and taking another 240 hostage.

Contrary to their propaganda, Gaza was not occupied and massacring children in front of parents, and parents in front of children, is not "freedom fighting". Hamas has vowed to commit October 7 attacks "again and again and again".

Israel has the right and responsibility to defend its people from such savagery. Hamas is a well funded terrorist proxy, funded by Iran, but also as the governing body of Gaza, it has access to all the billions of aid money donated globally from governments such as our own. Hamas has built over 500 miles of steel reinforced concrete tunnels underground to protect its fighters and move weapons and militants around the strip. Instead of building shelters for the Gaza civilians. Hamas has deliberately built its terrorist infrastructure in and beneath hospitals, schools, mosques, apartments and even under the UNRWA headquarters. Hamas fighters have been found hiding in hospitals and in schools, hiding behind innocent civilians.

So when Jamal Hakim moves to "condemn all attacks targeting civilians and civilian infrastructure including hospitals, utilities, homes, and places of worship, education, and culture", it is extremely disingenuous to overlook that Hamas has deliberately hidden their weapons, terror tunnels and infrastructure right in and under those buildings.

The entire Hamas strategy rests on embedding their terror network within the civilian population and using credulous international pressure to save them. The only thing they have built in 17 years is the terror tunnel system 1.5 times the size of London metro. Hamas is a uniquely cowardly enemy in the history of warfare, who willingly turn their own civilians into self serving casualty rates which are demonstrably false. Hamas only strategy for survival is the published death toll of Palestinians.

If these "activists" who try to control council policy truly cared about Palestinians or humanity, they would be advocating for Hamas to stop firing missiles into Israel on a daily basis, cede power and stop using Palestinians as human shields by building their terror network in order to maximise their own civilian casualties. Also, when the fatality rates are supplied by Hamas on a daily rate, and include 471 children and healthcare workers killed in Al Ahli Hospital on the 18 October, despite the fact it was later categorically proven that the hospital was not bombed, but a misfired Islamic Jihad rocket took out the car park, and on other days the statistic for 'women and children' adds up to more than the total daily tally; one can conclude the figures supplied by the propagandists are totally fake, and just another part of their war on public opinion.

In more clumsy grandstanding, this motion calls for an end to 'illegal settlements" which might sound reasonable to those who don't understand that those settlements have already been established as land swaps in any peace deal. Israel has offered 96% of the land Palestinians claim to want, with the other 4% in land swaps. Every peace deal has been rejected by Palestinian leaders who know that they will be assassinated by their own side if they were to accept that Israel was allowed to exist within ANY borders. In fact, this is not a land dispute but an ideological conflict where terror groups openly admit they seek all of Israel – from the River (Jordan) to the Sea (Mediterranean).

I suggest you consult a map and see what is left.

Media reports indicate Councillors at Merri-Bek, Darebin and Greater Dandenong have received death threats when abstaining or voting against such Notices of Motion. Social media channels at various councils such as Maribyrnong, also show extensive hate speech towards Councillors voting against as was the case at Maribyrnong City Council when they considered a recission motion.

Indeed, Councillor Oscar Yildiz, from Merri-Bek City Council, has taken a leave of absence, due to the incessant threats against him and his family after being one of four Councillors who voted against the motion condemning Israel and their alleged war crimes.

Cr Yildiz, the two time Mayor/Deputy mayor of Merri–Bek, said he and the other 'no' voting Councillors had received serious threats. In a statement on Linked In, Cr Yildiz said "a motion was put to Merri–Bek Council to vote on this global issue – a Vote which I believe was put up by self–serving individuals, simply doing it for their own political aspirations. I and 3 other Councillors voted against this motion purely on the basis that this was not within our remit as Local Government to act upon. I maintain my position that as Local Government we need to uphold our accountability to use our resources for matters we were elected for. In standing up for my elected responsibility, I have received unimaginable hate, death threats and threats against the safety of my family, as have the other 3

At the City of Greater Dandenong, Councillor Tim Dark, reported he too had received death threats after voting against a Notice of Motion to call for a ceasefire. At the Council Meeting on 22 January 2024, Cr Dark read from a letter sent to the council from Victorian local government Minister Melissa Horne urging the Council to not get involved in foreign affairs. The letter stated "The Israeli and Hamas conflict is a complex global situation that needs to be negotiated by world leaders and not the Victorian local government sector,".

Darebin Councillors too were subject to coercion, bullying and threats after agreeing to not fly the Palestinian flag on 8 January 2024. A recission motion was put forward to remove the Palestinian flag after receiving numerous concerns from residents that the motion was divisive and unsafe. The motion failed on 22 January 2024, as although some Councillors stood by their decision to take the flag down, others, including the Mayor, supported keeping the flag flying saying no flag was worth their family's life.

As these coercive tactics have been used successfully on other councillors, I would urge you to avoid such dangerous risks for your own councillors and please sidestep the whole unnecessary process which endangers both yourselves and Jews like myself, who are living in fear.

I write to you regarding an issue of concern that has come to my attention within the council's upcoming deliberations

As a member invested in the welfare of our community, I firmly believe that our council's primary focus should remain on matters of local governance and community well-being. While international issues undoubtedly hold importance, venturing into such territory can often lead to contentious reactions and unnecessary conflict within our council chambers.

It is imperative that we maintain a respectful and supportive environment for all constituents, ensuring that discussions remain constructive and directly pertinent to the needs and concerns of our municipal district.

As such, I urge caution in considering motions that extend beyond our immediate jurisdiction, carefully weighing the potential benefits against the inherent risks posed to the well-being of our local members. It is crucial to acknowledge the potential consequences of introducing motions pertaining to controversial international matters. Such actions may inadvertently subject dissenting members to possible instances of bullying and harassment.

The motion from Councillor Hakim is one sided and does not ask for Hamas to ceasefire. It also asks for Israel to release Palestinians in prison who are there for legitimate crimes against Israel.

It also mentions end to illegal settlements on the west Bank – this is a complicated matter and Israelis have been there for years – very small minority compared to the Palestinian settlements such as Ramallah and Jenin which are hotbeds of Hamas,

Again there is a mention of Islamophobia. This is a made up term as there is no such thing. However, there has been a 700% increase in anti Semitism in the world today since the atrocities of October 7, in fact the day after at the Opera House was a prime example. Not even one day after when Israel was trying to work out what had happened and was in the midst of trauma, there were calls of "where are the Jews" and "F..k the Jews". This is pure hate and more of this is seen in the city of Melbourne than anywhere else – constant graffiti and demonstrations and harassment of businesses.

This is what is truly happening. No one targets Muslims. But Jews are all the time. Not sure if Councillor Hakim would like this type of constant harassment. The Jews in Melbourne are not responsible for the war in Gaza.

Israel prides itself on upholding the law and if anything happens that concerns it, it will deal with it. It has not committed war crimes - Hamas has and will be called to account once the conflict ends.

And I remind the Council once again, the war was started by Hamas. Pure and simple. Israel is defending itself like Australia would in similar circumstances. It does not attack willy nilly. There are 500 miles of tunnels underground with terrorist hiding there as are hostages being still held. It is a difficult and horrible war. All war is horrific.

And Israelis too are traumatized and suffer.

My name is Wilmie Schoots, I'm a resident in Carlton. I was born in South Africa and am so thankful to have found a home in our amazing city and am building a life here.

In the last 135 days I have been witness to some of the most horrific images and videos that I have even seen. But I have felt compelled to bear witness and I have done so from the comfort of my own home, here in Melbourne. I do this knowing that my pain and distress is merely a fraction of the Palestinians that are living through it and those watching their families being slaughtered.

There can be no justification for the disproportionate actions taken by the Israeli government and military. The ICJ have ruled that there is credible evidence that Israel is committing a genocide and must do everything it can to prevent civilian deaths. That has not stopped military aggression unfortunately. At this time, to do anything other than call for a ceasefire (at the very least) is to be complicit in the genocide of the Palestinian people.

Over 30,000 civilians have been killed in Gaza, about two thirds of them women and children, with thousands more under rubble. The 2.2 million people of Gaza have been placed under siege by Israeli forces, with limited to no access to water, food, electricity, medicine or fuel. Most have now been displaced once again. Rafah, the last 'safe zone' is now under heavy bombardment, and politicians, army personnel, and settlement leaders have made it clear that Gaza will not be a home for any Palestinian to return to. In fact, they've asked governments around the world to accept Palestinian refugees as part of their plan to displace the entire population.

Refugee camps, schools, hospitals and mosques are being targeted, as are teachers, journalists, healthcare workers, doctors and aid workers. International bodies such as the UN are pointing to evidence of war crimes and genocide.

I believe that Councillor Jamal Hakim has prepared a robust and considered motion that is based on facts steeped in humanitarian and international law, widely accepted by most countries around the world, including Australia. Facts are facts, and you should feel courageous to stand up for these in the debate on Tuesday.

For the sake of local democracy and global justice I therefore request that you vote in favour of the motion.

For the sake of our souls and our conscience and our morality, I beg that you support the human rights, self determination and freedom of all Palestinian people.
