# **Report to the Future Melbourne Committee**

### MPavilion 10 extension to June 2025

Presenter: Rick Kwasek, General Manager Infrastructure and Amenity

#### Purpose and background

- 1. The purpose of this report is to request the Future Melbourne Committee approve MPavilion 10 remaining in the Queen Victoria Gardens until 30 June 2025. The report results from a request by Naomi Milgrom Foundation (NMF) (refer Attachment 2).
- 2. MPavilion 10 was approved by Council, Heritage Victoria and Department of Environment, Land, Water and Planning (DELWP) (now Department of Energy, Environment and Climate Action (DEECA)) as a temporary structure. It is due for closure and removal on 28 March and 9 June 2024, respectively.
- 3. If retained, MPavilion 10 is proposed to remain free and open to the public, 10am to 3pm daily on nonevent days. Programming runs from start November to end March. During the off-season (April to October), NMF will offer MPavilion for select events, including council programs.

#### Key issues

- 4. MPavilion is a significant contributor to Melbourne's global design and cultural identity; and the result of a longstanding partnership between CoM, Creative Victoria and NMF. The partnership is in its tenth year.
- 5. Council has supported MPavilion through \$300,000 funding and \$50,000 in-kind support, annually. Funding covers program delivery and events, in-kind support covers council officer time on MPavilion design and delivery. Council funding ceases in June 2024. Creative Victoria program funding expires in June 2025.
- 6. The City of Melbourne Domain Parklands Masterplan (2019) recommends a continuation of the current ornamental and passive recreation status for Queen Victoria Gardens.
- 7. MPavilion 10 was designed by globally revered architect, Tadao Ando. The design is an iconic piece of architecture and a challenging urban intervention. Safety, security and public access are key concerns that have been considered in assessing NMF's proposal (refer Attachment 3).
- 8. Between the program's end, and a decision being made by Council, NMF propose to continue public access to MPavilion 10.
- 9. The design community is divided about the opportunity.
  - 9.1. Some individuals have expressed concerns with the removal of a well-constructed pavilion, and the perception of material waste in a climate and biodiversity emergency. Granting the extension enables the delivery of the 2024/25 program within the current MPavilion structure. At the end of the one-year extension, parts of the structure can be relocated, while other elements can be recycled.
  - 9.2. Some individuals have expressed concerns with the ongoing safety, presentation and maintenance of the pavilion, given its enclosed nature and expansive perimeter walls. NMF have confirmed that it will take full responsibility for the maintenance and security of MPavilion 10 throughout the extension period, including covering financial costs of operation and minor modifications.
  - 9.3. Multiple letters of support accompany NMF's proposal (refer Attachment 2).
- 10. If approved, NMF have committed to fund and cover all costs associated with:
  - 10.1. ensuring ongoing safety, security and maintenance
  - 10.2. working with council to run potential activations within and around MPavilion 10
  - 10.3. reuse and repurposing of MPavilion 10 at the end of the extension period

- 10.4. reinstatement of the site in line with the terms of the licence.
- A decision from Council is required to retain MPavilion 10. Its retention is also dependent on approval 11. from Heritage Victoria and DEECA. Subject to DEECA approval a new licence will be negotiated. No planning permit is required.

#### **Recommendation from management**

- 12. The Future Melbourne Committee:
  - 12.1. subject to the necessary consents under the Heritage Act 2017 and the Crown Land (Reserves) Act 1978, approve the MPavilion 10 remaining in the Queen Victoria Gardens until 30 June 2025.

#### **Supporting Attachment**

#### Legal

- 1. Council is the trustee for the Queen Victoria Gardens and the Committee of Management for the Gardens pursuant to the *Crown Land (Reserves) Act 1978* (Act).
- 2. The extended use of Queen Victoria Gardens for MPavilion will require the consent of the Minister responsible for the Act and a further licence from the Council under the Act. This includes the publication of the consent in the Victorian Government Gazette and the consent to be tabled in Parliament for five sitting days.

#### Finance

- 3. There are minimal financial issues arising from the recommendations contained in this report. Queen Victoria Gardens is only suitable for low impact events, so loss of revenue is considered negligible as the space is not generally hired out for events.
- 4. NMF will cover all costs associated with the ongoing safety, security, maintenance, activation and reuse/repurposing of the MPavilion and reinstatement of the site.

#### **Conflict of interest**

5. No member of Council staff, or other person engaged under a contract, involved in advising on or preparing this report has declared a material or general conflict of interest in relation to the matter of the report.

#### Health and Safety

6. Relevant considerations including potential amenity impacts that could impact on health and safety have been reviewed as part of the assessment process.

#### Stakeholder consultation

7. The project is led by the Naomi Milgrom Foundation. The program has operated for 10 years. Noting the item is confidential, informal stakeholder consultation has been undertaken with select members of the design community.

#### **Environmental sustainability**

9. The 12-month extension will allow for further consideration of the reuse and repurposing of MPavilion 10 at the end of the extension period.

# **MPAVILION**

**MPavilion** is Australia's most idea-driven architecture commission and design festival.

Since 2014 MPavilion has delivered nine architectural commissions (the 2020 MPavilion program took place in a car park). The nine architects have included two Australian architects, both Australian Institute of Architect Gold Medalists, and seven international architects whose first work in Australia was MPavilion.

MPavilion is not a program or activity of any institution. It is offered by a philanthropist as a a unique fixture in Melbourne's summer calendar. MPavilion is created as a place celebrating and encouraging deeper knowledge and appreciation of the role of architecture and design in improving Australian lives, through a program which is free and open to all.

At the end of each season, the Naomi Milgrom Foundation gifts the MPavilion structure to the community. This has resulted in seven new civic structures designed by the world's leading architects relocated as permanent venues across Melbourne. The owners of the gifted MPavilions host a range of activations and events, and for general use by the broader community.

# **MPAVILION 10**

MPavilion 10 is the 10th commissioning series of iconic MPavilions in the Queen Victoria Gardens.

Designed by **Pritzker Prize winning** Japanese architect Tadao Ando as his first and likely only project in Australia, due to his advanced age and poor health.

The response to this pavilion has been incredibly strong, with 245 international media articles across Asia, Europe and the USA.

Designboom, the most popular global digital magazine for architecture and design have included MPavilion 10 in their Top 10 Pavilions of 2023.



# **ARCHITECTURAL DESIGN**

Tadao Ando's design for MPavilion encapsulates his desire to create a memorable structure that responds directly to the Gardens. It strives for spatial purity, employing the geometry of circles and squares to create a space in harmony with nature, a tranquil sanctuary reminiscent of a traditional Japanese walled garden.

MPavilion 10 features a large canopy, a 14.4metre aluminium-clad disc resting on a central concrete column. Two offset squares create two entrances that lead to the centre of the pavilion. A long horizontal opening running the length of both the north and south walls frames views of the Melbourne skyline and parklands, connecting the city and lush greenery of the Queen Victoria Gardens to the interior. The geometric forms and symmetry are reinforced by an internal arrangement that is half-paved and half-reflecting pool, which mirrors the canopy, sky, city and surrounds.

- MPavilion 10 has been designed by one of the world's greatest living architects and is likely to be his only project in Australia and the Southern Hemisphere. We believe it deserves a longer presence than this current five month season for Melburnians and visitors alike to enjoy.
- Creative Victoria has confirmed funding a further MPavilion and the Foundation is committed to delivering another season of programming.

# WHY SHOULD MPAVILION 10 BE EXTENDED?

- MPavilion holds a high educational value as demonstrated by the strong engagement by the architectural and design community including the Australian Institute of Architects who have included MPavilion in its recently released architectural walking tour app.
- The redevelopment of Arts Centre Melbourne and the broader Melbourne Arts Precinct will be disruptive. MPavilion would continue to attract foot traffic and visitation connecting Fed Square to the Myer Music Bowl and the Royal Botanic Gardens.



# **OPPORTUNITIES**

- MPavilion is unique to Melbourne and contributes to Melbourne's global reputation as the design capital of Australia.
- Much like the Mies van der Rohe Pavilion in Barcelona, the Tadao Ando MPavilion attracts many local, national and international visitors.
- NMF welcome the opportunity for Council to utilise the pavilion during the off-season (April to October) for events that align with their vision for MPavilion, such as Now or Never festival.



# PROPOSAL

# Extension to 2025

- The MPavilion 10 program ends 28 March 2024.
- During the off-season, MPavilion will remain free and open daily to the public. On non-event days, opening hours are proposed to be 10am to 3pm (weather permitting).
- The next MPavilion program will commence 21 November 2024.



# PROPOSAL (CONT'D)

- During the off-season, the Naomi Milgrom Foundation (NMF) will offer MPavilion for a limited number of offseason cultural and design events and activations, aligned with the Foundation's objectives.
- NMF, in close consultation with CoM, will work with Architect Tadao Ando and Executive Architect Sean Godsell to undertake minor modifications to the MPavilion for long term security, maintenance and safety. NMF will cover all costs in relation to the modifications.
- NMF will take full responsibility for the maintenance and security of the MPavilion structure throughout this period, including covering financial costs of operation





#### Extension to MPavilion 10 at Queen Victoria Gardens

I write to support the idea of extending Tadao Ando's MPavilion No 10.

Although seemingly a simple structure, its beauty lies in its understated refinement. Quite simply, it's possibly the most refined and most difficult MPavilion executed to date. A five-month lifespan is not long enough for such a unique object. Melbourne deserves more.

This MPavilion's author is one of the most famous architects in the world. We are lucky he agreed to this commission. It will become internationally recognised and awarded in due course, providing an important tourist destination for Melbourne. Ando's work is keenly sought out, whether in Japan or overseas, by an army of devotees.

Tadao Ando is in the latter years of his career, making MPavilion 10 highly valuable. It is a signature piece, and we are lucky to have it, just like other iconic architectural masterpieces; the Myer Music Bowl by Barry Patten, National Gallery of Victoria by Sir Roy Grounds, and Federation Square by LAB Architecture Studio.

Public response has been overwhelming, given the unique effect it has on its visitors. It evokes an intimate and memorable response, which has generated a lot of debate and positivity from many people I know.

I believe MPavilion 10 is the most refined of all the previous MPavilion iterations. This building is extremely durable and could last for 100 years. I hope that Melbourne City Council will agree to extend its life by at least one year.

Its form makes it adaptable to all kinds of events that can occur in Melbourne's unpredictable climate. It is perfect for both summer and winter events, given the protection provided by its perimeter walls, whilst its internal umbrella-like roof provides good weather protection.

I would be happy to accompany you as part of a delegation to Melbourne City Council if you desire, to support this proposal, and I'm available for additional comment.

## Attachment 3 – Considerations

#### Background

- 1. MPavilion is an annual public program operated by Naomi Milgrom Foundation (NMF) and supported by the City of Melbourne (CoM), Creative Victoria and 30 corporate and community partners. For almost each of the past 10 years, a new pavilion, designed by an internationally prominent architect, has hosted the program from November to March. The pavilions are deconstructed by June of the same year.
- 2. Council has supported MPavilion through funding of \$300,000 and in-kind support to the value of \$50,000, annually. In December 2021, Council approved program funding for 2022/23 and 2023/24, subject to the necessary approvals. Creative Victoria funding exists for one more year of programming to June 2025.
- 3. MPavilion 10 was designed by globally renowned Japanese architect and Pritzker Prize laureate, Tadao Ando. Ando is globally recognised as one of the world's greatest living architects. MPavilion 10 is likely to be his only project in Australia and the Southern Hemisphere, due to his advanced age and poor health. The response to this pavilion has been strong, with 245 international media articles from across Asia, Europe and the USA.
- 4. Ando's design for MPavilion 10 seeks to create a space in harmony with nature, reminiscent of a traditional Japanese walled garden. The pavilion features a large canopy resting on a central concrete column. Two offset squares define the two entrances to the pavilion. A long horizontal opening runs the length of the north and south walls, at eye level. The pavilion interior is half paving and half reflecting pool.
- 5. NMF propose to retain MPavilion 10 in its current location, for 12 months beyond the current permit end date, to June 2025. Particulars of the proposal are provided below.
  - 5.1. If retained, MPavilion 10 is proposed to remain free and open to the public, 10am to 3pm daily on nonevent days (weather permitting). MPavilion programming runs from start November to end March. During the off-season (April to October), NMF will offer MPavilion for a limited number of off-season cultural and design events, including potentially, the Now or Never festival and other council programs.
  - 5.2. NMF, in consultation with CoM, will work with Ando and Executive Architect Sean Godsell to undertake minor modifications to the MPavilion for long term security, maintenance and safety. NMF will cover all costs in relation to the modifications.
  - 5.3. NMF will take full responsibility for the maintenance and security of the MPavilion structure throughout this period, including covering financial costs of operation. NMF currently fund overnight security for asset protection.
- 6. NMF have not requested further funding and are aware that Council cannot provide additional in-kind support.

#### Issues

- 7. As MPavilion was initially approved by Council as a temporary structure, a decision from Council is required to retain it. Its retention is also dependent on approval from Heritage Victoria and DEECA. Subject to DEECA approval a new Crown Land (Reserves) Act Section 17B licence will also be negotiated. Due to the temporary nature of the request, no planning permit is required.
- 8. MPavilion 10's design precludes through views and movements across the site. This presents potential risks to the structure, public safety and City of Melbourne's reputation as follows.
  - 8.1. The design is not consistent with best practice gender equity place principles.



- 8.2. The reflection pool poses water safety issues, exacerbated by a lack of through-site passive surveillance. The presence of a reflection pool is deemed to be a low risk given the presence of other open shallow pools within the gardens.
- 8.3. The blank external walls of the pavilion are susceptible to tagging and graffiti.
- 8.4. The structure is climbable.
- 9. Queen Victoria Gardens is recognised as an ornamental garden and is managed as a passive, low key recreational space. It is a heritage feature at both a State and National Level and also a fragile environment, not designed to accommodate permanent structures and regular activation for events or large gatherings. The City of Melbourne Domain Parklands Masterplan (2019) recommends a continuation of the current ornamental and passive recreation status for Queen Victoria Gardens.
- 10. Council events such as the Now or Never festival may be able to utilise MPavilion 10 for some programming, though its small capacity (150 pax, 80-100 seated) limits potential applications. Additional events in Queen Victoria Gardens would be subject to regular permitting and approvals processes and be assessed against the guidelines for use. As identified in point 10 above, the gardens are not ordinarily approved for events due to their ornamental nature, however events within the MPavilion are generally acceptable.
- 11. MPavilion is a significant contributor to Melbourne's design identity and cultural reputation. An extension of its use at Queen Victoria Gardens will continue to attract cultural and architectural tourism, and positively activate the site during a period of construction disruption in the Melbourne Arts Precinct. Since opening, an average of 820 people have visited MPavilion each day, with many international, interstate and outer Melbourne residents travelling to the precinct to experience Ando's design.
- 12. Multiple testimonials and letters of support accompany NMF's proposal. These are included at Attachment 2. Letters have been received from Jill Garner (The Office of the Victorian Government Architect), Cameron Bruhn (Australian Institute of Architects), Peter Maddison (Maddison Architects), Paul Bangay (PRB Design), Georgie Cleary (Alpha 60), Andrew McConnell (Trader House) and John Gollings (Gollings Photography. Some of the letters outline an interest in activating MPavilion during the off-season.
- 13. While in a different context, it is important to be mindful of similar structures which have been demolished in the past due to undesirable behaviour. An example of this is the Fitzroy Gardens toilet, built in 1957 and demolished in May 2006 due to "complaints about offensive and intimidating behaviour from individuals who linger there".
- 14. A decision from Council is required by end April to allow time for NMF to coordinate demolition and removal of the structure if the request for an extension is declined. Removal of the pavilion and make good of the site is estimated to take six weeks plus lead time.
- 15. NMF is responsible for all make-good works. A \$25,000 security grant, held by Council, will be released to NMF following the return of the site in its original state.

#### Risks

- 16. All previous MPavilion structures on this site have been temporary and relocatable. Unlike previous MPavilions, the concrete walls of MPavilion 10 cannot be disassembled for relocation and will either be repurposed or recycled. The circular steel and aluminium roof, bluestone paved floor and concrete benches are fully relocatable.
- 17. While an extension could be viewed as opening the door for further advocacy on permanent retention, NMF have confirmed that the request applies to one year only.
- 18. The design community is divided about the opportunity.
  - 18.1. Some individuals have expressed concerns with the removal of a well-constructed pavilion, and the perception of material waste in a climate and biodiversity emergency. Granting the extension enables the delivery of the 2024/25 program within the current MPavilion structure. At the end of the one-year extension, parts of the structure can be relocated, while other elements can be recycled.



- 18.2. Some individuals have expressed concerns with the ongoing safety, presentation and maintenance of the pavilion, given its enclosed nature and expansive perimeter walls. NMF have confirmed that it will take full responsibility for the maintenance and security of MPavilion 10 throughout the extension period, including covering financial costs of operation and minor modifications.
- 19. The Queen Victoria Gardens are included on the Victorian Heritage Register and the National Heritage List as a component of Melbourne's Domain Parkland and Memorial Precinct. One of the listed features under the National registration is: the parkland landscape of the Domain Parklands with its Victorian era features of statuary, garden planting and memorials. Retention could invite public scrutiny on heritage impact and suitability of this arrangement for the site.
- 20. Melbourne Arts Precinct Co (MAPCo) have expressed an interest in placing infrastructure (such as a Spiegeltent) in Queen Victoria Gardens to extend their programming. Supporting the extension of MPavilion 10 could make it more challenging to decline other requests to place infrastructure for events in this park. The guidelines for use of this park restrict such activity.
- 21. Between 28 March (program end) and a decision being made by Council, NMF propose to continue public access to MPavilion 10.
