  - 2.2 resolves to suspend the City of Melbourne's sister city relationship with St Petersburg until such time as St Petersburg's regional anti-gay laws are revoked, as other Sister Cities of St Petersburg have done
- 3. requests management to draft appropriate resolutions for both scenarios outlined in section 2 for consideration at the Council meeting on 17 December 2013.
