Post travel report by Councillor Kevin Louey: 14–16 October 2015

15 December 2015

Presenter: Cr Kevin Louey, Chair Economic Development Portfolio

Purpose and background

- To report to the Future Melbourne Committee on the travel undertaken by Councillor Kevin Louey to Manila, Philippines associated with the 2015 Business Partner Cities (BPC) Roundtable for the period 14–16 October 2015.
- 2. On 11 August 2015, the Future Melbourne Committee approved the proposal for Cr Kevin Louey to travel to Manila, Philippines for the period 14–16 October 2015 to participate in the BPC Roundtable.
- 3. Councillor Louey was accompanied by an International and Civic Services officer.

Key issues

- 4. There was strong representation from BPC members at this year's Roundtable which provided Councillor Louey with the opportunity to further strengthen long standing connections with BPC members. Presenting to the Roundtable theme "Building Sustainable Regional and Global Economies through Small to Medium Enterprise (SME) Participation", Cr Louey focused on the importance of a resilient and globally connected municipality by supporting Melbourne's knowledge sector industry through Council led initiatives such as inbound and outbound business missions, advocacy activities and provision of financial support such as the Small Business Grants program.
- 5. At the conclusion of the conference, it was announced that Ho Chi Minh City will host the 2016 BPC Roundtable in the second half of the year. To gain maximum economic benefit from the opportunity, Melbourne was strongly encouraged by the host city and BPC Secretariat to consider leading a business mission to Vietnam. This opportunity will be explored further in collaboration with BPC Network comember, the Australian Industry Group.
- 6. Cr Louey used the occasion to meet with the Department of Trade and Industry, Philippines, The Philippines Economic Zone Authority, The Australian Ambassador to the Philippines and members of the Makati Business Club. These meetings provided an opportunity to learn more about the general Philippine economy and discuss opportunities for Melbourne companies to engage with Manila business, particularly in service industries such as professional services and education.
- 7. Participation at the Roundtable also provided opportunities for discussions with the BPC Secretariat and City of Osaka representatives in the lead up to the City of Melbourne business mission to Medical Japan (February 2016).
- 8. A meeting was also held with International Container Terminal Services Inc. to receive an update on the construction of the Victoria International Container Terminal at Webb Dock and explore ways that Council can support significant investment into Victoria's major infrastructure by foreign owned companies.

Recommendation:

- 9. That Council:
 - 9.1. notes this report and the incorporated summary of benefits and outcomes
 - 9.2. note that management will investigate the opportunity to participate in the 2016 Business Partner Cities Roundtable to Ho Chi Minh City, including leading a targeted business mission to that city, and provide a further briefing to Councillors at a later date.

Supporting Attachment

Finance

1. The cost associated with Councillor Louey's participation in the 2015 BPC Roundtable in Manila was \$5363.97. This included airfare (\$3974.40), accommodation (\$1105.73) and incidentals (\$283.84).

Conflict of interest

2. No member of Council staff, or other person engaged under a contract, involved in advising on or preparing this report has declared a direct or indirect interest in relation to the matter of the report.

Relation to Council policy

- 3. The Manager Governance and Legal, has confirmed that the travel costs accord with the requirements of the travel guidelines outlined in the Councillor Expenses and Resources Guidelines.
- 4. The travel aligns with Council Plan 2013–17, Goal 3: a prosperous city and year four outcomes of a sustainable resilient municipal economy that is globally connected.

Environmental sustainability

- 5. The travel facilitated opportunities for Councillor Louey to profile Melbourne expertise in the green space such as sustainable urban design with the Philippine government and business leaders.
- 6. The carbon emissions resulting from air travel were offset with the purchase of credits.

ACTIVITIES, ACTIONS AND BENEFITS OF TRAVEL

Activities and actions

- 1. Met with Mr Bill Tweddell, Australian Ambassador to the Philippines and Mr Anthony Weymouth, Senior Trade Commissioner to receive in-market updates and discuss the potential for City of Melbourne businesses to engage with that country. Specific sectors for further consideration include professional services, food and beverage and education.
- 2. Met Director Emma C. Asusano from the National Capital Regional Office of Department of Industry and Trade (DIT) for discussions on strategies to support small business. As Small to Medium Enterprises (SMEs) in Manila represent 99 per cent of total business, DIT initiatives such as their Shared Service Facility Program are crucial. This subsidised program allows small business to share infrastructure such as facilities and manufacturing equipment, thereby reducing costs and increasing collaboration. DIT run a number of successful support programs such as an SME Academy Program as well as operating Business Centres across the Philippines which includes access to Business Counsellors for practical advice like financial information or marketing strategies.
- 3. Hosted a Melbourne Manila networking dinner with attendees including Atty. Ernesto Maceda Jr, President of the Universidad de Manila, Mr Peter Perfecto and Ms Danielle del Rosario Makati Business Club, Ms. Maria Roseni Alvero, Assistant Secretary of the Foreign Trade Service Corps, Mr Vichael Angelo D. Roaring, Trade Officer, Foreign Trade Service Corps and Atty Luch Gemphis, Secretary to the City Council, City of Manila. Discussions centred on Manila Melbourne collaboration and proved to be an informal opportunity to discuss ways in which both cities can work together to increase business opportunities for mutual benefit.
- 4. Met with Christian Gonzales, Head, Asia Pacific and the Subcontinent International Container Terminal Services Inc. (ICTSI) to receive construction updates on the Victoria International Container Terminal and discuss ways for Council to support ICTSI's \$550 million investment in Victorian major infrastructure. A further meeting in Melbourne with the Lord Mayor was offered to Mr Gonzales.
- 5. Participation in the BPC Roundtable reaffirmed Melbourne's connections to trade offices and cities in the network and informed new attendees of our role in facilitating business and trade.

Benefits

- 6. Benefits arising from the activity for the City of Melbourne include:
 - 6.1 Strengthened connections with senior Australian in-country representatives from the Australian Government and the Australian Trade Commission (Austrade).
 - 6.2 Increased knowledge of the Philippines economic climate and complimentary areas for Melbourne businesses to seek opportunities. Created a business channel for Melbourne business to utilise for market entry purposes.
 - 6.3 Reaffirmed City of Melbourne's long standing connections with attending members of the Business Partner Cities Network.
 - 6.4 Gained support from 2016 host city Ho Chi Minh City and Secretariat City of Osaka for Melbourne to consider leading a business mission to Ho Chi Minh City for next year's Roundtable.
 - 6.5 Raised the profile of the City of Melbourne's capabilities in city management, as well as key industry sectors such as sustainable urban design and clean technologies to the Jakarta Provincial Government and identified the potential to receive a government delegation to showcase these areas.

BPC Roundtable Meeting 2015 Manila

On October 15, 2015, the City of Osaka, the Osaka Business Partner City Council and the Department of Trade & Industry Philippines, Foreign Trade Service Corps (DTI, FTSC) held "BPC Roundtable Meeting 2015" in Manila City, Philippines.

This years' meeting, in which representatives from Business Partner Cities (BPCs) came together to facilitate promotion of business interaction within the Asia—Pacific region through economic exchange, was the 26th of its kind. Seven cities presented their strategies and measures and there was a lively exchange of views under the theme of "Building Sustainable Regional and Global Economies Through SME Participation" together with discussion of the Trans-Pacific Strategic Economic Partnership Agreement (TPP), which has recently been a subject of major attention.

On behalf of the host city, a business overview and a presentation on the trade and investment environment in the National Capital Region (Metro Manila) were jointly delivered by the Foreign Trade Service Corps of Department of Trade & Industry (FTSC), the Export Marketing Bureau of the Department of Trade & Industry (EMB), the City of Manila, and the Philippine Chamber of Commerce and Industry (PCCI).



At the end of the meeting, the People's Committee of Ho Chi Minh City announced that it was prepared to host the next roundtable meeting in Ho Chi Minh City and this offer was unanimously accepted by the participants.



On the same day, concurrently with the BPC Roundtable Meeting, a special lecture and luncheon were hosted by the Philippine Economic Zone Authority (PEZA), and a business matching event was held in separate rooms with the cooperation of the Consulate-General of the Republic of the Philippines in Osaka, the Philippine Trade & Investment Center, the

Foreign Trade Service Corps of the Department of Trade & Industry (FTSC), the

Philippine Economic Zone Authority (PEZA), the Board of Investments of the Department of Trade & Industry Philippines (BOI), and the Philippine Chamber of Commerce and Industry (PCCI), both of which were very successful events.
