   Annual Plan and Budget as requested in the written submission from ACMI for the following reasons:
  - 1.1 Whilst management is supportive of the need to upgrade the amenity along the Flinders Street frontage adjacent to Federation Square, the detailed proposal put forward by ACMI is not feasible from an appearance and maintenance perspective and will need to be modified to meet the City's requirements.
  - 1.2 This project can be included in the advanced design program for City Design Studio for next financial year for which funding is already allocated. This will allow the City to produce a suitable design response for consideration in the 2017–18 Annual Plan and Budget process.
