## Purpose and background

1. The purpose of this report is to inform the Council of the financial performance of the 2015–16 Council works program at the end of the fourth quarter. It also outlines the progress of Council's major projects in Attachment 3.

## **Key issues**

- 2. The overall program tracked behind plan for the fourth guarter period. The value of work completed at the end of the fourth guarter was \$85.04 million out of an accumulated budget of \$113.99 million. This resulted in \$28.95 million underspend of which it is proposed to carry forward of \$26.4 million for projects still to be completed, including multi-year projects, into the 2016-17 financial year.
- 3. Significant milestones achieved during the fourth quarter include:

- Lincoln Square Plaza work commenced in April 2016 with schedule completion at the end of 3.1. September due to additional work required to repair vandalism during initial stages of construction - especially Swanston Street walls.
- 3.2. Flemington Road Oval pavilion works commenced in May 2016.
- Docklands Park Enhancement Works works completed at end of May 2016. 3.3.
- Elizabeth Street (southern end) agreement to commence targeted stakeholder engagement in 3.4. August 2016, subject to FMC approval.
- 4. Satisfactory progress is continuing on other major projects including:
  - 4.1. M Pavilion 2015 - relocated to Docklands with construction scheduled was completed in July 2016.
  - 4.2. Lincoln Square Stormwater Harvesting (tanks only) - work continuing with expected completion in September 2016.
  - University Square negotiations continue with MMRA to facilitate better outcomes for University 4.3. Square and the Parkville Precinct. Negotiations continuing with final community engagement scheduled to start in August, 2016.
  - 4.4. Southbank Boulevard preparations for Phase 2 community engagement scheduled to commence on 19 August 2016 and road discontinuance process started.
- 5. JH Boyd Redevelopment - Following resolution from the Future Melbourne Committee held on 3 May 2016 the contract with Cario Melbourne Pty Ltd (Cairo) was terminated and the project team are working towards preparing revised documentation for the project to be publicly advertised in 2016–17 financial vear.
- 6. A detailed report is provided in Attachment 2 of this report.

## 2015–16 Council Works Program Fourth Quarter Report

#### 1. Overview

The cumulative value of work at the end of the 2015-16 financial year was \$85.04 million compared to the accumulated Year to Date value of \$113.99 million.

Milestones achieved in the fourth quarter include:

- Lincoln Square Plaza work commenced in April 2016 with schedule completion at the end of September due to additional work required to repair vandalism during initial stages of construction – especially Swanston Street walls.
- Flemington Road Oval pavilion works commenced in May 2016
- Docklands Park Enhancement Works works completed at end of May 2016
- M Pavilion 2015 relocated to Docklands with construction completed in July 2016
- Lincoln Square Stormwater Harvesting (tanks only) work continuing with expected completion in September 2016.
- University Square negotiations continue with MMRA to facilitate better outcomes for University Square and the Parkville Precinct. Negotiations continuing but final phase four community engagement scheduled to start in August 2016.
- Southbank Boulevard preparations for Phase 2 community engagement scheduled to commence on 19 August 2016 and road discontinuance process started.

## 2.1 Analysis

The maintenance program has achieved \$9.92 million compared to the planned value of \$10.41 million (95.3%).

The new/upgrade works program achieved \$23.97 million compared to the planned value of \$41.10 million (58.32%).

The renewal works program achieved \$50.02 million compared to the planned value of \$60.69 million (82.42%).

In total the Council Works Program achieved 74.6% of planned value of work for the 2015-16 financial year. The major variances to the planned value of works are:

- Living Victoria Fund \$6.3 million
- Property Services New and Renewal Works have underspent planned value of works by \$6.84 million. \$4.94 million has been surrendered as surplus.
- Royal & Princes Parks Recreation Infrastructure Improvements \$2.28 million
- Major Streetscape Improvements and Design- \$1.19 million
- Bicycle Improvement Program \$1.08 million
- Street Lighting Upgrade \$969k
- Flood Mitigation New Works \$941k
- Public Art Program \$924k
- Parks Renewal Works Program \$731k
- Railway Place and Miller Street Reserve Park Expansion \$703k
- Street Lighting Renewal (LED rollout New Upgrade) \$615k
- North Melbourne Reserve New Landscaping & Synthetic Court \$577k
- MacArthur Square Upgrading \$464k

## 2.2 Program Adjustments

Program adjustments have been included in Attachment 4. The main adjustments for 2015-16 are:

- Purchase of the QVM Munro site and 104 Hawke St totalling \$76.35 million
- Additional funds approved by Council relating to QVM Precinct Renewal \$4.64 million
- Additional external capital contribution of \$1.71 for the purchase of 104 Hawke Street, West Melbourne
- Implementation of Docklands Community and Place Plan received funds of \$1.55 million from Places Victoria.
- A proposed decrease of \$1 million for the Street Lighting Upgrade project is recommended as maintenance provisions for the LED changeover were are pending the CitiPower offer to be finalised
- Living Victoria Fund has been revised down by \$900,000 which was expected to be received from the University of Melbourne. Funds were due to be allocated to the University Square project, which has now been placed on hold due to Melbourne Metropolitan Rail impact on the project. Therefore proposed contribution from the University of Melbourne will not be required until 2016-17 financial year.
- Additional external funding from Vic Roads of \$769,800 for the Federal Investment Black Spot Programme for the traffic signal and safety improvement works

- External funding from Places Victoria for Docklands Park enhancement works at Victoria Harbour of \$750,000
- A transfer of \$650,000 to Railway Place and Miller Reserve Park Expansion, funds from Urban Landscapes Climate Adaptation was approved for additional Vic Roads Requirements, contaminated soil and safety lighting

## 3.2 Other Key Projects

## 3.2.1 M Pavilion - \$550,000

The M Pavilion is a contemporary pavilion primarily funded by the Naomi Milgrom Foundation with the support of the City of Melbourne, located in the Queen Victoria Gardens. A new pavilion will be provided each year over a 4 year period with the first pavilion relocated to the Hellenic Museum in February 2015.

The second pavilion – M Pavilion 2015, has been relocated from the Queen Victoria Gardens to Docklands where it is being reconstructed on the corner of Harbour Esplanade & Collins Street, fronting the Collins Street side. The works, including additional landscaping are scheduled for completion at the end of July 2016. The area is expected to open to the public in early August.

M Pavilion 3 2016–17 is programmed to begin construction in late July 2016 in the Queen Victoria Gardens.

## 3.2.2 Engineering Infrastructure Projects - \$17.39 million

## 3.2.2.1 Flood mitigation \$3.3 million

Five projects have been completed. These works are made up of the King Street, Collins Street and Spencer Street precinct drainage works and four other medium size projects. All the projects have been completed except small section of drain in Lt Bourke St due to services.

## 3.2.2.2 Roadway renewal \$5.1 million

The roadway renewal program consists of 48 projects. All the planned road projects have been completed ahead of schedule except road works in Haig St. Haig St road works carried forward to 16/17 financial year to complete after the drainage works.

## 3.2.2.3 Footpath Renewal \$4.5 million

The footpath renewal program consists of 62 projects. All the projects have been completed except two projects in Haig St and cardigan St.

#### 3.2.2.4 Drains Renewal \$2.8 million

Drainage renewals works consists of 21 projects. All the projects have been completed.

#### 3.2.2.5 Street Lighting Upgrade \$1.6 million

This work involved refurbishing street lights with LED technology. A Council approved initiative has led to Council securing a \$30 million loan from Clean Energy Finance Corporation, \$15 million of which is allocated for the LED refurbishment. A total of 1344 street lights owned by the Council and Jemena have been changed over to LED lights at a cost of \$821,000

Planning for the changeover of remaining lights to LED lights underway with power authorities, CitiPower/Jemena to identify the appropriate technology, delivery model and schedule

#### 3.2.3 Major Streetscape Improvements and Design – \$4.0 million

The following five Streetscape projects (bluestone paving of footpaths) have been completed in 2015-16:

- Flinders Street, Swanston Street to Russell St, North side
- Flinders Street, Russell St to Exhibition St, North side
- Collins Street, King Street to Spencer St, North side and South side
- William Street, St James Lane to Lt Collins Street, west side
- Balance (1.18million) carried forward to 2016/17 FY. This will be used for bluestone paving of Bourke St footpath on north and south sides and two minor projects differed due to building works.

#### 3.2.3.1 Elizabeth Street Streetscape \$3 million

The Elizabeth Street Streetscape works \$3 million capital funding from 2015–16 budget provided for the project was based on starting construction by mid-2016. Due to timing of the communication and community engagement program resulting out of Metro considerations, the construction for the southernmost section of Elizabeth Street has been delayed.

During the year \$700,000 was allocated to the Spencer Street pedestrian underpass which will now not proceed and the funds will be returned to Elizabeth Street. \$1.9 million was also allocated to Collins Street footpath upgrades and this work was completed in the financial year.

#### 3.2.4 Bicycle Improvement Program – \$3.9 million

Bicycle Improvement Program consists of over 50 various size projects from 15/16 FY and some carried forward projects from 14/15 financial year. A total of 37 projects have been fully completed. A few projects have been carried forward to 16/17 FY due to various reasons. The following projects are significant projects that have been completed during the 2015-16 financial year.

- Linlithgow Avenue and Alexandra Avenue intersection Removal of left turn lane
- Macaulay Road from Kensington Road to Langford Street Install/improve bicycle lane facilities
- Lloyd Street, Dynon Road to Radcliffe Street widen existing shared path
- College Crescent / Princes Park Drive signal remodel for bicycle lamps

• Epsom Road, Smithfield Road to Market Street - install new bicycle lane

## 3.2.5 Road Safety / Traffic Signals / Walking Plan Program - \$2.03 million

The following projects have been completed during the 2015-16 financial year:

- Abbotsford Street / Brougham Street, North Melbourne intersection remodel works at the northwest corner
- Park Drive / Story Street, Parkville roundabout remodel works providing kerb extensions and pedestrian zebra crossings
- Eastwood Street / Bellair Street, Kensington at railway underpass, install 2 pedestrian crossings
- Mercantile Parade, Kensington installation of pedestrian zebra crossing
- Lt Bourke Street at Heffernan Lane installation of pedestrian zebra crossing
- Elizabeth Street / Flinders Lane intersection remodel providing pedestrian signals and audio tactiles
- Flinders Lane / Russell Street intersection remodel providing pedestrian signals and audio tactile

## 3.2.6 IT Renewal Program – \$7.5 million

The 15/16 IT renewal budget contributed to the completion of 43 IT business and technical projects including the implementation of the new corporate website, the new library management system, the rollout of collaborative tools such as Yammer and Lync, upgrades to desktops, meeting room AV, applications and infrastructure.

In addition, a further 40 projects were commenced and were at various stages of completion as at 30 June 2016. These projects will be completed with funding from 15/16 carry forward or 16/17 IT renewal budget.

# Major Projects Fourth Quarter Progress Report 30 June 2016

## 1. Queen Victoria Market Precinct Renewal

## 1.1. Status of Project

The implementation of the Queen Victoria Market Precinct Renewal (QVMPR) Master Plan was a major initiative in the 2015/16 Council Plan Action Plan. Key updates for the fourth quarter include:

- The advancement of the BAFO process for the appointment of a preferred development partner for the Munro Site.
- Receipt of the Panel report for Amendment C245 Queen Victoria Market built form controls on 12 July 2016. The Amendment was endorsed by Council, with amendments, for referral to the Minister on 26 July 2016.
- Development and public release of the Implementation Framework for the QVMPR Program which outlines how key renewal projects within the Master Plan will be staged over the next five years and importantly how the market will continue to trade during this time. The Framework was endorsed by Council, with amendments, on 26 July 2016.
- The Cultural Heritage Management Plan (CHMP) for the precinct (excluding the Old Melbourne Cemetery) has been submitted for assessment by Aboriginal Victoria.
- The QVMPR Sustainability Plan has been endorsed by the Program Control Group.
- Project briefs for early market amenity improvements works, including exploring opportunities for enhancement of weather protection, improved lighting, screening of waste areas, new pedestrian crossing connecting upper/lower market and outdoor respite areas are being finalised.

Melbourne Metropolitan Rail Authority (MMRA) has been established by State Government to plan, design and deliver this major city-shaping infrastructure project on behalf of Public Transport Victorian (PTV). City of Melbourne (CoM) has established a partnership arrangement with MMRA to facilitate the project and ensure integration with other key projects including:

- Elizabeth Street Streetscape Works
- Flinders Street Station Refurbishment
- Queen Victorian Market Precinct Renewal
- Arden Macaulay Structure Plan
- University Square
- City Road Master plan
- Southbank Boulevard
- Moonee Ponds Creek Master plan
- Elizabeth Street Catchment Integrated Water Management Plan

CoM are working closely with the following key government agencies with respect to this project:

- Metropolitan Planning Authority (MPA)

## 2.3. Key Issues

Community consultation and engagement is ongoing regarding early construction works, particularly with affected businesses and residents.

MMRA website <u>www.vic.gov.au/mmrailproject</u> regularly provides project updates. MMRA have held a number of public meetings with residents, businesses and retailers along the length of the project corridor between August 2015 and June 2016.

The Environmental Effects Statement (ESS) process will be run by DWLWP commencing 22 August 2016. This public planning process was preceded by significant public information on the project being released by MMRA in May 2016.

Ref: Council Annual Plan Action Report #9755972 item 6.3.4 (major initiatives) work with the State Government on the Melbourne Metro Rail Project. Updated monthly.

MMRA have formally requested early occupation of City Square in February 2017 and propose to take this action under the Land Acquisition and Compensation Act. This matter is to be taken to FMC in August 2016 for consideration.

CoM have established a Project Steering Group chaired by Director City Design and Projects with CEO and all Directors as PSG Members.

## 4. Ron Barassi Senior Park (formerly Western Park Stage 1) – \$18 million

## 4.1. Status of Project

The park is a key project initiative in the Docklands Community and Place Plan being delivered by Places Victoria.

Construction commenced on site in September 2014. The project was completed and officially opened on Saturday 10 October 2015 by the Minister for Planning, the Lord Mayor and the CEO of Places Victoria:

The project is currently in the Defects Liability Period a full title and ownership is expected to be transferred to the City of Melbourne after the completion of the stage 2 works.

City of Melbourne City Design Studio are continuing to act as consultant Architects and Landscape Architects in ensuring that defects and contractual landscape maintenance works are being carried out to the end of the Defects Liability Period. Some additional works, as part of stage 1, are being considered and will be funded by Places Victoria.

The project concept plan allows for the future construction of an indoor sports stadium (Stage 2) to the rear of the pavilion. Places Victoria had requested that Council provide \$1 million towards the sports stadium development for amenities specifically requested by Recreation Services in the form of additional activity spaces. Council has committed \$1 million in the 2017-18 financial year to the project.

Places Victoria are currently preparing documentation in relation to the program and scoping of the Stage 2 proposal for an indoor sports stadium and associated amenities.

## 5.3. Key issues

## 5.3.1. Princes Park

Due to the Council requirements to carry more consultation with the clubs. This has delayed awarding the Contract till Early July 2016. Works has commenced now on site with completion is scheduled for late October 2016.

## 5.3.2. Flemington Road Oval

Council has approved the installation of new sports lights to the oval. A Heritage Permit was received after a lengthy delay due to objections. The works being documented now and will be tendered shortly..

The Contract for the new pavilion has been awarded to Fercon Property Group with works commenced as schedule early May 2016. Work are not progressing as planned due to inclement weather and access to the site.

## 5.4. Financials

The two projects are funded by the former Linking Melbourne Authority. These works have been included in the 2013–14 and 2014–15 Council Works Programs as externally funded project budgets. As a result of the cancellation of the East West Link project a revised funding budget of \$9.46 million was agreed with the authority. A total of \$6.62 million has been expended so far.

Notes: \$3 million capital funding from 2015–16 budget provided for the Elizabeth Street project was based on starting construction by mid-2016. Due to timing of the communication and community engagement program resulting out of Metro considerations, the construction for the southernmost section of Elizabeth Street has been pushed into the 2017–18 financial year. It is envisaged that the \$3M former funds will be reallocated back to fund the construction works scheduled for mid-2017.

## 9. Carlton Squares

## 9.1. Status of project

There are four projects that sit under the Carlton Squares project:

- 1. Reimagining University Square
- 2. Lincoln Square storm water harvesting and flood mitigation tank
- 3. Lincoln Square plaza modifications
- 4. Lincoln Square master plan.

## 9.1.1 University Square

## 9.1.1.1. Project Objectives

- To prepare a Master Plan, including implementation and construction plan, for University Square.
- To increase public space to meet the needs of a rapidly changing population in our education precinct.
- To respond to a declining landscape and environmental change by designing a more climate-adapted landscape
- To design contemporary public open space that meets the needs of our community.

## 9.1.1.2. Financial

- Current funding \$6,887.000 (includes funding from State Government, CoM and The University of Melbourne)
- Future budget bids \$9,200.000

## 9.1.1.3. Key Issues

- The Melbourne Metro Rail Project (MMRP) started shortly after phase three community engagement concluded. The proposed Parkville Station and impacts of the MMRP has had a profound influence on the master plan, particularly in relation to the location of Parkville Station (Barry and Grattan Street intersection) and the proposed occupation of sections of University Square during MMRP construction - 2018 to 2022. (See Attachment 2 – Parkville Station and Construction Phasing).
- This will have a direct implication of staging of University Square construction forcing a re-think in the construction programme and elongating the duration of the project – possibly to 2022.
- Extensive negotiations, through the City of Melbourne's Metro Rail Team and the EES process, will see above-ground station infrastructure such as chilling plant and ventilation minimised in public open space.
- It is also likely to avoid a five-year postponement of master plan implementation works due to a shared occupation of the site during MMRP construction.
- The City of Melbourne will be seeking some compensation in relation to the occupation of the site by MMRP.

## 9.1.1.4. Status, Project Milestones and Community Engagement

- It is proposed to start a four-week display of the Draft University Square Master Plan (final phase four community engagement) on 19/08/2016 before Caretaker Period commences on 21/09/2016.
- It is proposed that the final master plan would be presented to Council for adoption in December, 2016.
- Stage one construction could begin in Autumn, 2017 subject to MMRP occupation requirements

## 9.1.2 Lincoln Square Storm Water Harvesting and Flood Mitigation Tank

## 9.1.2.1. Project Objectives

- To mitigate the EPA-rated 'severe' status of the Elizabeth Street catchment by capturing water at the top of the catchment in heavy-rain events.
- To provide an alternative irrigation source for the three Carlton squares.

## 9.1.2.2. Financial

• \$4,000,000 (State Government and Council funding)

## 9.1.2.3. Status, Key Milestones and Community Engagement

- Community engagement concluded in December 2015
- Tender awarded in January 2016
- Construction commenced in early March 2016
- Expected completion September 2016.

## 9.1.3. Lincoln Square plaza modifications

## 9.1.3.1. Project Objectives

- To re-design the plaza and Bali Memorial area to deter skate boarding
- To respect the heritage and context of Lincoln Square.

## 9.1.3.2. Financial

• Revised budget \$995,000

## 9.1.3.3. Status, Key Milestones and Community Engagement

- Construction commenced on 13 April, 2016.
- An IMP process was convened in November, 2015 to ensure that all risk scenarios were considered and appropriate risk mitigation and community consultation procedures were considered in a cross-organisational manner.
- Key stakeholders were informed, including Victoria Police, The University of Melbourne and the adjacent Rydges Hotel.
- An external working group with 12 skateboarding representatives was organised to start work on the temporary skate program (as per the Council resolution) and to provide an opportunity to discuss the closure of Lincoln Square.
- While the exact date for construction was not made public, information relating to the project was listed on Council's website and signs were erected on-site.

## 9.1.3.4. Key Issues

- Following recent media attention on this project, several protest websites have been developed by the skating community. Lincoln Square is a world-renowned skate site.
- It is conceivable that site security will be an issue. The site perimeter could be broken and in a worst-case scenario, the contractor may deem that the site is not safe.
- An Issues Management Process is in place to ensure that risk is managed.
- An external working group with Lincoln Square skaters has been established and we are working to achieve section 1.5 of the Council resolution to develop street skate elsewhere in the central city.

## 10. Transforming Southbank Boulevard and Dodds Street

## 10.1. Project Objectives

- To consolidate and re-organise underutilised road space in Southbank Boulevard and Dodds Street to create new public spaces that offer a broad spectrum of recreation, social and civic opportunities that supports the needs of a rapidly growing resident, worker and visitor population.
- To provide a safe cycling route of Southbank Boulevard
- To improve the functional engagement and legibility between Southbank's public and private realm, in particular the opportunity to complement and enhance the link between arts and cultural institutions.
- To create the 'Melbourne experience' in the form of exemplary, high quality and vibrant pubic space designed and programmed to support a diversity of use and spaces to gather, linger, celebrate and relax...
- To respect and reflect the values and aspirations of the Southbank community.

## 10.2. Financials

## 10.2.1. Southbank Boulevard

- Current funding \$3,970,000 (including Section 173 funding from Australia 108)
- Future funding bids \$12,900,000

## 10.2.2. Dodds Street

- Current funding \$1,000,000
- Future funding \$1,000,000

## 10.3. Status, Key Milestones and Community Engagement

- Phase 1 community engagement concluded in December, 2015
- Key themes from phase one community engagement included concern that a reconfigured boulevard would not meet traffic requirements, public space in Southbank was non-existent, roads were barriers, more green space and trees, turn buildings 'inside-out' to support community interaction, improve security and create a space for local people.
- It is proposed to start a four-week phase two community engagement process on 19/08/2016 before Caretaker Period commences on 21/09/2016. Phase two is designed as a check-in opportunity to introduce design principles that will form the basis of the master plan and to present an Ideas Plan that will introduce precincts and high-level concepts.
- A Road Discontinuance process has been initiated by notifying the DELWP.

## 10.4. Key Issues

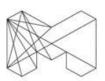
- On-going discussions with the Melbourne Metro Rail Authority (MMRA) have identified strong support for Council to construct proposed stage one works (St Kilda Road to Moore Street) in September, 2017. This is seen as an opportunity to create new public space in the midst of MMRA construction. Support from Yarra Trams and the PTV is critical to meet this timeline because this section of Southbank Boulevard contains tram infrastructure. Every effort is underway to secure support and funding from Yarra Trams and the PTV.
- The opportunity to start stage one construction (provided we receive support from Yarra Trams and the PTV) necessitates phase two community engagement to start before Caretaker Period in order that the draft master plan, tender documentation and the public tender process can be concluded in time for September, 2017 construction.
