Management of Online Event Listings - Contract 3550

Purpose and background

- 1. The purpose of this report is to recommend awarding a tender for the provision of services to manage event listings on the What's On website for two years with two, one-year extension options.
- 2. The contract provides management (editing and publishing) of over 8000 events per year on the What's On website, with coverage provided between 9am and 5pm on weekdays (excluding public holidays). The current contractor is John Ryan trading as Sitegeist.
- 3. The current tender expired on 31 May 2016. It cost \$176,208 per annum in its final year (or \$675,407 over the four-year contract term). A Request for Quotation process was undertaken for an interim period of four months, from June to September, while a competitive tender process was undertaken. John Ryan trading as Sitegeist was awarded the interim contract for the cost of \$56,914.64.
- 4. The tender was advertised in *The Age* newspaper on Saturday 28 May 2016. Three tender submissions were received.
- 5. The weightings of the evaluation criteria were declared in the invitation to tender documents and were Cost (50 per cent), Experience, Capability and Past Performance (30 per cent) and Plan for Proposed Services (20 per cent).
- 6. The tender evaluation summary is contained in Attachment 1.

Key issues

- 7. The cost to Council of appointing the recommended tenderer is \$334,000 over two years, which is within budget.
- 8. The tender evaluation panel recommend John Ryan trading as Sitegeist as the preferred tenderer due to a competitive pricing offer (around 8 per cent annual reduction on current costs), a proven effective resourcing model and extensive relevant experience.

Recommendation from management

9. That Council awards the contract for the Management of Online Event Listings on the What's On website to John Ryan trading as Sitegeist for a term of two years commencing 1 October 2016 with two options to extend the contract term by up to a further one year each, for an annual contract sum of \$167,000 and otherwise in accordance with the negotiated terms and conditions of contract.

Legal

Pursuant to section 186 of the Local Government Act 1989 (Vic), before a Council enters into a
contract for the purchase of goods or services to the value of \$150,000 or more (levels increased by

contract and invite tenders from persons wishing to undertake the contract.

Finance

2. The contract cost is \$334,000 over two years, which is in line with budget expectations.

Procurement

- 3. This matter accords with the Centre Led Procurement Policy. It has been developed collaboratively with Paul Klebanowski, Category Manager, Procurement and Category Management.
- 4. This Tender and the resulting recommendation is fully supported by Procurement. The proposal has been competitively sourced and the proposed contract represents an approx. 8 per cent saving over the current contract.
