Schedule of Council and Future Melbourne Committee meetings 2017

Purpose and background

- 1. The purpose of this report is to consider the dates, times and venues for meetings of the Council and its Future Melbourne Committee (FMC) for 2017.
- 2. The Council, on 29 September 2015, approved meeting dates for the Council and Committee meetings up to the end of December 2016. The FMC ratified the Committee meeting dates on 6 October 2015.
- 3. The FMC on 17 November 2015 subsequently approved a revised schedule for 2016. This change was enacted to allow the second FMC meeting to be scheduled in week 3, rather than week 2.

Key issues

- 4. The schedule (refer Attachment 2) should be approved at the 29 November 2016 Council meeting:
 - 4.1. to allow for ratification of the meeting dates by the FMC in December
 - 4.2. in order that appropriate public notice can be given.
- 5. The schedule can be amended by resolution of the Council as necessary.
- 6. Typically FMC meetings are scheduled on the first and third Tuesdays of the month and Council meetings are scheduled on the last Tuesday of the month. Due to ANZAC Day falling on Tuesday 25 April the FMC meeting scheduled to be held on that date will now convene on Wednesday 26 April. Due to the Melbourne Cup holiday, FMC meetings will be held on the second and third Tuesday in November 2017.

7. That Council approves the schedule of Council and Committee meeting dates for 2017 as detailed in Attachment 2 to the management report.
