2016-17 Council Works Program First Quarter report

Purpose and background

1. The purpose of this report is to inform the Council of the financial performance of the 2016–17 Council works program at the end of the first quarter. It also outlines the progress of Council's major projects.

Key issues

- 2. The overall program tracked slightly behind plan for the first quarter period. The value of work completed at the end of the first quarter for 2016–17 financial years was \$15.18 million compared to the accumulated Year to Date budget value of \$15.74 million. This resulted in \$558,000 (3%) underspend mainly due to extreme wet weather conditions delaying projects.
- 3. A detailed report is provided in Attachment 2 of this report.

- 7. In addition, the designs for all projects within the program build in measures to minimise the environmental impact and reduce operating costs.

2016–17 Council Works Program First Quarter Report

1. Overview

The cumulative value of work at the end of the first quarter for 2016-17 financial years was \$15.18 million compared to the accumulated Year to Date budget value of \$15.74 million.

2.1 Financial Analysis

The maintenance program achieved \$1.76 million compared to the planned value of \$1.83 million (15% of total budget).

The new works program is ahead of planned value and achieved \$4.47 million compared to the planned value of \$4.24 million (7% of total budget).

The renewal works program achieved \$8.94 million compared to the planned value of \$9.67 million (16% of total budget).

In total, the Council Works program has achieved 11% of planned value for the first quarter of the 2016–17 financial year. This is comprised of \$2.788M ahead of planned and \$3.346M delayed, resulting in an overall 3% behind budget (\$558k).

Details of major variances are as follows:

- Parks Renewal Works Program \$765k
- Property Services Works ahead (\$630k)
- Flood Mitigation New Works \$410k

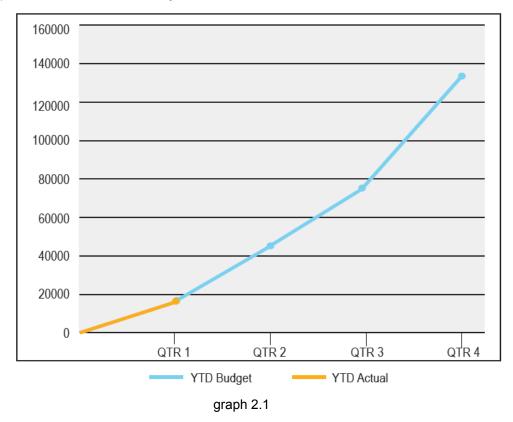
- Climate Change Adaptation Streetscapes (Renewal) \$290k
- Queen Victoria Market Precinct Renewal Project (QVMPR) \$279k

Program adjustments have been included in Appendix 2. The main adjustments for 2016–17 are:

- A proposal to transfer \$1.94 million from Flood Mitigation New Works to the Flood Mitigation works for Whiteman Street/Clarendon Street.
- A proposal to transfer \$150,000 from Implementation of Docklands Community and Place Plan to Wharf and Marina Maintenance for the provision of Docklands wharf and marine maintenance works.
- A reduction in funding of \$323,947 based on the latest revised payment schedule from Department of Infrastructure and Regional Development relating to the Roads to Recovery contribution.
- A reduction in funding of \$162,000 due to the external contribution not anticipated to be received for the Green Your Laneway Pilot Projects.

3. Key Issues

Key Milestones achieved in the first quarter include:

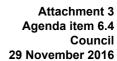
- Queen Victoria Market Precinct Renewal Release of the Implementation Framework and execution of the Munro Site Development Deed with a developer.
- Southbank Boulevard Phase two community engagement concluded and road discontinuance process has been approved by the Department of Environment, Land, Water and Planning.
- University Square Draft master plan was displayed for community consultation in September.

- JH Boyd Redevelopment A Public Notice was advertised for the proposal to sell the parcel of land to Cairo Melbourne Pty Ltd for \$15.5 million, two submissions were received and are being reviewed by the submissions committee.
- Lady Huntingfield Redevelopment Community engagement has commenced and design documentation is in progress.
- Green Your Laneway Pilot Project Stakeholder engagement complete with specific proposals for greening of walls and private areas sent to each building owner for review.

1. Queen Victoria Market Precinct Renewal

Scope of work: In October 2013, City of Melbourne (CoM) announced the largest investment in its history to preserve and renew the Queen Victoria Market (QVM), creating an expanded market precinct. The five year renewal program seeks to retain and restore the market's heritage while moving key market infrastructure and parking below-ground to create more room for market trade and new open space. Importantly, the market will continue to trade right throughout the renewal program with a strong focus on business continuity during construction.

Status:

- Endorsement and public release of the Implementation Framework.
- Munro Site Development Deed executed. Significant progress of community facilities schematic design to inform lodgement of planning permit in November 2016.
- Endorsement of recommendation to refer adoption of Planning Scheme Amendment C245 to Minister for Planning.
- Progression of New Market Pavilion and Q1/Q2 infrastructure design works.
- Delivery of precinct enhancement works including; Queen Street pedestrian crossing upgrade, Queen Street 'pop up' park, improved disability access and installation of new lighting in K Shed.
- Works brought forward for this year to upgrade Therry Street substation and F Shed switch room in order to accommodate summer peak periods and new market pavilion requirements.

Scope of work: Work in partnership with Melbourne Metropolitan Rail Authority to optimise project benefits for CoM. Planning approval anticipated Dec 2016 / Jan 2017. Early Works contract has commenced and due for completion in Feb 2018. Main Contract commences Feb 2018.

Status:

Melbourne Metropolitan Rail Authority (MMRA) has been established by State Government to plan, design and deliver this major city-shaping infrastructure project on behalf of Public Transport Victoria (PTV). City of Melbourne has established a partnership arrangement with MMRA to facilitate the project and ensure integration with other key projects including:

- Elizabeth Street Streetscape Works
- Flinders Street Station Refurbishment
- Queen Victoria Market Precinct Renewal
- Arden Macaulay Structure Plan
- University Square
- City Road Master plan
- Southbank Boulevard
- Moonee Ponds Creek Master plan
- Elizabeth Street Catchment Integrated Water Management Plan

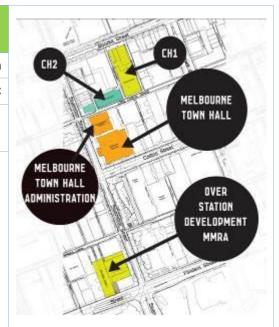

Scope of work: Redevelopment of the Council House1 precinct to provide Council and commercial accommodation subject to detailed financial and project analysis.

Status:

- Representatives from the City of Melbourne have met with the three shortlisted consortia to discuss Council's interest in a civic offer for the CBD South over station development in the form of Council office accommodation, a new city library and visitor centre.
- Representation of Council's interest will continue through the Melbourne Metro Rail Authority on a monthly basis until February 2017 when consortia tender submissions are due.
- Work has commenced on a comparative analysis of both the CBD South and Council House 1 / Commonwealth Bank sites and will be included in a separate report to Council in November 2016.



4. Southbank Boulevard Upgrading

Total Project Budget: \$18.87 million 2016–17 Budget: \$1.19 million

Planned completion date:

June 2020

Scope of work: The creation of 2.5 hectares of public open space in Melbourne's most densely populated suburb.

Status:

- Phase two community engagement completed on 20 September. Work to prepare Draft Master Plan underway for March, 2017.
- The road discontinuance process has been approved by the Department of Environment, Land, Water and Planning. Traffic engineering and landscape design work is underway so that a draft master plan will be ready for February 2017.
- Discussions are continuing with Yarra Trams and Public Transport Victoria with regard to occupation permits for stage one construction in October 2017.



5. University Square

Scope of work: To develop a University Square Master Plan and construction program that restores a failing landscape and creates a 21st century park in Melbourne's education precinct.

Status:

- The University Square Draft Master Plan was displayed for community consultation in September 2016.
- The Draft Master Plan will be presented to Council in December 2016 for adoption.
- Negotiations continue with the Melbourne Metro Rail Authority to ensure that staged implementation of the Master Plan can begin in 2017 – before construction of Parkville Station starts.

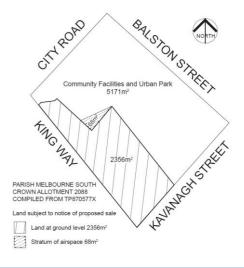

9. Lady Huntingfield Child Care Centre Upgrade

\$2.2 million

Planned completion date:

Feb 2019

Scope of work: The redevelopment of Lady Huntingfield Childcare Centre includes delivering a 106 space childcare centre that incorporates an integrated model including maternal child health, family services and other compatible uses. The temporary relocation of families from Lady Huntingfield to an expanded Hotham Hub Children's Centre is required during 2017–18 to ensure continuity of services during construction.

Status:

Hotham Hub Alterations and additions

- Concept design complete and Expression of Interest documentation underway.
- Town Planning approved under delegation.
- Construction planned for commencement in April 2017 with transition of families into the expanded centre in December 2017.

Lady Huntingfield Redevelopment

- Community engagement commenced and will continue throughout the project.
- · Concept design commenced.
- Construction planned for commencement in January 2018 with transition of families back into the redeveloped centre in early 2019.
- Scope is being confirmed as designs are finalised which will inform budget.

- The contract for the oval lighting was awarded in October 2016 with works scheduled for completion by the end of March 2017.
- Landscaping works are being documented with works to be carried out after the completion of the pavilion.



11. Hawke and Adderley Street Open Space

- Demolition quotation closed 20 October 2016 followed by tender evaluation and award
- Demolition to commence onsite mid to late November 2016 and be completed by end of December 2016 pending the disconnection of services onsite, obtaining a building permit and other permits
- Detailed design in progress with completion anticipated in January 2017
- Public Consultation is complete with minor modification to the design required
- Playground audit currently in progress
- Planning Permit process is underway
- Construction tender will be advertised February 2017, pending the outcome of the planning permit



12. Implementation of Docklands Community and Place Plan

Planned completion date:

Scope of works: A number of small to medium scale projects to support the implementation of the Docklands Community and Place Plan (DCPP) and Harbour Esplanade.

Status:

- Docklands South Park Feasibility underway.
- City Mariana shelter concept phase underway.
- Docklands/Northbank Feasibility and investigation under way.
- Docklands Minor Wharf & Marina maintenance maintenance review underway.

13. Green Your Laneway Pilot Project

On Track

Budget:

\$1.63 million

Planned completion date:

June 2017

Scope of work: Introduction of green infrastructure to existing building at various locations at the CBD.

Status:

- Planning complete for project. Four laneways have been selected from community nominations.
- Stakeholder engagement completed with four 'design preview' workshops to show concept designs to stakeholders in each lane. Feedback was generally positive in relation to greening proposals.
- Feedback provided included scope beyond current greening scope in the lanes e.g stakeholders were strongly in favour of significant pedestrianisation and kerb extensions in the three lanes, lighting, bin management, smoking bans were also frequently requested. This feedback will inform consideration of future work.
- Specific proposals for greening of walls and private areas have been sent to each building owner for their review and initial approval.
- Research component of the project has been funded by a \$30,000 grant from ARUP to explore the design of a cofunding program for future laneway greening. The engaged consultant, Thick Studios, presented a draft review of private funding mechanisms for future greening laneway projects. The research identifies a clear service design for the future program, and released in October.
- Site testing is underway and agreements with building owner are being prepared.
- Broad community engagement of four laneway designs is in preparation for early November

14. Major Streetscape Improvements and Design

Budget: \$4.84 million Planned completion date: June 2017

Scope of work: Various CBD footpath upgrades to bluestone paving plus major streetscape upgrade projects comprising Southbank Promenade and New Quay Docklands.

Status:

- Bourke Street and Spencer Street footpath upgrade projects in progress.
- Community engagement for Collins Street / Little Bourke Street / Lonsdale Street footpath upgrade projects completed and issued for construction.
- Southbank pavement / landscape concept plan being finalised for community engagement and New Quay pavement design in progress.
- YTD value of completed works is \$276,000.

15. Tree Planting Program

Budget: \$1.5 million Planned completion date: June 2017

Scope of works: Tree planting program for the municipality

Status:

Delivery:

- Planting program is underway and to date 990 trees have been planted. The program will continue to the end of October with a further 100 trees scheduled for planting
- Scoping, planning and community engagement will begin in November prior to the planting season starting in March/April 2017 with 2000 trees scheduled for planting by June 2017.

16. Bicycle Improvement Program

Budget: \$2.67 million Planned completion date: June 2017

Scope of works: Various bicycle and motor cycle improvement work throughout municipality.

Status:

- At the request of the Department of Environment, Land, Water and Planning (DELWP), Council officers held a workshop with senior strategic planning officers from across inner Melbourne to discuss the Bicycle and Motorcycle report, and what could be done under the Planning Scheme to address the issues.
- The workshop provided strong support for Council's initial request to the Minister.
- DELWP officers are briefing the Minister for Planning and we expect to hear a response shortly.

17. Flood Mitigation New Works

Budget: \$4.59 million Planned completion date: February 2017

Scope of work: Various flood mitigation new works throughout municipality.

- Renewals including Rankins Road and Munster Terrace drain.
- New works including Clarendon Street and Whiteman Street flooding.

Status:

- Project planning complete.
- Drainage investigation of Arden Macaulay section of the creek has been completed
- Stakeholder engagement undertaken with Melbourne Water and Victorian Planning Authority
- Project partnership established with Melbourne Water to develop preferred open space and flood outcomes
- Report development underway.
- Wells Street drainage works have complexities due to third party approvals and impacts on Kings Way. It is
 therefore proposed to transfer \$1,941,000 to the intersection of Normanby Rd and Clarendon Streets to address the
 very regular flooding which occurs in that location

- A further 1,089 lights in West Melbourne to be upgraded to LED lights by end of February 2017.
