Future Melbourne Committee Structure and Future Melbourne Plan 2026

Purpose and background

1. The purpose of this report is to enable Council to note the community's Future Melbourne Plan 2026 (FM 2026), adopt FM 2026 goals (as amended), agree the terms of reference for the Future Melbourne Committee and appoint chairs and deputy chairs to each portfolio segment of the Future Melbourne Committee agenda.
2. At the beginning of each term, the Council establishes its objectives through a Council Plan and agrees governance arrangements to support decision-making and city representation roles.
3. In 2015-16, the City of Melbourne invited the community to refresh the 2008 Future Melbourne Plan - the community's long term vision for the city.
4. The ambassadors and citizen's jury presented FM 2026 to the former Council in August 2016. The former Council noted FM 2026 as the community's refreshed vision and goals for the municipality and as a resource for the next Council.

Key issues

5. Councillors have reviewed FM 2026 and elected to adopt the nine goals with one minor amendment: Goal 8: 'A City Managing Change' will be changed to 'A City Planning for Growth.' A list of the revised goals is provided in Attachment 2.
6. The Council also intends to use FM 2026 as a key resource to inform the development of the Council Plan.
7. Councillors have also reviewed the terms of reference of the Future Melbourne Committee and identified a portfolio structure. The updated terms of reference is provided as Attachment 3.
8. Councillors have agreed on the positions of Chair and Deputy Chair for these portfolios, drawing on the specific interests and skills of the Councillors. The portfolio structure, which is broadly aligned to the FM 2026 goals, is outlined in Attachment 4.

Legal

6. The presentation of a refreshed Plan followed an extensive community engagement process. The community engagement occurred in the project's ideas phase run over February and March 2016 and the deliberative phase took place between May and June 2016.

Environmental sustainability

7. The Plan recognises that 'sustainability is the basis of all Future Melbourne goals'.
8. The Committee's revised terms of reference and portfolio themes reinforce the significance and priority required for environmental and sustainability challenges and opportunities facing Melbourne.

Membership

The Lord Mayor, Deputy Lord Mayor and Councillors are members of the Future Melbourne Committee.

Quorum

The quorum for the Future Melbourne Committee is a majority of its members.
