Purpose and background

1. The purpose of this report is to inform Council of the financial performance of the 2016–17 Council works program at the end of the third quarter. It also outlines the progress of Council's major projects.

Key issues

- 2. The value of work completed at the end of the third quarter for 2016–17 financial years was \$60.67 million compared to the accumulated Year to Date budget value of \$77.10 million. In summary, the Council Works program is 79 per cent delivered against planned at the end of the quarter three.
- 3. A detailed report is provided in Attachment 2 of this report.

Recommendation from management

 - 4.1. Notes the 2016–17 Council Works Program third quarter report.
 - 4.2. Approves the program adjustments to the 2016–17 Council Works Program that are included in Appendix 2 of the 2016–17 Council Works Program Third Quarter report, and notes the following significant program adjustments:
 - 4.2.1. a proposed reclassification from Capital to Maintenance Capital Grant for both Street Lighting LED project (\$3,700,000) and Melbourne Contemporary Pavillion project (\$300,000)
 - 4.2.2. a proposed transfer of \$509,201 to support delivery of Green Your Laneway Pilot
 - 4.2.3. a proposed transfer of \$500,000 into Corporate Renewal Works to support completion of Security improvements.

 - 5.1 directly enhancing opportunities for recycling, capturing and conserving water (such as Lincoln Square)
 - 5.2 planting trees (such as Tree Planting Program)
 - 5.3 creating public open space (such as University Square)
 - 5.4 minimising environmental impact and reducing operating costs (such as Energy Efficient Street light Renewal)
 - 5.5 maximising environmental benefits as part of the design (such as Queen Victoria Market New Market Site pavilion structure), and
 - 5.6 enabling sustainable transport (such as Bicycle Improvement Program).

2016–17 Council Works Program Third Quarter Report

1. Overview

The cumulative value of work at the end of the third quarter for 2016–17 financial years was \$60.67 million compared to the accumulated Year to Date budget value of \$77.10 million.

2.1 Financial Analysis

Maintenance

The maintenance program achieved \$8.49 million compared to budgeted value of \$8.34 million which represents 102% delivery against plan to date.

Capital Works

The new works program achieved \$22.27 million compared to budgeted value of \$30.97 million which represents 72% delivery against plan to date.

The renewal works program achieved \$29.91 million compared to budgeted value of \$37.80 million which represents 79% delivery against plan to date.

Combining new works and renewal works, overall Capital Works is 24% behind budget on a total program year to date budget of \$68.76 million.

Total Council Works

In total, the Council Works program (Capital + Maintenance) has delivered **79%** against year to date budget value for the third quarter of the 2016–17 financial year.

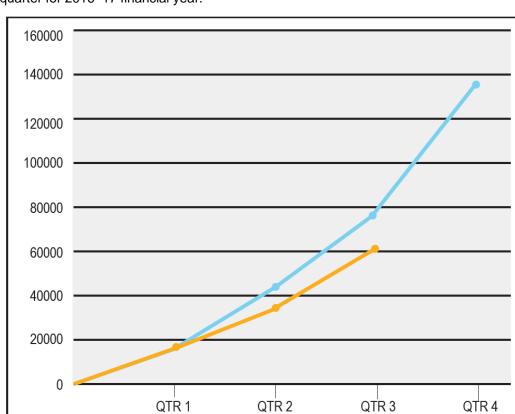
Details of major Capital Works variances this quarter are as follows:

- Two projects are showing variances due to being reclassified from 'Capital' to 'Maintenance'. Refer Third Quarter Program adjustments for details.
 - 'Street Lighting Renewal' is a new maintenance budget based on proposal to reclassify \$3.7 million Street Lighting LED project (15G0393N) as 'Maintenance Capital Grant' rather than 'Capital'.
 - 'Melbourne Contemporary Pavilion' is a new maintenance budget based on proposal to reclassify \$300,000 Melbourne Contemporary Pavilion project (14G4011N) as 'Maintenance Capital Grant' rather than 'Capital'.
- IT New Capital program spent \$377k more than expected this quarter due to costs being incurred earlier than planned
- Queen Victoria Market Precinct Renewal Project (QVMPR) spent \$1.781 million less than planned due to revised scope and favourable expenditure against budget
- Flood Mitigation Renewal Works is \$1.545 million underspent to date due to delays from design scope changes and impact of inclement weather in quarter one.
- Drains, Roadway and Kerb/Channel renewal works spent \$2.03 million less than planned due to works delays however future works accelerated to complete as per budget by end quarter four.
- Southbank Boulevard Upgrading project underspent by \$594k to date due to delays caused from changes to tram and bus stop locations from Public Transport Victoria and Yarra Trams.
- Bicycle Improvement Program underspent by \$727k due to delays caused by upcoming Metro Tunnel Project and third party / utility works. Program adjusted by bringing forward 6 bicycle projects from 2017/18 & 2018/19 programs. 34 projects now fully issued to CityWide and in progress to be completed by 30 June 2017.
- Parks Renewal Works program remains behind schedule with \$1.87 million underspend to date. Several larger renewal projects delayed by unforeseen issues and timing of works around major events. Actions in place for acceleration of works however \$500k carry-forward likely.

Appendix 3 provides a full list of project variance figures and Appendix 4 provides project specific explanations for major variances over \$200,000.

Program adjustments have been included in Appendix 2. The main adjustments this quarter are:

- A proposed transfer of \$509,201 to Green Your Laneway Pilot (16B3319N) since tender submissions were higher than anticipated to complete all four lanes. Funds proposed to be redirected from savings identified through Lonsdale Street median renewal and tree replacement project (\$36,174) as well as underspend from Urban Landscapes Climate Adaptation streets renewal (\$173,486) and Climate Change Adaptation Streetscapes Renewal (\$299,541) due to works on hold in light of St Kilda Road impacts of Metro Tunnel Project construction.
- A proposal to reclassify \$300,000 Melbourne Contemporary Pavilion project (14G4011N)
 as 'Maintenance Capital Grant' rather than 'Capital' as this project was formally
 transferred through City of Melbourne from Naomi Milgrom Foundation to Melbourne Zoo
 on the 8 March 2017.
- A proposal to reclassify \$3,700,000 Street Lighting LED project (15G0393N) as 'Maintenance Capital Grant' rather than 'Capital' since Citipower or Jemena are the owners for assets created.
- A proposed transfer of \$33,597 from 'Melbourne Visitor Centre Refurbishments'
 (13G3404R) to 'Relocate and re-design Melbourne Visitor Booth Bourke Street'
 (15G3409R) to combine the two Visitor Centre projects into one
- To fund the progress of Security works brought forward from 17/18 program, it is proposed that a total of \$500,000 be transferred into Corporate Renewal Works from underspend in Annual Minor Works (\$100,000), Property Services Commercial Works (\$50,000) and Community Services Renewal (\$350,000).

3. Key Items

Milestones achieved in the third quarter include:

- Queen Victoria Market Precinct Renewal

 Refresh works to the H and I toilet block are
 complete. Precinct Cultural Heritage Management Plan for Munro Site and Queen Street
 submitted to Aboriginal Victoria.
- Southbank Boulevard Upgrade Yarra Trams agreed to issue Occupation Permit so that stage
 one construction can start in April, 2018 to align with Easter holidays. A key stakeholders
 meeting was held at the Yarra River Traders' Association annual meeting and regular meetings
 were held with Public Transport Working group to resolve public transport infrastructure
 requirements for trams and buses.
- Lincoln Square Plaza, Tank and Landscape Work on the storm water harvesting tanks and diversion pit are complete with Lincoln Square North Road opened.
- South End Elizabeth Street Designs and planning for standard upgrade of the Western footpath underway with construction to commence in June, 2017.
- Hawke and Adderley Street Open Space Demolition of 104 Hawke St completed March 2017.
- Green Your Laneway Pilot Project Tender for design and construction of greening infrastructure closed and evaluation of submissions and tender award underway.

Queen Victoria Market Precinct Renewal

On Track

Total Project Budget:

Up to \$250 million

2016-17 Budget:

\$9.17 million

Planned completion date:

2021

Scope of work: In October 2013, City of Melbourne announced the largest investment in its history to preserve and renew the Queen Victoria Market (QVM), creating an expanded market precinct. The five year renewal program seeks to retain and restore the market's heritage while moving key market infrastructure and parking below-ground to create more room for market trade and new open space. Importantly, the market will continue to trade right throughout the renewal program with a strong focus on business continuity during construction.



Status:

Ongoing delivery of the QVMPR Program:

- Trader workshops continue to inform detailed design and operational functionality of the New Market Site pavilion.
- Functional briefing workshops for the underground operational areas are continuing with QVM P/L.
- Refresh works to the H and I toilet block are complete.
- The Green Star Communities Rating submission has advanced with targeted lodgement of Round 1 in April 2017.
- Precinct Cultural Heritage Management Plan for Munro Site and Queen Street submitted to Aboriginal Victoria.
- Munro and other planning approvals are dependent upon the approval of Amendment C245.

2. Metro Tunnel Project

Planned completion date:

Scope of work: Work in partnership with Melbourne Metropolitan Rail Authority to optimise project benefits for CoM and facilitate delivery. Planning approval was Gazetted in January 2017. Early Works contract has commenced and due for completion in Feb 2018. Main contract commences Feb 2018.

- Early Works at CBD North (Franklin Street / A'Beckett Street) commenced January 2017.
- Early Works at CBD South (City Square) commenced late March 2017.
- Compensation negotiations with MMRA commenced in March 2017.
- PPP consortium bids due April 2017. A CoM director and two executive managers will prepare a confidential report for MMRA regarding the bids by mid May 2017.

Scope of work: Redevelopment of the Council House 1 precinct to provide Council and commercial accommodation subject to detailed financial and project analysis.

Status:

- Continuing updates on progress have been provided throughout the last quarter via a Council report on 28 February 2017 and a presentation to a Councillor Forum on 28 March 2017
- PPP consortium bids close in April 2017 for the Metro Tunnel Project. The opportunity for future accommodation, associated with the over site development at CBD South will be better understood once the tender process has advanced.
- Commercial real estate advice is being sought to analyse comparative development options for both the CH1/CBA site and the over site development at CBD South.
- A further report and presentation will be submitted to Council on 30 May 2017 with the results of the comparative analysis.

4. Southbank Boulevard Upgrade

2016-17 Budget: Total Project Budget: \$18.87 million \$1.19 million

Planned completion date:

June 2020

Scope of work: The creation of 2.5 hectares of public open space in Melbourne's most densely populated suburb.

Status:

- Yarra Trams has agreed to issue an Occupation Permit so that stage one construction can start in April, 2018 to align with Easter holidays
- Meetings with the Public Transport Working group to resolve public transport infrastructure requirements for trams and buses have been held regularly so that a final functional layout can be completed.
- 3D modelling and rendering is underway to prepare concepts for community consultation.
- A key stakeholders meeting was held at Eureka Observation deck at the Yarra River Traders' Association annual meeting.
- Design work to ensure a seamless integration with the new Melbourne Conservatory of Music linear park and Dodds Street has concluded.
- Preparation of a Cultural Heritage Management Plan and the road discontinuance process is underway.
- Display of the Southbank Boulevard & Dodds Street Draft Design is now scheduled to June/July 2017 to incorporate transport infrastructure and Melbourne Metro tunnel requirements.

5. University Square

Scope of work: To develop a University Square Master Plan and construction program that restores a failing landscape and creates a 21st century park in Melbourne's education precinct.

Status:

- Design development and tender documentation continues for stage one construction work on Leicester Street, Pelham Street gateway and the main lawn
- Detailed negotiations continue with the Melbourne Metro Rail Authority and other State Government agencies to ensure that stage one construction at University Square can proceed while accommodating occupation and construction requirements for the new Parkville Station and traffic and bus diversions.

Scope of work: To prepare a landscape concept plan for Lincoln Square, following completion of the plaza and flood mitigation/stormwater harvesting tank that sets out a blue print for the future of Lincoln Square. Including potential park expansion, improved pedestrian circulation and a new play space.

Status:

- Work on the storm water harvesting tanks and diversion pit are complete with Lincoln Square North Road opened.
- Works on the power supply upgrade and pumps enclosure are underway with works scheduled for completion end of July 2017.
- Community engagement for the Lincoln Square Landscape Concept Plan commenced.
- A concept plan for Lincoln Square on track for July 2017.



7. South End Elizabeth Street

Scope of work: The southern end of Elizabeth Street streetscape improvement plan (between Flinders Street and Flinders Lane) is being progressed by City Design following targeted stakeholder engagement in 2016. Improvements to the southern end of Elizabeth Street will prioritise pedestrians, improve safety, enhance public open space and the retail interface, as well as ensuring integration with major state government projects at Flinders Street Station and the Metro Tunnel Project. This project actively integrates with the development of a broader Elizabeth Street Plan, with input from a number of Annual Plan actions (water management).

Status:

- Designs and planning for standard upgrade of the Western footpath underway with construction to commence in June, 2017.
- Key stakeholder consultation on a draft concept for the Eastern side Elizabeth Street to be held in May with broader community consultation in June, 2017.
- Construction of the Eastern side scheduled to commence in September, 2017 following completion of road closure process.



8. JH Boyd Redevelopment

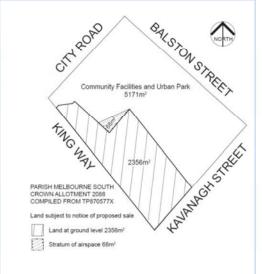

- Contract of Sale documentation in final stages with Settlement expected May 2017 following March Council agreement to sell the development site.
- Community to be updated in May about intention to build a permanent park and timeframes.
- Progress made on Boyd Park concept design to support phase 2 community engagement (July 2017) and park construction in 2017/18.

9. Lady Huntingfield Child Care Centre Upgrade and Hotham Hub

Scope of work: The redevelopment of Lady Huntingfield Childcare Centre includes delivering a 106 space childcare centre that incorporates an integrated model including maternal child health, family services and other compatible uses. The temporary relocation of families from Lady Huntingfield to an expanded Hotham Hub Children's Centre is required during 2017–18 to ensure continuity of services during construction.



Status:

Hotham Hub Alterations and additions

- Planning permit and secondary consent for design changes have been approved for redevelopment of the site.
- Tenders for building contractors has been received, currently under assessment.
- Planning continues for construction commencement in May 2017, slightly delayed due to need for scoping review based on tender prices. Transition of families into the expanded centre remains planned for December 2017.

Lady Huntingfield Redevelopment

- Planning continues for construction commencement in January 2018, with the transition of families back into the redeveloped centre planned for early 2019
- Schematic design agreed.
- Concept design under further development by the structural, civil, mechanical, hydraulics and electrical engineer to inform budget.
- Communication updates on progress continue with parents and staff via email and centre coordinators.
- Final schematic design will be on display and the community will be invited to view the design by mid June 2017.

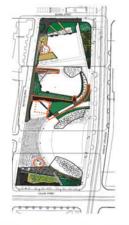
Scope of works: A number of small to medium scale projects to support the implementation of the Docklands Community and Place Plan (DCPP) and Harbour Esplanade.

Status:

- City Marina: (top picture) Concept design is now complete, includes shade structure and seating. An investigation into existing structure is underway. This will help inform design development.
- Docklands park enhancement works: (pictured, middle) Second stage scoping and designs underway now that first stage of renewal works is complete. Second stage of documented works include upgrade of landscape, furniture, ramps and planting, along with Reed Vessel art work repairs..
- Docklands South Park: Planning and pre-design investigations
 progressing with the replacement of the toilets and surrounding areas being
 the priority focus. The ecology review, traffic audit, and soil/water test are
 to be undertaken at a later stage.
- Docklands/Northbank Park: (pictured, bottom) Promenade and crane remediation progressing and on schedule for completion by end of 2018 (phase one). MoU between the State Government, City of Melbourne and Riverlee for remediation of existing sub structure (phase two) still to be agreed. An engineering scope has been received for the demolishing of this sub structure which is being further interrogated by City of Melbourne and the developer to ensure that the best possible outcome will be achieved. The brief for the public park (phase 3) is progressing to advance the design process.

16. Bicycle Improvement Program

- Nine Year 1 Bicycle improvement projects deferred due to Metro Tunnel Project and other third party projects. Nine Year 2/3 projects have therefore been brought forward, of which three are complete and six in progress.
