Report to the Council

Proposed travel by Councillor Louey: Osaka, Japan 28 August to 1 September 2018

Presenter: David Livingstone, Manager International and Civic Services

Purpose and background

- 1. The purpose of this report is to seek Council approval for the Chair, Prosperous City portfolio, and City of Melbourne appointee to the Business Partner City (BPC) Network, Councillor Louey, to travel to Osaka, Japan to participate in the BPC network Roundtable 2018, 28 August to 1 September.
- 2. The City of Melbourne has been a member of the BPC network since 1999 and has participated in each annual roundtable since. The secretariat of the BPC network is the Osaka City Municipal Government, one of the City of Melbourne's most important global partners. Melbourne and Osaka's 40th Anniversary of sister city relations is being commemorated in 2018. The BPC network consists of 13 other economically important Asia Pacific cities that Melbourne maintains significant connections with, such as Shanghai and Tianjin in China and Ho Chi Minh City in Vietnam.

Key issues

- 3. With its theme of '*Creation of Business Innovation and Strengthening of International Competitiveness*', participation in the BPC Roundtable will provide the City of Melbourne with an opportunity to:
 - 3.1. promote the City of Melbourne's international interests through key city partners across the Asia-Pacific region
 - 3.2. showcase Melbourne's strengths as a global centre of innovation
 - 3.3. nurture and leverage an important regional network.
- 4. Additional meetings will be sought with the cooperation of our contacts at the Australian Consulate-General in Osaka (Austrade) and the Victorian Government Trade and Investment Office in Tokyo. These additional meetings will provide the City of Melbourne with an update on market developments and opportunities for trade and investment for Melbourne businesses (proposed itinerary at Attachment 3).
- 5. Melbourne and Osaka have a history of close engagement in the health and life sciences sectors and are developing closer links relating to startups and urban design. These connections have gained significant momentum through the 2018 Business Mission to Japan in March 2018, including valuable leads that could be incorporated into the BPC network travel program to good effect.
- The Mayor of Osaka, Mr Hirofumi Yoshimura, plans to visit Melbourne with a business delegation from 16-20 December 2018 to celebrate the 40th Anniversary. Participation in the Roundtable will also provide the Councillor an important opportunity to discuss the visit.
- 7. It is proposed that a member of the International and Civic Services Branch accompany the Councillor to provide high level support to the visit.

Recommendation from management

- 8. That Council:
 - 8.1. Approves City of Melbourne's participation in the 2018 BPC Roundtable in Osaka, Japan.
 - 8.2. Nominates Councillor Louey's travel to Osaka to participate in the Roundtable and stakeholder meetings for the period 28 August to 1 September 2018.
 - 8.3. Approves an amount of up to \$6300 to cover the travel costs, including: business class airfare \$4600, accommodation \$600 (three nights including three breakfasts) and \$1065 to cover meals and incidentals (three days at \$355 per day).
 - 8.4. Notes that Councillor Louey will prepare a report to the Future Melbourne Committee or Council within 60 days of return from travel.

The estimated cost of the proposed travel to Osaka for the Councillor would be \$6300 which includes business class airfare \$4600, accommodation \$600 (three nights including three breakfasts) and \$1065 to cover meals and incidentals (three days at \$355 per day). These costs will be met from within the approved 2018–19 overseas travel budget.

Participation in the 2018 BPC in Osaka will contribute to achieving Council Plan Goal: 'A Prosperous City' which seeks to position Melbourne as the destination of choice amongst international and local business and enterprise by excelling in its ability to nurture a vibrant economy for those who work, live, study, visit and invest. It also pursues the business approach outlined in 'Melbourne: Doing Business Globally' (endorsed by Council November 2014) which guides Council's international activities to deliver business development opportunities that increase exports and investment.

Environmental sustainability

5. The carbon emission resulting from air travel to Osaka will be offset with the purchase of credits.

Overview of the theme:

This year marks the commemorative 30th anniversary since the founding of the Business Partner City (BPC) Network. Over the past 30 years, the Asia-Pacific region has experienced the active promotion of trade and investment liberalization along with the facilitation of multilateral trade and introduction of foreign investments. These developments not only stabilized the economic foundation but it also stimulated rapid economic development in the Asia-Pacific region. Presently, as the driving force of global economic growth, this region has continued to lead the world economy. We anticipate that the Asia-Pacific will retain its position as the world's most dynamic region for the coming years.

Despite the rapid economic growth, each country and region face new issues and challenges such as labor shortage influenced by the declining birthrate and aging population as well as decreased population, income gaps, poor economic and social infrastructures, environmental problems, resource and energy problems, new infectious diseases, increased needs for disaster-prevention and anti-terror measures. This will correlate with the aims of raising international competitiveness and making regions capable of continuously evolving and growing through the establishment of innovationfriendly environments in business partner cities. Let us take this opportunity to reflect how business partner cities can collaborate by exploring various perspectives and angles.
