Purpose and background

- The purpose of this report is to consider the dates, times and venues for meetings of the Council and its Future Melbourne Committee (FMC) for 2019.
- 2. The Council, on 26 September 2017, approved meeting dates for the Council and FMC up to the end of December 2018. The FMC ratified its meeting dates on 3 October 2017.

Key issues

- 4. The schedule can be amended by resolution of the Council as necessary.
- 5. Typically FMC meetings are scheduled on the first and third Tuesdays of the month and Council meetings are scheduled on the last Tuesday of the month.
- 6. Given next year's National General Assembly of Local Government is to be held from 16 to 19 June 2019, the FMC meeting has been scheduled for Thursday 20 June 2019.
- 7. Due to the Melbourne Cup holiday, FMC meetings will be held on the second and third Tuesday in November 2019.
