The Alliance for Gambling Reform is very pleased to see City of Melbourne progressing with Planning Scheme Amendment C307.

It was a substantial piece of work and has come through the initial consultation period largely unscathed, despite the pokies industry raising some concerns.

The City of Melbourne has arguably the best record of any Australian council when it comes to resisting pokies applications, as the amendment report notes.

Council's relatively modest 11 pokies venues (excluding Crown Melbourne, where gamblers lost \$450m on the pokies in 2017–18) is a remarkable contrast with the 200-plus pokies venues which have ruined City of Sydney, particularly

the live music scene.

Containment of pokies and Melbourne's laneway and small bars culture have delivered your council Australia's best performing and most vibrant night time economy.

However, recent analysis by The Alliance has revealed that the state seat of Melbourne delivered pokies venues \$84 million in gambling losses in 2017–18, the highest of any seat in the Legislative Assembly (excluding Crown's contribution to losses in Albert Park).

This figure matches City of Melbourne as a whole as all 11 pokies venues fall within the state seat of Melbourne.

For this reason, council needs to be particularly vigilant to resist future pokies applications whilst also considering future interventions which may manage down both losses and venue numbers. (ie Could the Celtic Club be persuaded not to re-open with the 40 pokies currently being stored in a warehouse).

To that end, it is imperative that the next Victorian Gaming Minister ends the ridiculous situation which sees the Capital City Zone being the only part of Victoria which is not capped for poker machine numbers and we encourage further council advocacy on this matter.

Finally, it has been noteworthy that the gambling issue has been largely absent from the state election campaign debate. This is mainly because the two major parties are on a unity ticket and don't have any interest in discussing the issue.

The Alliance therefore encourages councillors to make some strong statements in support of gambling reform and the proposed amendment during tonight's debate.

In support of this move, we have commissioned our mobile billboard to do a few laps of the CBD this afternoon ahead of your discussion at Town Hall.

I look forward to addressing the committee on this important matter this evening.

It was disappointing not seeing any Councilors taking part in this.
