Melbourne Fashion Week Runway Production Agency Tender Contract No. 3587

Purpose and background

- 1. The purpose of this report is to seek approval to award the contract for the Melbourne Fashion Week (MFW) Runway Production Agency (Contract No. 3587) to Event Gallery Pty Ltd for a term of one year, with two additional one year extension options.
- 2. This contract provides the production development and delivery of the MFW Designer Runways, including development of runway creative concepts, procurement of talent, staff and all operational requirements.
- 3. The current contract is being delivered by Event Gallery Pty Ltd under a one year contract with two one year options to extend. The options to extend were exercised with the final year contract expiring March 2019.
- 4. The tender was advertised in 'The Age' newspaper on 3 November 2018. Six tender submissions were received and five were compliant.
- 5. Consistent with the industry approach the tenderers were advised that the value of the contract was \$339,500 exclusive of GST, and asked to provide their best creative and value-for-money content for the tender.
- 6. The Tender Evaluation Panel assessed each submission based on the evaluation criteria of Cost (30 per cent), Experience and Capability (30 per cent), Plan for Proposed Services (30 per cent) and Supplier Compliance Management (10 per cent).
- 7. Following a review of the tender submissions three shortlisted applicants were invited to present their plan for proposed services to the Tender Evaluation Panel on 10 January 2019.
- 8. The tender evaluation summary is contained in Attachment 1.

Key issues

- 9. Event Gallery Pty Ltd was evaluated as the preferred tenderer by the Tender Evaluation Panel as their submission demonstrated the strongest alignment with the service specifications of the contract, as well as the most appropriate use of available budget, and their experience, capability and past performance was to an extremely high standard.
- 10. The costs for appointing the recommended tenderer are \$339,500 annually, and are provided for in the current budget.

Recommendation from management

11. That Council awards the contract for the Melbourne Fashion Week Runway Production Agency to Event Gallery Pty Ltd for a term of one year at an annual cost of \$339,500, with two additional one year extension options in accordance with the negotiated terms and conditions of contract.
