Dear Lord Mayor and Councillors,

We are very disappointed with the suggestion of appealing the decision of Heritage Victoria which rejected an entirely inappropriate development at Fawkner Park.

Fawkner Park is "a magnificent setting of significant tree avenues and open spacious lawns" as described in the current Master Plan for the Park. This is one of the great Heritage Parks of Melbourne and so it is with disbelief that we learned of the City Council plan to construct a multifunctional competition style sports court on one of the grass fields of the Park alongside the heritage avenue of Elms. This is currently a popular picnic spot and playground for young children with dappled sunlight through the Elm trees. We believed that the highly esteemed heritage values of the Park would be a constraint on the Council's plan and Heritage Victoria has duly upheld these values and refused a Permit for the current project.

We would question the basis of an Appeal to Heritage Victoria against their decision. The Heritage values of the Park were not adequately considered in the original plans for improvements to the Pasley Street North entrance to the Park. Several consultants were engaged over the 11 years developing this project but **there appears to have been no Heritage expertise employed.** 

There are other major problems with the proposed works which should be of concern to the Council.

1. The public benefit and need for the new sports court out towards the centre of the Park is unclear. The public appears to be happy with the present arrangements and passive recreation users and active sports groups exist harmoniously in the Park. The passive recreational users appreciate the peaceful serenity of the Park at the same time as there are active sporting interests on the expansive playing fields and the peripherally located sports courts. In contrast the new proposed court in the Parkland is highly intrusive in appearance, noise and activity levels.

The Primary School is happy with their present court. **Parents support leaving it where it is**. The proposed new court is 400 meters from the school, shared with older participants, not as accessible and has added security risks.

2 The main arguments put forward for the removal of the school's paved area concerns the drainage problem but this occurs in a depression four meters north of the paved area and where there is no drainage grill. The water sometimes trickles onto the basketball court. It is misleading to say that the paved area "acts as a dam". According to one parent who visits the site daily two drains were installed wrongly, around the perimeter of the depression where they are quite ineffective and other faulty work is behind the problem. The Drainage Report from Cardno Victoria, which accompanied the Application to Heritage Victoria made no reference to the school asphalt area as a problem. It is unclear whether other problems identified have been dealt with. In the words of the submission of the Australian Garden History Society to Heritage Victoria, "simple engineering works and some careful landscaping should be able to resolve and improve this area".

3 The public information and publicity campaign was flawed and limited. This explained the small number of negative responses to the original Concept Plan which remained unchanged following the consultation period

The project was publicised as "Entrance Improvements" to the Pasley Street North entrance to the Park, a misnomer for the scale and nature of the work. The project extended from the entrance all the way to the Avenue of Elms. An area of 1 hectare. The simple outlines of the Basketball court on the asphalted area of the school playground became a multipurpose, well fitted out sports court with asphalt base and platforms for skateboarders surrounded by concrete pathways which increased the size of the court area to over 1000sq.m. It was not the relocation of the present court but a larger, ostentatious court set against the Avenue of Elms. The plans progressed far beyond improving landscape and drainage issues around this entrance to the Park. Posted in the Park were signage unhelpful in explaining the program of works with an unlabelled diagram and wording that did not refer to either a court or its relocation at all.

The large population of residents on the North and West side of Fawkner Park who make up the largest use of the Park, the passive recreational users of the Park, were almost entirely unaware of the extensive work planned for Fawkner Park. There was a mail out to residents but this appeared to be sent to Pasley Street residents only.

Submissions to Heritage Victoria, e.g. the National Trust, suggest improvements to Pasley Street entrance to Fawkner Park may be achieved with **the court in its present or nearby position**.

Finally, the eight Heritage Parks should be managed with respect for their Heritage value. Problems of conflict between community interest and needs and Heritage values could be resolved if expert Heritage advice was included in the planning process and design team right from the beginning

on the basis that:

1. the new position makes the court less conspicuous to the outside of the park because it is located further from the entrance and therefore relatively hidden – surely a win for heritage values.

2. this location will reduce the noise to residents, (effectively improves the heritage value of a peaceful park for residents)

3. the new treatment prevents the park being being degraded further by the drainage issues, and thus losing heritage value.

4. the new entrance creates a more park/garden like atmosphere to the entrance, rather than the current "marshalling area"

5. some rearrangement of paths is essential and obviously necessary to improve safety from bike riders especially for the 440 children (this year) at the South Yarra Primary School before and after school and at recess times. Parents can't pick up children at the front of the school where there is only a miniscule footpath alongside the fierce racetrack of Punt Road. (The school has even lost its meagre front garden as 12 new classrooms are built this term.) Is it being suggested that we add hand rails to heritage buildings for the frail, but don't protect children from the lycra brigade coming downhill from Toorak Road? I have a special concern for the pre schoolers who attend pick up with their parents. The new paths are intended to deviate bike riders (who use Pasley St North and the associated pedestrian crossing) away from both the South Yarra Primary School, Christ Church Grammar School and the preschool which use the eastern paths.

We, the School Council of South Yarra Primary School, would like to highlight our strong support of the proposed 'Pasley Street North Entrance Improvements' at Fawkner Park.

Our school currently has 444 enrolled students. The student numbers are increasing each year, and there is high demand for the school. The improvement works proposed are to the rear of the school, which is the main entrance for all school students.

Given the limited space on the school campus, the school children play in Fawkner Park during recess and lunch time. These improvement works will provide exactly that, the improvement to the existing conditions of the area of Fawkner Park at which they play and enter the school.

This area of the park is currently in a significantly degraded state. The area is known to staff and students as the dust bowl, as the grass no longer grows there. When the wind blows, the dust circulates throughout the school and playground. The existing layout of this area of the park (including structure paths or lack thereof) ignores the movement of students and parents in this space, and does not recognise the constraints of the land in that area.

During heavy rainfall events the area floods for many hours and sometimes days, impacting the safe and secure entry and exit of the school. This impacts the ability for parents to drop off the children in an orderly fashion and it impacts the ability of the students to access the play spaces in Fawkner Park.

The proposed relocation of the basketball/netball court is viewed as beneficial by the School Council on two grounds. Firstly, it will improve the drainage and flooding issues in the area, and secondly, it will move the basketball court to an area that is safer for the children to play ball sports – that is, further from the road.
