

#### 1. That Council:

- 1.1. Amends the Council's General Delegations Policy in accordance with the changes identified in Attachment 2 of the report from management subject to the final sentence in new section 5 being replaced with "Where notice of such a proposed resolution has been given but quorum is unable to be achieved to consider the proposal, then suspension will be by agreement of both the Lord Mayor and Chief Executive Officer, with such an agreement required to be notified to all councillors and published on the corporate website forthwith. All decisions that would normally have been dealt with by Council or special committee in open session, but which are made under delegation due to an emergency and/or extraordinary circumstances under this section, will be published on the corporate website as soon as practicable".
- 1.2. Amends the Council's Delegation Policy for Planning Applications in accordance with the changes identified in Attachment 3 of the report from management subject to the final sentence in new section 2.6 being replaced with "Where notice of such a proposed resolution has been given but quorum is unable to be achieved to consider the proposal, then suspension will be by agreement of both the Lord Mayor and Chief Executive Officer, with such an agreement required to be notified to all councillors and published on the corporate website forthwith. All decisions that would normally have been dealt with by Council or special committee in open session, but which are made under delegation due to an emergency and/or extraordinary circumstances under this section, will be published on the corporate website as soon as practicable".
