Management report to Council

Purpose and background

1. The purpose of this report is for Council to create a new delegation under the *Road Management Act* 2004 (RMA) to reflect updated positions.

Key issues

- 2. At its meeting of 29 June 2021, the Council reviewed delegations which had been made under section 11 of the *Local Government Act 2020* (the Act), delegations by Council under other Acts and Council's general delegations policy.
- 3. One of the Acts reviewed was the RMA.
- 4. Due to a change in a Branch name, new delegations are required for updated positions.
- 5. It is recommended that a new delegation under the RMA be made to reflect the updated positions and the previous delegation revoked.

Recommendation from management

 - 6.1. By instrument of delegation sealed by the Council under section 118(1) of the *Road Management Act 2004* (RMA), delegates to the persons from time to time holding the positions referred to in column 1 of Attachment 2, Council's powers and functions as a road authority under the RMA, identified in column 1, subject to:
 - 6.1.1. the conditions and limitations identified in column 4 of Attachment 2 of the report from management.
 - 6.1.2. the restrictions contained in section 118(1) of the RMA and section 11(2) of the LGA 2020.
 - 6.1.3. compliance with Council's General Delegation Policy.
 - 6.2. Revokes instrument of delegation CCL-2021-1 relating to the RMA, with such revocation to take effect immediately after the execution of the instrument of delegation referred to in paragraph 6.1 above.
