In my capacity as a president of Carlton Inc, representing all the Traders on Lygon Street, and director and owner of one of the oldest and most recognisable businesses on Lygon Street being King and Godfree, I strongly oppose the positioning of any toilet near our main street which relies heavily upon outdoor dining. When this proposed toilet was first brought to Carlton Inc's attention a number of years ago we provided a petition against it, signed by the majority of traders in the area, with supporting photos of the Piazza Italia public toilets that are consistently covered in graffiti and where a number of homeless people take shelter. As a compromise we suggested that if it had to be put anywhere, it be placed in your proposed position 4, which would not affect our businesses or residential homes, and where it would have the most use being near a large public transport depot. The precedent set with the public toilet near the Piazza has only shown us that these proposed toilets will significantly detract from any visitors wishing to dine in our area, as who in their right mind would want to eat and drink near a toilet. My family owns a number of residential properties in the area and have never had any issues with public urination or defecation in our 70 years experience in the area, so I am perplexed as to why this toilet is being proposed in the first place. Three of your proposed locations will affect three of the most prominent businesses and draw cards to the area. It is an insult to the hard work and investment they have made to make Carlton what it is today. I implore you to use some common sense and to place this toilets in a position that will least affect the surrounding

businesses which would be position 4. Carlton inc has for the last three years asked for a number of improvements to be made to our street that have been based upon the traders day to day experience, and yet it is the Carlton Residents Association that has had the ability to put this proposition through against the will of the business and land owners who will be most affected by it. I do not understand why their opinions matter more to the City of Melbourne than the businesses that have been truly struggling to survive over these past few trying years. I strongly believe that if the homelessness issue was addressed and rectified we would not have the need for these proposed toilets and that these toilets will only entice more homeless to the area. King and Godfree have made submissions, delivered petitions from residents and patrons, and met with council over the last 4 (?) years to object to the proposal of Public toilets in Faraday Street adjacent to our premises.

Over the last 8 years we have been involved in lengthy, expensive and protracted planning sessions with the City of Melbourne and the heritage department to obtain planning permits to renovate our heritage listed building.

We altered plans so as to fit in with the heritage of the street scape and our building, to meet with the requirements of these departments.

Especially we had to ensure that our building did not visually impact the view from the street.

The idea that a public toilet now be allowed to be placed outside our front door within 6 metres of curb side tables and entry defies belief.

The preferred option is near the tram stop, or in near Cardigan Street, close to the kitchen for the homeless or adjacent to the now de commissioned public toilets on the east side of Faraday Street.

You may all be aware of the impact of Covid on our business . How can we leave curb side tables so close to a public toilet? One only needs to see the filthy condition the public toilet adjacent to Carlton Gardens to imagine the impact to our business.

What of the 'Heritage " street scape which we spent countless amounts of money to retain and the council spend

endless hours to ensure?

King and Godfree features in advertisements for Melbourne which the council have made and paid for by the council , which are currently screening on TVC, yet you propose to disfigure the vision with a public toilet?

Thanks to Alison Leighton and the management team for the time and effort that they have put into preparing this report.

I support the recommendations from the management team . Councillor Jamal Hakim and the City of Melbourne should benefit a great deal from this overseas trip to Aotearoa. Councillor Jamal Hakim should be encouraged to enjoy the experience of learning more about Auckland and its creative sector, and to embrace the role of sharing Melbournes story with our friends across the ditch. Melbourne is an international city and it is appropriate for the Lord Mayor, Councillors and City of Melbournes management team to travel overseas to enhance Melbournes reputation and extend its knowledge and skills base.

Melbourne is the music capital of Australia. City of Melbourne has been very pro-active in encouraging and supporting the music industry through difficult times. Melbourne Music Week (MMW) is now recognised as an important music festival, and is embraced by musicians and industry. The music scene in Auckland is a vital part of that city's cultural landscape, and is a huge part of Aucklands identity. A prime example of the pride New Zealanders have with their music scene is that when New Zealand Prime Minister Jacinda Ardern had her first meeting with Prime Minister Anthony Albanese, as a gift she presented to the PM music album releases from New Zealand's legendary Flying Nun label - including records by Aldous Harding, The Clean, and Reb Fountain. In an egalitarian manner, Prime Minister Anthony Albanese gave the NZ PM vinyl records from Spiderbait (Victorian band), Midnight Oil (NSW band) and Powderfinger(Queensland).

The New Zealand Music Commission gives great encouragement and support to local New Zealand musicians. The Going Global Music Summit is a two day specialised music industry conference taking place at Roundhead Studios in Auckland. It offers Aotearoa musicians and industry further education, inspiration and the chance to connect to the global music industry.
