- 1. That the Future Melbourne Committee:
  - 1.1. Notes that the City of Melbourne is planning to amend the Melbourne Planning Scheme in 2020 to give effect to a new Municipal Planning Strategy (formerly 'Municipal Strategic Statement');
  - 1.2. Expresses its intention that, as part of the above described planning scheme amendment, a series of non-controversial zoning changes for all Council-owned informal parks as well as the Royal Park Nature Playground to the 'Public Park and Recreation Zone' (PPRZ) also be exhibited;
  - Requests management to prepare mapping and ordinance amendment documentation to facilitate this process.
  - 1.4. Indicates the City of Melbourne's intention that as future informal recreational spaces in the municipality are created on Council-owned land not zoned PPRZ, further rezoning amendments to bring such spaces into the PPRZ should be pursued, and coupled with other amendments where convenient.
