RESPONSE IN RELATION TO:

Events leading up to the Future Melbourne Committee 4th June 2019 personally affected me.

STATEMENT

In recent times I have become increasingly concerned about a litany of media regarding Chinese influence in various Australian governments, political organisations and officials and in particular Chinese 'sensitivity' around media reporting on the events in Tiananmen Square.

On June 4, I personally experienced the affect of Chinese 'sensitivity' manifested locally at my workplace, i.e., Council. This concerns me greatly. It continues to do so. I am personally affected and I feel an obligation to ensure that these events be recorded in the public realm. This is my first opportunity to do so.

PERSONAL EXPLANATION:

Most Australians, regardless of their origins, will be aware that June 4 is a day of tragic significance, the anniversary of the 1989 events in Tiananmen Square.

At the June 4 FMC meeting, my intention <u>had</u> been to move a simple and respectful Motion concerning the tragic events of that day. Two of my colleagues had offered to second my Motion which

- Firstly, acknowledged the 30th anniversary of this tragic event, which has
 caused such great pain and disrupted the lives of so many young Chinese
 students then studying in Australia.
- Secondly, acknowledged that we in Australia, and now they, have the
 privilege of living in a democracy where human rights are upheld.

However, during the afternoon prior to the 5.30 pm June 4 FMC meeting, a series of events unfolded sending an alarming 'message' to Council. I believe 'political influence' at Consular level occurred which triggering acute distress in some of my colleagues. When confronted by this distress, finally at 5.25 pm I was dissuaded from proceeding with the Motion or with an agreed Statement or a Personal Statement as intended. Regrettably the anniversary June 4 came, and went, unacknowledged by Council.

On reflection, I know that this timid acquiescence in the face of such pressure was an error on my part. I regret this on a number of levels.

Choosing to stay silent, to in effect bow to 'political influence' right here in our city, may have been a humane or collegiate response, but it was contrary to the very democracy that we hold dear.

Such silence on my part, and ultimately on the part of Council as a whole, is a disservice to our democratic processes.

Remaining silent resulted a failure to acknowledge what has happened to those in our community granted protection and refuge within our democracy 30 years ago.

This 'political influence' altered the actions of a democratically elected Councillor – in this instance me. It succeeded in changing my conduct on June 4. In effect, it led to suppression. Such 'political influence' manifesting as distress in a colleague, or voor resulted in my failing to acting as my conscience dictated.

This is not a minor matter. My sense is that this incident raises questions on the conduct of Council. I have little doubt that such 'political influence' will come again into play in Council affairs.

Such 'political influence' is not benign, nor respectful, nor acceptable in our democracy. It has to be called out for what it is, when it happens. And it will happen. As Albert Einstein remarked 'If I were to remain silent, I'd be guilty of complicity.' And I refuse to be complicit!

Awareness, vigilance, and transparency are required of us all, In the interests of transparency my intention in making this this personal statement is ensure that this regrettable incident of overt 'political influence in fact known in the public realm.
