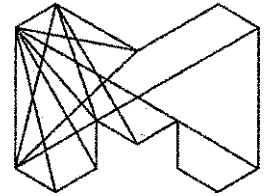

Approval for exemption has been granted by the State Department of Health on the basis that the recommended changes below to the draft Council Plan are made in order to satisfy matters specified in s26(2) of the *Public Health and Wellbeing Act 2008*.

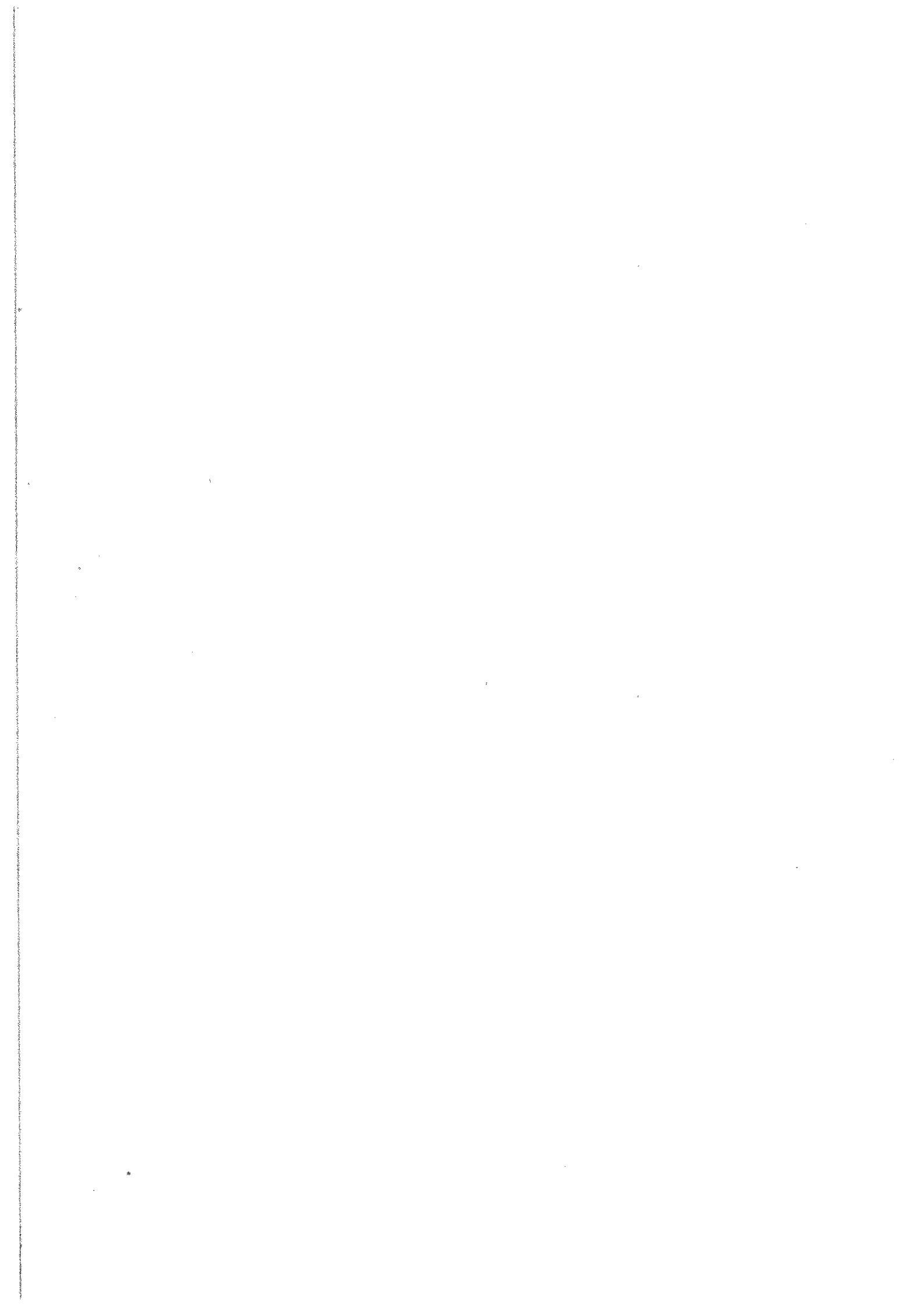
