FORM VALID FROM 1 JULY 2021 TO 30 JUNE 2022



Please note that it is not a statutory requirement under the Food Act 1984 to submit floor plans for a new food premises layout. The City of Melbourne however strongly recommends that floor plans be submitted for assessment to ensure that any proposed works comply with the requirements of the Food Standards Code.

Council provides this service to assist businesses meet their legislative obligations when fitting-out food premises and to ensure that any additional works or changes are avoided post-construction, which is often a more costly and time consuming exercise and may delay granting of Food Act registration.
