Docklands Summit Actions and Next Steps

Purpose and background

- 1. On Tuesday 20 September, Future Melbourne Committee (FMC) resolved to incorporate the findings from the Docklands Summit into the neighbourhood planning program including clear actions, and maintain engagement and involvement through the Neighbourhood Portal (the Portal).
- 2. The feedback received as part of the workshops at the Summit has been collated into a "what was said" report published on the <u>Participate Melbourne</u> website. Key themes and solutions raised at the Summit are listed in Attachment 2.

Key issues

- 3. Actions that align with existing Neighbourhood Priorities will be incorporated into the Portal, as part of a Summit specific update in November. Management will play a convenor role in bringing together key stakeholders in Docklands to continue momentum from the Summit as part of on-going community engagement via the Neighbourhood Portals.
- 4. Solutions and actions that align with existing Council priorities and work programs will continue to be delivered and reported as part of the Council Plan, such as advocacy for the redevelopment of Central Pier, delivery of the Shopfront activation program, Greenline and the Events Partnership Program.
- 5. Emerging solutions and actions that sit outside of the Council Plan and the Neighbourhood Priorities require further investigation, prioritisation and consideration of resourcing. Potential new projects to deliver on these actions in the short, medium and longer-term include:
 - 5.1. **Immediate beautification (short-term):** Deliver temporary beautification focused around Victoria Harbour, such as relocatable planter boxes, public benches, public artwork and additional greening.
 - 5.2. **Yanonung Quay (short-term):** There is an opportunity to partner with Development Victoria (DV) to deliver physical improvements and a program of small-scale activation at Yanonung Quay on Harbour Esplanade; leveraging the recent investment by Port Phillip Ferries. This proposal would create a community focal point, including a platform for community events and place-based engagement which can be realised within the next 12-24 months.
 - 5.3. **Brand and identity (short-medium term):** Build on the pride the Docklands community have in their neighbourhood, by ensuring communications celebrate the successes and unique qualities of the precinct. Promote events and activations that align with Docklands as a family friendly precinct (for example the Boat Show).
 - 5.4. **Community infrastructure (medium-term):** Partner with DV to review the operational capacity of existing community facilities and identify opportunities to deliver improvements.
 - 5.5. **Public Realm Improvements Plan (medium-term):** Prepare a plan for Docklands which reviews the current provision of basic amenities, wayfinding, public art, greening and parks, lighting, infrastructure servicing and identify areas for capital works investment as well as opportunities for creative spaces for short-term activation.
 - 5.6. **Strategic Plan (longer-term):** Work with the Victorian Government to investigate preparation of a strategy plan for Docklands which would include a precinct wide vision, identify sub-precincts and their characters, feasibility options for a new or expanded school, review planning controls and make recommendations for changes, and consider the potential for transformational projects.
 - 5.7. **Governance (longer-term):** Work with the Victorian Government to establish a Docklands Governance Review Group with representation from the major authorities in Docklands, to review the roles and responsibilities of the various agencies and identify clear procedures for communications and decision making; and set out a strategy for the transition of development control from DV to Council at the appropriate time.
- 6. New initiatives, activities and projects emerging from this work will inform upcoming annual planning and budget process for 2023–24.

Recommendation from management

- 7. That the Future Melbourne Committee:
 - 7.1. Endorses the Docklands Summit actions and next steps (attachment 2).
 - 7.2. Prioritise the following projects, subject to the allocation of funding and resourcing:
 - 7.2.1. convene a stakeholder group to facilitate connections in the precinct and continue momentum from the Summit
 - 7.2.2. undertake immediate beautification around Victoria Harbour
 - 7.2.3. partner with Development Victoria (DV) to deliver physical improvements and a program of small-scaled activations to Yanonung Quay
 - 7.2.4. ensure communications celebrate Docklands and promote events that align with Docklands as a family friendly precinct
 - 7.2.5. partner with DV to review the operational capacity of existing community facilities and identify opportunities for improvements
 - 7.2.6. prepare a Public Realm Improvements Plan to review the current provision of amenities and identify areas for improvements and activations
 - 7.2.7. work with the Victorian Government to deliver a Strategic Plan Docklands
 - 7.2.8. work with the Victorian Government to establish a Docklands Governance Review Group.

Legal

1. There are no direct legal implications arising from the recommendation from management.

Finance

- 2. There is currently no budget allocated specifically for Docklands Summit projects, though there is some potential for redirection of savings this financial year toward small scale public realm projects.
- 3. Preparation and delivery of new initiatives, activities and projects will require additional resources, external consultant support and annual capital works budgets.
- 4. Major projects, such as the redevelopment of Central Pier and Harbour Esplanade, will be dependent on Victorian Government budget bids and supported through on-going advocacy by Council.

Conflict of interest

5. No Council staff, or other persons engaged under contract, involved in advising on or in preparing this report declared any material or general conflict of interest in relation to the matter of the report.

Health and Safety

6. As part of the workshops at the Summit, the Docklands community raised a number of concerns around safety, accessibility and amenity. The projects identified to deliver on the actions from the Summit, include improvements to the public realm, activations and initiatives to address these issues, to have a positive effect on health and safety of the Docklands and wider community.

Stakeholder consultation

- 7. On-going community engagement on the agreed actions will be maintained through the Neighbourhood Portal.
- 8. Targeted stakeholder discussions (including partnership funding opportunities) will be undertaken as individual projects progress to the detailed design phase, through the Neighbourhood Portal.

Relation to Council policy

9. The renewal of Docklands, including increased visitation, activation and the redevelopment of Central Pier and surrounds, is identified through a number of Major Initiatives within the Council Plan 2021-25 and the Economic Development Strategy 2031. Specifically MI 7, increase visitation to Docklands by partnering with the Victorian Government and key stakeholders to enable reconstruction and redevelopment in Central Pier and surrounds.

Environmental sustainability

10. Environmental sustainability will be supported through the delivery of the public realm improvements through increasing biodiversity in Docklands through greening.
