Pathway Maintenance and Support contract: No 3515 25 November 2014

### Purpose and background

- 1. The purpose of this report is to award a tender for the provision of support and maintenance for the Pathway application for five years.
- 2. The current support and maintenance for the Pathway application expires on 31 December 2014. A new contract will ensure continued support, services and improvement for this core Council application.
- 3. The tender was advertised in 'The Age' newspaper on Saturday 16 August 2014. One tender submission was received and it was compliant.
- 4. The weightings of the evaluation criteria were declared in the Invitation to Tender documents and were Cost (60 per cent), Experience and Capability (30 per cent), IT Solution and Work Plan (10 per cent), with a pre-qualification of Supplier Compliance Management.

# **Key issues**

- 5. The response received by INFOR Global Solutions (ANZ) Pty Ltd was of a high quality and met the technical specification. The quality of the service previously provided by INFOR Global Solutions (ANZ) Pty Ltd met our contracted agreement.
- 6. The cost to Council of appointing the recommended tenderer is \$1,976,995.54 over five years.

### **Recommendation from management**

7. That Council awards the contract for the provision of Pathway Maintenance and Support to INFOR Global Solutions (ANZ) Pty Ltd for a term of five years commencing 1 January 2015 for a total contract price of \$1,976,995.54.

#### Legal

1. Pursuant to section 186 of the *Local Government Act 1989*, before a Council enters into a contract for the purchase of goods or services to the value of \$150,000 or more (levels increased by Order in Council dated 7 August 2008), the Council must give public notice of the purpose of the contract and invite tenders from persons wishing to undertake the contract.

#### **Finance**

2. The cost to Council of appointing the recommended tenderer is \$1,976,995.54 over five years. The year one cost is \$365,006.98. The first 6 months of this cost has been budgeted for in the Business Information Service's 2014-15 Operating Budget.
