1. Commencement of meeting and apologies

The meeting commenced at 5.30pm.

The Chair, Acting Lord Mayor, Arron Wood, advised that:

- the agenda comprised of eight reports from management, one of which was confidential and three items of general business
- no apologies had been received from Councillors.

Condolence statement for Ronald Joseph 'Ron' Walker AC CBE

The Chair, Acting Lord Mayor, Arron Wood, read the following statement:

The City of Melbourne sadly acknowledges the passing of former Lord Mayor, Ron Walker on 30 January 2018.

Ron was first elected to the City of Melbourne on 22 August 1968 to Hoddle Ward and after ten years of service, resigned on 14 August 1978, having served as Lord Mayor from 26 August 1974 to 29 August 1976.

At the age of 34, Ron Walker was one of the youngest to be elected as Lord Mayor of the City of Melbourne.

Ron was committed to reinvigorating the city at a time when development had stalled, remarking that "a plan will achieve little if it does not lead to action". He was an instrumental part of the city's revival at the time, which led to the extension of pedestrian access and open space in Bourke Street and the creation of the Bourke Street Mall. Ron also influenced the development of City Square into a vibrant open space for the community.

Following his time as Lord Mayor, he continued to follow his passion for Melbourne by filling the city's calendar with major events – race meetings, international motor races, cultural festivals and conventions – all of which have helped shape the city's reputation as the events capital of Australia.

In 1981, Ron and his wife Barbara donated to the people of Victoria the iconic jet-water fountain located on the corner of Linlithgow Avenue and St Kilda Road. Its vibrant lighting design is often used to celebrate public events.

The City of Melbourne extends its deepest sympathies to Ron's wife Barbara, family and friends.

Former Councillor Tessa Sullivan

Former Lord Mayor, Robert Doyle AC

The Acting Lord Mayor, Arron Wood, read the following statement:

I take this opportunity to also acknowledge former Lord Mayor Robert Doyle AC who formally resigned yesterday.

Robert Doyle was City of Melbourne's longest serving Lord Mayor and was first elected to Melbourne City Council in November 2008. In November 2016, Robert Doyle was re-elected as Lord Mayor for a historic third term.

Robert Doyle has made a significant contribution to the City of Melbourne and will leave an indelible mark on our City. He was deeply passionate about creating a vibrant, sustainable and forward-looking city that richly deserved its mantle as the world's most liveable city.

- 1.1. *Agrees that the West Gate Tunnel Project (WGTP) is contrary to long established State and City policy and practice, has significant negative effects and therefore is not supported.*
- 1.2. *Acknowledges the Victorian Government's willingness to commit to mitigate some of the negative effects of the project as raised in the Environmental Effects statement.*
- 1.3. *Requests management continue their work to obtain formal commitment, funding and delivery of the following 10 legacy projects and actions:*
 - 1.3.1. *Improving traffic and access including funding streetscape upgrades on Spencer and Franklin Streets, funding other traffic mitigation works in North Melbourne, West Melbourne, Docklands and the CBD and funding works to improve airport bus services by delivering a high level of on-road priority on the freeway and arterial road networks connecting to the Southern Cross Station terminal.*
 - 1.3.2. *No further expansion of road capacity or change to the status of local roads in North Melbourne, West Melbourne and Docklands to accommodate extra traffic from the Project.*
 - 1.3.3. *Conversion of Spencer and Clarendon Streets from arterial to local roads between Dryburgh Street and Normanby Road to facilitate improvements to pedestrian safety and urban amenity especially near Southern Cross Station and in West Melbourne.*
 - 1.3.4. *Modification of the CityLink concession deed to remove the limitation on changes to King, Spencer and William Streets.*
 - 1.3.5. *Investment in Moonee Ponds Creek, including expansion of the masterplan to cover an area from Mt Alexander Road to the Yarra River, and funding for land and works to fully deliver the masterplan. Development of a masterplan for the creek between Footscray Road and Dynon Road is a requirement of the Minister's Assessment.*
 - 1.3.6. *Supporting urban renewal in Arden and Macaulay by identifying and facilitating an alternative Citywide site in either the Dynon Road area or Fishermans Bend, to service the needs of the expanding central city.*

 - 1.2. *Welcomes a new Apple Global Flagship Store in the City of Melbourne, but expresses serious concerns about the way that this particular decision was made to fundamentally change the design, purpose and use of Melbourne's premier civic meeting place without public consultation.*
 - 1.3. *Notes requests by the City of Melbourne in January 2018 to Apple and the State Government that they commit to a significant redesign of the Apple Global Flagship Store at Federation Square to avoid 'pavilion' or 'temple-like' design that is out of context in Federation Square and poorly integrated with the square's existing architecture, better contain the public square, achieve a six star green star rating and undergo a public consultation process – which ideally could take in more of Federation Square given proposals for the new Metro Tunnel entrance – before resubmitting an amendment to the Melbourne Planning Scheme.*

 - 1.1. *Notes the endorsement of the draft Electronic Gaming Decision-Making Framework by this committee on 17 October 2017 and its findings relating to the significant social and economic harms to the City of Melbourne's citizens and communities caused by electronic gaming machines.*
 - 1.2. *Makes it policy in relation to the upcoming 28 February 2018 deadline for applications to renew existing electronic gaming machine entitlements for 20 years from 2022 to 2042 that all venues with existing entitlements are encouraged to apply for a substantially lower number than are currently operating at the venue.*
 - 1.3. *Requests that the CEO write to all incumbent venues in the municipality with a licence to operate electronic gaming machines (as listed at attachment 1 to the notice), as well as the CEO of each AFL club based in the municipality that operate venues with electronic gaming machines within the state (being Carlton, Richmond, Melbourne and Collingwood), by 9 February 2018, requesting that they respond to the policy of the City of Melbourne as stated above.*

- 1.4. *Requests that management make a media statement by mid March 2018 listing all venues and AFL clubs as defined above with their current and known requested future electronic gaming machine entitlements, acknowledging those that applied for an entitlement below the number of machines currently operating, listing the most recent expenditure data as published by the VCGLR for those that did not, and generally setting out the current state of electronic gaming machine entitlements and impacts in the municipality.*
- 1.5. *Reiterates the position of the City of Melbourne that the central city, currently the only part of the state without a cap on the number of electronic gaming machines, should be brought into the municipal cap.*
- 1.6. *Requests that, following the action taken in paragraph 1.4, the CEO write to the leader and gaming spokesperson of all parties currently represented in the Legislative Assembly informing them of Council's position and requesting that each party make specific election commitments prior to the 2018 general election including bringing the uncapped areas of the municipality into the municipal cap and reducing the state cap commensurate with the permanent retirement of all non-renewed entitlements.*

The motion was put and carried unanimously with the following Councillors present: The Chair, Acting Lord Mayor, Arron Wood and Councillors Frances Gilley, Le Liu, Leppert, Louey, Pinder-Mortimer, Reece, Riley and Watts.

9. Public questions

Shane Scanlon, Docklands News asked if it was reasonable to conclude that the West Gate raised freeway extension, by converting local road to arterials, comes at the expense of Docklands with the extra traffic expected via the Wurundjeri Way extension.

Acting Lord Mayor, Arron Wood advised that the Council had prosecuted this case solidly and Harbour Esplanade is a critical consideration. He also noted that he is on record as saying the West Gate tunnel will not be good for Docklands. The City of Melbourne will continue to prosecute the argument of any roads other than Wurundjeri Way not being widened, and that he himself had the Chief Executive Officer's support in continuing this argument.

Shane Scanlon asked what the Council's understanding and process of the timing is in relation to a by-election.

Keith Williamson, Manager Governance and Legal advised that pursuant to the *Local Government Act 1989* a by-election has to be held within 100 days of the resignation of the Lord Mayor and it is also required that it be held on a Saturday. The election will be held on the 12 May 2018 or earlier, but he noted that a date had not been set yet as it is the role of the Minister for Local Government to set the date.

Shane Scanlon further asked if Councillors had to resign from their position to run in the by-election.

Keith Williamson advised that Councillors were not required to resign from their position to run in the by election. The *City of Melbourne Act* advises that any of the Councillors can run for the position that is now vacant. Should they be unsuccessful they will revert back to their original position.

John O'Brien advised that a restaurant on the corner Exhibition and Little Lonsdale Streets continues to omit exhaust fan smoke six metres high. City of Melbourne staff have attended but it continues to happen (has been over a year). The building beside the exhaust fan is unable to open its windows due to the smoke and smell. He further noted that there is currently an issue in Haywood Lane with cigarette butts, beer barrels and cardboard.

Acting Lord Mayor, Arron Wood advised that he was aware of the exhaust fan issue, and that City of Melbourne officers have found the exhaust fan to comply with current standards. He advised that officers will again inspect the exhaust fan, however, if the exhaust fan complies there is not a lot that Council can do. He further suggested that Council officers may be able to work with the owner of the premises to facilitate a voluntary outcome. In relation to the waste issue as there are nearly 1 million people coming into the city per day the Council does extremely good job in relation to waste removal. He advised that he is happy to ask officers where the Council is at with this issue and get back to Mr O'Brien.

James Lesh, Citizens for Melbourne, asked if the Councillors would be willing to lead the debate over the future of Federation Square and commit to holding a public forum at the Town Hall by the end of the month.

Acting Lord Mayor, Arron Wood advised he is mindful of running a proxy public consultation process which has no impact on the final outcome. He advised that he believes Council should continue to advocate strongly for a second revision of the State Government's master plan for Federation Square.

Cr Watts left the meeting at 8.42pm and did not return.

10. Closure of meeting



The recent allegations by two female Councillors and media reports have served to remind me of my own experience six years ago when I made a complaint against Robert Doyle for bullying. Common causal factors within the workplace culture gave rise to these allegations. I find this distressing.

Statement

Recent research is unequivocal – significant costs arise from workplace harassment. Consider the immense costs associated with current allegations – personal, professional, legal, lost productivity, and reputational damage. Regardless of the outcome of the Freckelton investigation, unless underlying causal factors are faced, the problems at my workplace Town Hall will persist.

To quote journalist Tracey Spicer *"A culture wide, generations long, epidemic of workplace sexual harassment and assault doesn't persist without a broad network of complicity, composed of individuals with varying degrees of knowledge and culpability."*

The City of Melbourne Act is itself a causal factor; spawning a Council culture of entitlement, elitism and impunity shaped by those playing political games and those with economic influence, leaving local constituent concerns at the margins. A gerrymander designed to prioritise 'the big end of town' above residents and small businesspeople.

In my opinion, led by Robert Doyle over three terms the workplace culture resembles the political milieu of Spring Street; characterised by 'risk management', 'confidentiality', media optics, unanimity and expediency rather than optimal transparency and disclosure and service to constituents.

Consider the flow-on effect of Team Doyle Cabinet-style caucus meetings which are inherently exclusive; an absence of robust Council-wide debate; and an extraordinarily pattern of unanimity in bloc voting, compounded this term an absolute majority.

We are aware of what has divided the Doyle Council but, given that ALL Councillors sign the ostensibly binding Councillor Conduct Code, I am deeply dismayed to reflect that if any Councillor, aware of this alleged misconduct, had promptly fulfilled their obligations under the Local Government Act, the OH&S Act, and the Councillor Code, then the current miserable situation for all concerned and the damage to our City may well have been averted. I gather that the scope of the Freckelton investigation may not reveal whether or not any Councillors stood idly by, over the months during which Tessa Sullivan's distress grew.

Turning now to the Administration's role in shaping workplace culture.

I am personally and professionally aghast that six years after my bullying complaints, processes remain seriously deficient.

Consider the absurdity of the reporting processes faced by Tessa Sullivan:


- Initially a formal complaint had to be made to the CEO, who was then required to immediately inform the Lord Mayor.
- Under Councillor Code of Conduct, any complaint against the Lord Mayor must first be reported to the Deputy Lord Mayor (member of Team Doyle) who must then meet with the complainant and the Lord Mayor to resolve the complaint.

Protection for alleged victims, where those with power are involved, is as inadequate today as it was six years ago. Distressed councillors can opt to endure, face a daunting and costly complaints process, or ultimately, as in Tessa Sullivan's case, resign.

It is heartening that the Administration is now set to tackle deficiencies in relevant Acts and Code. Yet, it persists with a defensive and political stance that it already models best practices in transparency and disclosure, and in workplace harassment which are inappropriate in the current context.

Changes within Council may be more problematic. The status quo has served the Team Doyle well until now. Entrenched allegiances, established routines and retaining a large voting bloc remain. Time will tell – but my hope this appalling episode at least triggers change – greater collegiality and trust, genuine debate and a proper balance between the conduct of this Local Council and its role as State capital.


