Submission by Paul McSweeney at the request of Mr Michael Butcher, President of Melbourne South Yarra Residents Group Inc (MSYRG), who is temporarily interstate.

1. MSYRG acknowledges and appreciates the consultation and revision work undertaken by Council officers following the draft master plan circulated for comment in August 2018.

2. As advised during the consultation process, and in the MSYRG written submission dated 24 October 2018, MSYRG has particular concerns regarding the following aspects of the revised master plan:

- Temporary or permanent road closures within Alexandra Avenue, Anderson Street, Linlithgow Avenue and Birdwood Avenue, including slip roads, and any major construction/narrowing activities within that road network ought not be implemented or trialled while the Metro Melbourne Tunnelling project continues, with its consequent closure of Domain Road and suspension of the Domain Road tram service. At that time an up to date traffic management study based on the then relevant traffic conditions should be implemented prior to any changes to the Domain Parklands road network.
- The Edmund Herring Oval (currently utilised by the Melbourne Metro Authority as a project worksite) should have its surface restored to natural grass at the completion of the Melbourne Metro Project, not synthetic. In addition there should be no installation of sports lighting.
- Precinct 5 King's Domain South (east) should be retained as open parkland and trees in the current format. There should be no installation of picnic and barbecue infrastructure, fitness equipment, or change in the planting understory.

3. Any road closures within or adjoining the Domain Parklands will add to and adversely affect the already major increase in congestion within the local traffic area caused by the narrowing of Toorak Road West and the closure of Domain Road. They will also interrupt the resumed provision of the no. 605 bus service once the Southbank Boulevard construction work has been completed. This service compensates the travelling public for the loss of the Domain Road tram service during the Melbourne Metro project,

4. The proposals regarding the development of Edmund Herring Oval, outlined above, into a more intensive sporting venue are incompatible and inconsistent with the surrounding landscape and public activities

5. The proposals for Precinct 5, King's Domain South (east) outlined above will change forever the character and history of this traditional open parkland and treed environment.
