Proposed amendments to the 2017–2021 Council Plan

Purpose and background

- 1. The purpose of this report is to seek Council approval of proposed amendments to the 2017-2021 Council Plan (Council Plan) for public consultation as part of this year's annual review.
- 2. Section 125(7) of the Local Government Act 1989 (the Act) requires the Council, at least once each financial year, to 'consider whether the current Council Plan requires any adjustment in respect of the remaining period of the Council Plan.'
- 3. The Council may make adjustments it considers appropriate to the Council Plan outcomes, priorities or indicators following an opportunity for the public to make submissions through a 28-day statutory consultation process, in accordance with the Act.

Key issues

- 4. No substantive changes are proposed to the four-year outcomes and priorities of Council Plan. However, following one cycle of annual reporting on the Council Plan, it is timely to address the issues relating to a minority of progress indicators in the Council Plan to improve the basis for future annual reports.
- 5. The indicators proposed to be amended (refer Attachment 2) include those that cannot be accurately reported as currently worded due to data limitations or problems with their framing. Indicators are proposed to either be replaced, where a better alternative exists, or removed. In instances where indicators are proposed to be removed, this does not affect Council's ability to report progress towards the Council Plan outcomes in the Annual Report as these will be supported by remaining indicators.
- 6. Proposed Council Plan amendments not subject to statutory consultation include plans to update the Lord Mayor and CEO messages, the Group Councillor photo, two individual Councillor photos and their contact details, Portfolio details and the list of strategies. We also propose to reposition the indicators (currently at the back of the Council Plan) against the outcomes for each Goal.
- 7. Subject to Council approval on 9 May, the proposed amendments to Council Plan will be advertised on 10 May. After considering any public submissions at a special meeting of the Future Melbourne Committee on 13 June, the final amendments will be presented to Council on 25 June 2019.
- 8. Any amendments to Council Plan indicators will come into force after Council's endorsement of a revised Council Plan in June. This will not affect the 2018–19 Annual Report but will affect subsequent annual reports for the remaining two years of Council's term.

Recommendation from management

- 9. That Council:
 - 9.1. approves the proposed amendments to the 2017-2021 Council Plan in Attachment 2 for consultation
 - notes that public notice of the proposed Council Plan amendments will be given in accordance with 9.2. section 223 of the Local Government Act 1989 (the Act) in The Age newspaper
 - in accordance with section 223 of the Act, appoints the Future Melbourne Committee to: 9.3.
 - 9.3.1. consider any written submission which is received by the Council within 28 days after the publication of the public notice
 - hear any person wishing to be heard in support of his or her submission or a person 9.3.2 acting on his or her behalf at a special meeting of the Future Melbourne Committee to be held at 5.30pm on 13 June 2019
 - 9.4. notes that it will be requested to consider adoption of the proposed Council Plan amendments at its meeting on 25 June 2019.

Legal

- 1. Section 125(7) of the Act requires that the Council consider at least once every financial year whether the Council Plan requires any adjustment.
- 2. Where an adjustment is proposed to the strategic objectives of the Council (four-year outcomes), strategies for achieving its objectives (four-year priorities) or strategic indicators for monitoring their achievement:
 - 2.1 a person may make a submission on the proposed adjustment within a period not less than 28 days after public notice of the same
 - 2.2 the Minister must be advised of any final adjustment within 30 days of the decision.
