### **Reports from Future Melbourne Committee**

# Reports from Submissions (Section 223) Committee

5.3 Proposed public Highway Declaration of whole block bounded by La Trobe, Lonsdale, Exhibition and Russell Streets, Melbourne The purpose of this report was to recommend the public highway declaration of the roads within the whole block bounded by La Trobe, Lonsdale, Exhibition and Russell Streets, Melbourne pursuant to sections 204(1), 207A and 223 of the *Local Government Act 1989*.

Cr Le Liu declared an indirect conflict of interest in this matter because of impact on residential amenity under Section 78 E of the *Local Government Act 1989* as he lives close to the proposed public highway declaration. Cr Le Liu left the meeting at 5.45pm prior to discussion taking place.

- 1. That Council:
  - 1.1. Declare the roads bounded by La Trobe, Lonsdale, Exhibition and Russell Streets, Melbourne, as shown shaded and cross hatched on the public notice dated 27 March 2019 (Roads) as public highways, for the reasons that:
    - 1.1.1. the Roads are already considered to be public highways at common law having been constructed by and maintained by Council for many decades and being on the Council's Road Register
    - 1.1.2. the only objection received relates to the northern end of Bennetts Lane at the rear of 131 La Trobe Street which portion of road (affected area) was constructed around 1854 by Council at the cost of the abutting property owners and has subsequently been maintained and cared for by Council, and the declaration will:
      - 1.1.2.1. maintain access rights for the abutting proprieties at 131 La Trobe Street and 24 Bennetts Lane
      - 1.1.2.2. make clear the Council is responsible for maintenance of the affected area
      - 1.1.2.3. ensure unobstructed access for the property at 131 La Trobe Street to its fire exit and maintenance of the ventilation to the carpark.
  - 1.2. Notify in writing every person who has lodged a separate submission of the decision and reasons for the decision.

The following precincts will be funded: Carlton Inc.; Chinatown Precinct Association; City Precinct; Collins Street Precinct Group; Docklands Chamber of Commerce; Greek Precinct Association; North & West Melbourne Precinct Association; Kensington Business Association and; Yarra River Business Association.
  - 1.3. Approves the details of the successful applicants being made public following the passing of this resolution.
  - 1.4. Notes management's intention to begin planning to undertake a review the current Program throughout 2019-20 to allow for Council consideration ahead of the current program ending 30 June 2021.

- 1.1.2. A commencing rental of \$205,000 per annum plus GST with increases of 4% per annum
- 1.1.3. A market review every (5) years.
- 1.2. Notes the lease will be entered into under delegation.
