The Friends of Moonee Ponds Creek supports the plan to enhance the open space opportunities for the Moonee Ponds Creek.

There is one amendment that is requested before the plan is approved by the Committee. This is to ensure the protection of the western embankment between the Macaulay Rd and Arden St Bridges. This is a special area of open space with well established native vegetation (see attached photo) planted and upgraded by the community since 2000 – with the most recent this year.

The Strategic Opportunities Plan under Opportunity W8 would threaten the destruction of this established vegetation by construction of culverts under the embankment.

The Friends of Moonee Ponds Creek believes this section should not be specifically targeted for 'Levee Banks Water Storage' but that the whole Central reach, from Racecourse Rd to Arden St, should be part of the hydrological

considerations for 'Levee Banks Water Storage'. We thus propose the wording of W8 Opportunity to be:

W8 – Levee Banks Water Storage – “Investigate constructing culverts under levees to re-engage the floodplain storage and improve use of western creek berms in the central reach to improve open space”.

We ask the Committee to consider this amendment.
