## Purpose and background

- 1. The purpose of this report is to seek Council approval for Councillor Nicholas Reece to participate in the Public Space Design Forum in Sydney in November 2019.
- 2. Councillor Reece is Council's Chair, Planning portfolio and Deputy Chair Major Projects portfolio.

### **Key issues**

- 3. Councillor Reece has been invited by the conference organisers to speak at the inaugural Public Space Design Forum on the topic 'Central Melbourne Design Guide Clarity is key'.
- 4. The forum will provide a platform for discussion on policy and strategic planning for the design of new and existing public spaces. The agenda will feature a mix of policy driven sessions, interactive panel discussions and examples of best practice initiatives through a variety of case studies.
- 5. Some of the key speakers include:
  - 5.1. Alex O'Mara, Group Deputy Secretary, Place Design and Public Spaces, NSW Department of Planning and Environment
  - 5.2. Anna Bardsley, Associate Director of Policy and Research, Infrastructure Australia
  - 5.3. Ben Hewett, Acting NSW Government Architect
- 6. Participation in the forum will further promote Melbourne as a leading Design City.
- 7. Whilst in Sydney, Councillor Reece also proposes to hold meetings with representatives of City of Sydney on planning policy matters.
- 8. The cost to Council is estimated at \$1838 covering the cost of airfares, accommodation, ground transportation and incidental expenses.

### Recommendation

9. That Council approves Councillor Nicholas Reece's proposal to travel to Sydney in November to speak at the Public Space Design Forum at a cost to Council estimated at \$1838.
