Participation in ICLEI meetings, Resilient Cities Congress (Bonn, Germany) and Ecocity World Summit (Vancouver, Canada), Councillor Cathy Oke, 2019

Purpose and background

- 1. The purpose of this report is to inform Council on participation by Councillor Cathy Oke in the following:
 - 1.1. ICLEI Local Governments and Sustainability (ICLEI) Global Executive Committee meeting, World Secretariat Board Meeting and the Resilient Cities Congress 2019 in Bonn, Germany.
 - 1.2. The Ecocity World Summit 2019 in Vancouver, Canada.
- 2. Attendance at these meetings was approved by Council on 30 April 2019.

Key issues

- 3. Travelling overseas in a private capacity in June, Councillor Oke made a side-trip to Bonn, Germany to attend a series of ICLEI meetings. Costs associated with the side-trip were funded by ICLEI and Councillor Oke with no cost to Council.
- 4. Participation in the ICLEI meetings and the parallel Resilient Cities Congress allowed Councillor Oke to fulfil her duties as President of the Board and Vice President of the Global Executive Committee of ICLEI.
- 5. Melbourne, convener of the previous Ecocity World Summit in 2017, was invited by the Ecocity organisers to pass the baton to Vancouver as host of the 2019 Ecocity World Summit and to build the bridge linking the two events.
- 6. Councillor Oke represented the Melbourne hosts of the 2017 event (City of Melbourne and University of Melbourne) at the formal opening ceremony and participated in speaker and chairing roles throughout the Summit.
- 7. Active participation in the events in Bonn and Vancouver, at no cost to Council, allowed Councillor Oke to contribute to City of Melbourne's goal to maintain Melbourne's reputation as a global city leader of sustainability, demonstrating leadership and innovation to address and adapt to the challenges presented by climate change.
- 8. Included as Attachment 2 is an overview of the key activities and roles performed by Councillor Oke.

Recommendation

9. That Council notes the report by Councillor Cathy Oke on participation in ICLEI meetings and the Resilient Cities Congress in Bonn, Germany and the Ecocity World Summit 2019 in Vancouver, Canada at no cost to Council.
