Objection - relating to inadequate parking and traffic regime

The objectors run various businesses from premises at Princes Hill Gallery at 213 Canning Street Carlton, corner canning and Neill Streets [north-west corner] including:

- 1. International Legal and Notarial firm
- 2. Language Agency
- 3. Melbourne French Theatre
- 4. Importantly, the Consulate General of Senegal

We have an authorised driveway to the premises on Canning Street which over the past few years has been continuously blocked by:

- 1. Parked cars
- 2. Cars allowing passengers to alight
- 3. Major gas, plumbing, sewerage and road works over the past 5 years
- 4. Street closures, without appeal or proper consultation
- 5. Exacerbated by the busiest bicycle route on canning street
- 6. The inherent dangers this represents for our vehicles entering the premises through the authorised garage.

New School

We formally object to this permit as an inappropriate site, for a school, next to one of the busiest arterial road in Melbourne – the Council should be held responsible for the misuse of its powers and all legal and other liability flowing from the decision.

Access to our garage entry, parking, quiet enjoyment of interference in use of our premises and safety would have to be guaranteed by Council.

There will be an intense drop off and collection period at the start and the end of the school day which will cause havoc to cyclists, our vehicles entering in and out of the garage and entry and exit to our building with the number of children (85+ estimated) as well as teaching staff.

Council is obligated to establish a regime which protects cyclists, pedestrians and our business activity.

Unless an adequate traffic and protection regime is put in place, we formally object to this permit which is void of proper traffic assessment and management.

We do not accept the submission that the property was previously a hotel and as such parking was accepted as difficult or even not an issue by this new use.

Council is under a duty to reassess the very different use a school represents as opposed to a hotel, which Council always supported to the detriment of residents and ratepayers.

The site is not compliant or appropriate for a school and should only be considered for residential or commercial development.

The other major safety issue will be the Princes Street pedestrian crossing, which is not designed for a school structure whatsoever. Council will responsible for any accidents and issues that arise without a proper plan in place.

Parking Matters

We request full details of where teachers will park all day in the area and exactly where drop offs and collection will occur. This is critical in meeting Council's own duties and responsibility.

The traffic engineering report makes no mention of the garage or no standing zones towards the south and southwest on the corner of Canning and Neill Streets.

The traffic engineering report pays lip service to the needs of businesses and residents in the area.

Council must put guarantees in place for full access to the garage and exit to the roundabout on the corner of Canning and Neill streets for this objection to be withdrawn.

The traffic engineering report is based on some specious standardised criteria, not applicable to such as possible staff and parent car use without any proof or monitoring and survey after the school opens. The report is defective and has omitted ongoing use in this regard.

The Minister of Planning has specifically omitted this site from the urban design policy meaning that this site will develop with little restriction or consideration of key planning or environmental issues. It is vital that Treasury Square be subject to good design controls and overlay considerations.

Previously I have written to the Minister of Planning regarding my concerns about the:

- the impact of rezoning and development on the neighbouring suburbs, parks, shadowing, wildlife, facilities and aesthetics
- the impact of increased traffic
- the need for any development to be sympathetic with existing East Melbourne and CBD historical and award winning buildings. We do not need another Gas and Fuel building disaster.

My concerns have been ignored and these issues continue to be a real problem.

It is time to draw a line in the sand and protect Melbourne from inappropriate development. Let us really consider good architecture and the public and relegate the priority given to developer's profitability and lack of accountability (eg. poor attention to standards such as cladding).

FUTURE MELBOURNE COMMITTEE AGENDA ITEM: 7.1 Cr Leppert – Design Controls.

295-387 Wellington Pde Sth.

The East Melbourne Group Inc. represents 500+ members of the East Melbourne Community. We are writing in support of the motion in agenda item 7.1 put forward by Cr Leppert and seconded by Deputy Lord Mayor Cr. Reece pertaining to the parcel of Vic Track land at 295-387 Wellington Pde Sth erroneously referred to as Treasury Square. In its present form it certainly doesn't justify that title and visuals presented as a developed site show residential. commercial and hotel buildings with limited to no public space that would justify being called a square. In fact, it is the lack of controls on the site that is most alarming and an issue the EMG. MCC and many residents raised when the site was erroneously changed to CBD planning controls. In addition, a sale and tender process was undertaken prior to the zoning of the land.

The EMG is of the opinion that there is nothing unique enough nor sufficient precedent to justify this parcel of land being treated any differently to the rest of the City of Melbourne. Indeed, the lack of planning controls pertaining to this site is unjustified. We are advised by our urban design consultant Trevor Westmore that: "The application [or lack of application] of DDOs in this area appears to have been done without reference to urban design values. There appears to be no DDO covering the area right back to Jolimont Road, although most of the area has been developed with low rise buildings which would probably be the appropriate limit under a DDO.

The logical response to the development of any individual part of a place which has the potential to impact [adversely or otherwise] on the objectives of a comprehensive approach to the planning/urban design of a place should be that it should be managed under the same range of opportunities and constraints that affect the greater place. Therefore, these should be defined.

What place is it part of?

Definition of the place is the first step. Our first response is that as part of the south side of Wellington Pde South [that was the original E Melb Cricket Ground and later the railway yards] but which now provides a

built form edge to the south side of Wellington Park and the Treasury Gardens beyond, which does not share the characteristics of the CBD.

However, there is a much greater place here. It is the place between the CBD and The Domain, which to many is still a blank canvas awaiting their contribution. Note the recent suggestion of numerous high-rise buildings - the subject site is not the only undeveloped site close to Melbourne.

The property at No 289 Wellington pde sth does clearly introduce a precedent as a CBD scale-built form close to the characteristic high-rise CBD, but which blocks views to and from the CBD and tends to dilute its visual clarity, while not being part of it. A similar development on No 295-387 would add to this negative characteristic.

Therefore, my recommendation would be to introduce a new DDO over the whole area south of Wellington Pde Sth and west of Jolimont Street, including the railway yards, that would address the special characteristics of the broader place and its relevance to surrounding areas, including Cr. Leppert's issues with views to the CBD but also from it.

As an interim measure, the hybrid suggestion [DDO1 and DDO10 with view/height provisions] would have a similar effect for the subject sitebut not for dealing with the already identified potential future pressures to the balance of the undeveloped area of the rail yards beyond it."

It is within this context that the East Melbourne Group urge councillors to support this motion. We also urge you to continue to push for a suitable plan and controls for the whole area of Wellington Pde Sth west of Jolimont Rd.

ITEM NO 7.1: SUPPORTING THE MOTION ON DESIGN CONTROLS TO INCLUDE TREASURY SQUARE

We are writing to the [City of Melbourne] Future Melbourne Committee/ Minister for Planning, Government of Victoria, requesting its urgent action in relation to the proposed Treasury Square development site (Treasury Square) to rectify an omission which could drastically impact the liveability of the City of Melbourne.

It has come to our attention that there is no applicable urban design policy or control in place in relation to Treasury Square. This would allow the development of that site to continue with little to no restrictions or consideration of key planning and environmental considerations.

In [May 2020], we together with other residents and affected persons raised concerns and objections to Amendment 370 relating to the rezoning of the land at Treasury Square. Our concerns were not addressed by the Minister, there was no formal or informal consultation. Instead, the Minister exercised its own internal mechanisms of government to push through the rezoning, thereby bypassing the need to address with such affected persons those concerns. The concerns we raised included, amongst others:

- Impact of rezoning and development to the neighbouring suburbs, parks, wildlife, facilities and aesthetics to the City of Melbourne;
- impact to traffic and safety of neighbourhood;
- importance that the resultant development includes consideration of continued benefit to the public and offers a means of connecting the City grid to the surrounding sports, arts and river precincts;
- need for consistency of the look, feel and approach of the development would align to the city grid and that of East Melbourne, both of which includes historically significant sites; and
- Increase to population density in the City of Melbourne, which as we have seen particularly during COVID lockdowns, creates real issues to the residents and the city as a whole.

To date, these concerns have not been addressed by the process undertaken by the Minister. Without the application of any design controls or overlay will mean these issues will continue to be ignored.

Importantly, Treasury Square was previously designated as "Public Use". Inherently, the intention of the City of Melbourne and its town planners, past and present was that the use of this land requires some consideration of public benefit. Without any design controls, the fundamental purpose this land will not be considered.

Part of the "justification" to rezoning was to provide an "extension" of the city zone, to meet growing urban demand. We note that development sites within the City, Docklands and Southbank precincts which are also equally zoned as City Centre have design overlays and controls in place. There is no reason why Treasury Square should not be treated in a consistent manner. To allow this exception for this site would set a dangerous precedent for the future development of the city.

As a resident of the City of Melbourne and the State of Victoria, we call on our representatives (City of Melbourne Council and State Minister) to act in the interests of its constituency who appoint them. To date the Minister's handling of Treasury Square and lack of consultation demonstrates a lack of understanding and failing to understand the needs of the people. The Minister is also not taking into consideration available advice and recommendations from town planning experts, the City of Melbourne or the State Priority Projects Standing Committee. By doing so, the Minister continues to acts recklessly and negligently. If the City of Melbourne does not take action to also address this, it, by its omission is, enabling the continuance of negligent and reckless actions of the Minister.

As a resident of this great city and as your constituent, we plead for you to take action supporting the motion item 7.1 to ensure that the Design and Development Overlay Schedule 1 is applied to the Treasury Square site.
