Submission to the Future Melbourne Committee 15.03.22 re TAP budget (item 6.3)

Since 2019 I have been NWMA's rep to the West Gate Tunnel Project (WGTP)'s Community Liaison Group. During this time, NWMA has strongly advocated the need for a noise barrier on the planned Wurundjeri Way Extension (WWE) over the railway yards adjacent to Railway Place, West Melbourne.

The WGTP maintain that they have met their legal requirements under their EPR¹, in which VicRoads set a noise limit for the WWE. This takes no account of the existing noise from diesel trains which already impacts heavily on the residents of Railway Place and nearby. WGTP appear to be legally correct; the EPR was deficient.

NWMA was encouraged to approach the Department of Transport (DoT) directly, which we did in 2021. We learned that the \$100M Transport & Amenity Program (TAP) budget was set up to mitigate the effects of the significant additional vehicle traffic to and from the WGTP (on completion in 2025), which will be channelled from and into five arterial roads passing through West and North Melbourne. At least 2,000 additional vehicles per day are expected to pass along the WWE between the morning and evening traffic peaks.

One of the most negative effects of this additional traffic will be its noise impact on the residents of Railway Place. The TAP budget, having been set up to mitigate the effects of the additional traffic on our suburbs, is the appropriate budget to use to build the required noise barrier on WWE.

The response by CoM staff has been that this cost should be borne by DoT alone. NWMA asks the City Councillors to be pragmatic. It would take a huge political effort for DoT to persuade its Minister to provide additional funds for this noise barrier, when the TAP budget already exists for this purpose!

We ask the CoM to put the needs of its West Melbourne residents ahead of its desire to sheet home all the costs to DoT. The TAP budget for this year, 2021/22, is already allocated. We ask the CoM, via the TAP Steering Committee, to allocate sufficient TAP funds in 2022/23 for an engineering feasibility study for the noise barrier, and sufficient funds in 2023/24 to build that noise barrier.

The residents of West Melbourne and the members of NWMA will be most grateful.

We write on behalf of the Victorian Pride Lobby in regards to the notice of motion before the next Council meeting on "LGBTIQ+ programs".

We strongly urge you to pass the motion, with an amendment to remove point 3.

We believe that it is important that Councillors are briefed on Council's progress towards implementation of the Rainbow Pledge asked of candidates in the lead up to the 2020 election, and which many of you have signed.

In particular, we believe that it is important that Council investigate the establishment of an LGBTIQA+ community advisory committee (to complement your existing internal Pride Network) and what services might be suitable for Rainbow Tick accreditation (and whether publicly-facing services have been improved as a result of Council's participation in the Australian Workplace Equality Index). We also believe that it is important that Council investigate the development of an action plan addressing LGBTIQA+ communities, especially given that the Inclusive Melbourne Strategy contemplates developing further plans to deliver on Council's priorities for an inclusive City. This should be guided by an LGBTIQA+ community advisory committee.

We do, however, have concerns with the section of the notice of motion that states that our Local Government Equality Index "cannot be said to measure or benchmark equality in any meaningful way." We wish to make a number of points in response.

First, we acknowledge that the Local Government Equality Index does not and cannot fully capture the entire output or impact of Council's services and programs for LGBTIQA+ inclusion. Attachment 1 to the notice of motion details Council's LGBTIQ+ services and programs. We do not seek to ignore these or suggest that people should rely on the Index alone, and would welcome ideas on how we can better support and champion Council's other LGBTIQ+ inclusion initiatives.

Second, we dispute the assertion that the Local Government Equality Index does not measure equality in any meaningful way. The Index scores councils against each of the LGBTIQA+ inclusion initiatives in the Rainbow Pledge: (1) Rainbow Tick accreditation of services; (2) an LGBTIQA+ advisory committee; (3) an LGBTIQA+ action plan; (4) flying the rainbow flag; and (5) participating in pride events. Implementation of these initiatives will ensure that Council can play its part in achieving LGBTIQA+ equality.

Third, we question why the Council would criticise our work in this way. On this, we note that we: (a) wrote to you in March 2021 stating that we stand ready to work with Council on implementing these actions and offering you the opportunity to reach out to us if you have any questions or would like any support; (b) attended the stakeholder discussions on the Inclusive Melbourne Strategy in April 2021 and provided feedback, albeit that it was not reflected in the final Strategy; and (c) wrote to your CEO in December 2021 to invite comments on the Local Government Equality Index, acknowledging that many councils have gone above and beyond these five measures and appreciating your work in this regard.

On this basis, we kindly ask that you amend the motion to remove point 3. We find this part of the motion unnecessary and pointless, particularly as it demeans our work as a community group to improve LGBTIQA+ inclusion in local government. We have always sought to work positively with councils across the state to improve LGBTIQA+ inclusion, and seek to work with yourselves, particularly Cr Leppert, to address any misinformation and issues raised by this part of the notice of motion.

In conclusion, we recognise that Council is delivering some fabulous LGBTIQ+ services and programs. We are also trying our best to improve LGBTIQA+ inclusion in local government – an area where this work is the first of its kind in Australia. We ask that we work together and support one another in these important endeavours.
