To Melbourne City Councilors,

As a local resident of North Melbourne I have several comments and concerns around item '6.2 Melbourne Planning Scheme Announcement C417, Macaulay'.

Residential, Commercial, Retail Mix

As stated in the Planning Scheme Amendment, Macaulay aims "to support a genuine mix of uses", and according to the final Structure Plan the precinct will contain "a vibrant mix of shops, offices, spaces for small and medium-sized enterprises and start-ups".

The current Planning Scheme Announcement "encourages a minimum 20 per cent of floor areas as employment or other non-residential use". This threshold is an encouraging start to the precinct, however the encouragement of a certain percentage doesn't necessarily result in a precinct that meets this desired floor area split.

This is especially the case in Macaulay given the developments which have either applied for permit, have a permit approved or are already under construction. Based on the 'City of Melbourne – Development Activity Model' as of Monday 13^{th} June it is already clear that the current development style for the precinct is not in line with the Structure Plan nor this Planning Scheme Amendment. Of 23 developments listed in the Development Activity Model, only 5 developments actually deliver over 20% of floor space to non-residential purposes (14-22 Bruce Street, 2-50 Elizabeth Street, 103 Boundary Road, 9-101 Alfred Street, 87-105 Racecourse Road). This leaves 78% of developments in the precinct which do not align with the stated goals of this Planning Scheme Amendment. Without appropriate and urgent consideration to this by council there is every possibility Macaulay will become a solely residential precinct before the first metro train even runs through Arden Station, losing the chance of a truly once in a generation revitalisation of North Melbourne.

A diversity of uses of both individual buildings and the entire precinct is vital to its overall success, and it is important council ensures that it doesn't turn into a medium-density residential precinct that doesn't deliver on the stated desire to deliver a vibrant precinct with a mix of land uses.

The evidence so far suggests on its current path Macaulay is heading straight towards a residential 'build-to-rent' precinct, guaranteeing that residents won't be benefitting from a "vibrant mix" but rather living in a developer's paradise. Council shouldn't just be encouraging a diversity of mixed uses but mandating that it is actually delivered.

Shiel Street – Street wall Height

I support the inclusion of a mandatory maximum street wall height of 3 storeys on Shiel Street, and particularly thank Councillor Leppert for his ongoing responsiveness and support for attempting to maintain the residential nature of the boundary streets of the Macaulay Precinct. This is despite the State Government refusing to respect this residential nature, nor the overshadowing of Gardiner Reserve, through the Big Build development at 3-15 Shiel Street.

Traffic Impact of Canning/Vaughan Terrace Traffic Work

I support the integration of proper bike lanes on Canning Street, as well as the implementation of a pedestrian crossing opposite the entry to the Arden Gardens shopping centre.

Whilst supporting the change of Vaughan Terrace into a bike-only thoroughfare, I am concerned about the potential traffic flow impacts onto neighbouring streets, namely Melrose, Shiel, Haines and Dryburgh Streets. Has any modelling been conducted which investigates the impact onto local neighbouring streets, the majority of which have had speed bumps installed over the past few years.

Precincts Vision

As outlined in Attachment 4 there are a range of potential uses for each of the four different precincts defined in the Macaulay Structure Plan. Despite requiring a 3.8% affordable housing contribution across the entire Macaulay precinct, only the Melrose precinct is flagged as having additional public housing. Public housing should be distributed throughout the entirety of Macaulay as opposed to being focused on a single area of the overall Macaulay precinct.
